The program had approximately 160 swimmers participate in its 2011 program, covering ages 5 and older. The organization sponsored 4 swim meets sanctioned by Illinois Swimming Inc. under the rules and regulations of USA Swimming as well as participated in several additional sanctioned meets sponsored by other local swim clubs. Swimmers are grouped by age and skills for practices that take place 3 or more times per week depending on the assigned practice group.
