WCS had approximately 200 swimmers participate in its programs in 2012, covering ages 5 years and older. WCS sponsored 4 swim meets sanctioned by Illinois Swimming Inc. under the rules and regulations of USA Swimming as well as participated in additional sanctioned meets sponsored by other local swim clubs. Swimmers are grouped by age and skills for practices that take place 3 or more times per week, depending on the assigned practice group.
