## 2015-2016 Fee Agreement

### Fee Schedule

| Training Group | Fee   | Description   |
|----------------|-------|---|
| Senior         | \$125 | Senior team billing will occur September (at registration), October and March-July.   |
| Pre-Senior     | \$90  | Pre-Senior, Black and Red team billing will occur September (at registration)-February for the Short Course Season and April-July for the Long Course Season. Swimmers who achieve Short Course divisional, state and/or zone cuts, and choose to participate in those events, will be billed at the noted rate in March. |
| Black          | \$80  |   |
| Red            | \$75  |   |
| White          | \$55  | White team billing will occur October-February for the Short Course Season and April-July for the Long Course Season. Swimmers who achieve Short Course divisional, state and/or zone cuts, and choose to participate in those events, will be billed at the noted rate in March.   |

### Other Fees

- USA Swimming Registration and Insurance Fee (non-refundable): \$61.00/swimmer
- CGAC Family Registration Fee (non-refundable): \$100/family
- Meet entry fees are separate and additional. Fee amounts are determined by the host club and will be posted to your account. Committed meet entry fees are non-refundable. Fees are deemed committed as of the meet entry deadline posted on the Club website/pool bulletin board.

### Fee Exceptions

- Previous CGAC swimmers who are members of a college swim team will not be assessed training fees (college swimmers are responsible for meet entry, award and USA fees).
- Special requests must be submitted in writing and approved by the Board of Directors.

### Withdrawal

- Training fees are billed until written/email notification of a swimmer's withdrawal from the program is received. It is assumed swimmers will continue from Short Course to Long Course unless written/email notification is received.
- Swimmers may not withdraw/re-enter the program during the season.
- Committed meet entry fees are due regardless of whether the swimmer attends the related meet.
- Unearned volunteer credits must be met or fees of \$60/unearned credit will be assessed (see Volunteer Agreement and Volunteer Information Sheet).
