FACILITIES: Rainbow Beach is a 10 lane, 50-meter pool with turbulence control lane markers, electronic timing with back-up system, and printout. Final results prepared by computer. (8 lanes will likely be used for competition)

RULES: Current USA Swimming and Indiana Swimming rules will govern this meet. No entries will be accepted unless the entrant is either registered or certified with USA Swimming. Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of June 24th, 2011 shall determine the swimmer's age for this meet. Coaches must constantly display their USA Swimming credential to gain deck access. The meet referee reserves the right to ask for coaches credential display and/or deny deck access if a coach does not comply. All events will be scored as timed finals events.

USA Swimming athlete members must be under the direct supervision of a USA Swimming member coach during warm-up, competition and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

"Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement."

The referee reserves the right to use flyover starts to maintain a reasonable timeline.

COMPUTER: Meet Manager by Hytek will be used. Coaches are welcome to a backup of the meet at the conclusion of the meet. Please bring a thumb/flash drive.

ENTRIES: Each swimmer is limited to 5 events per day plus 2 relays. All times should be submitted in Long Course Meters. All entries are required to be in a hy-tek team manager format and emailed to the entry chair prior to the deadline.

On deck entries will be accepted until the time limit of the session is met. Deck entries of new swimmers to the meet will be accepted if the swimmer can provide a current USA Swimming ID number. On deck entry fees will need to be tendered at the time of the entry.

ENTRY

DEADLINE: Entries must be received by 1:00 p.m. Monday June 6th, 2011. Teams not accepted will be notified by Tuesday June 14th, 2011. Deadline will be extended if meet is not full.

AWARDS:

- Team awards (trophies) will be given for first (1st) through third (3rd) places.
- Host team will be ineligible for any team trophies.
- **Individual High Point awards (trophies) will be awarded to the top five (5) swimmers in each age and gender group.**
- Medals will be awarded to the top three (3) finishes in each event.
- Ribbons will be awarded for places 4-16 in all age groups.
- All age groups will receive ribbons for places 4-6 in relay events.
- Heat awards will be given to all Heat Winners.
- The meet will feature Mystery Heat winners!
- Coach's Relay with trophy for winning team!

POOL CERTIFICATION:

The competition course has not been certified in accordance with 104.2.2C(4). Pool depth is four (4) feet or deeper from end to end.

ENTRY PROCEDURE:

1. Before 1:00 p.m. Monday June 6th, 2011, submit your entries by email on a Hytek Commlink file (.CL2 file) most commonly known as a team manager file.
2. When your team is accepted into the meet, VST will email back to the designated individual an Entry Report for your team. Carefully check this Entry Report and inform us of any errors or variances by email as soon as possible. Deadline for changes is 1:00 p.m. June 10th, 2011.
3. The Meet Director must receive the following before June 24, 2011: Check for payment of all entry fees, executed release and hold harmless agreement (included in this packet), Officials/Timers Sheets (included in this packet).
4. No Times will be accepted but will be seeded slowest behind Long Course Meter times.
5. Keep the original Entry Report emailed to you by VST along with any and all subsequent Entry Reports notifying you of changed or updated entries. These are the official record of your team's entry. No other information will be considered if there is an entry error or discrepancy. No refunds or changes will be made to your team's entry due to your failure to review the reports sent to you by VST.
6. Entries will be accepted starting Monday, May 30th, at 8:00 a.m., 2011 up until the previously stated deadline of Monday, June 6th at 1:00 p.m.

ACCEPTANCE

CRITERIA: If the meet is over-entered, VST has sole discretion to determine which entries to accept. In exercising its discretion, VST will consider the following: Teams will not be broken, Number of Officials/Timers provided by the team, balance of age groups and gender in entry, level of competition, geographic location, VST's acceptance into other team's meets.

FEES: \$4.00 per Individual Entry
\$6.00 per Relay
\$1.50 per swimmer surcharge to Indiana Swimming
\$6.00 per Deck Entry
\$10.00 per Relay Deck Entry
Make check payable to "VST".

CONDUCT: Swimmers must check in for all events for the day 45 minutes before the start of each session. A swimmer who fails to sign in will be scratched. A clerk of course will be provided for the 8 & under swimmers.

SCORING: Ten (10) places will be scored in individual and relay events. If a club enters more than one relay in an event, only the highest finishing relay team will score.

Points will be awarded as follows:

Individual Events: Places 1-8 9-7-6-5-4-3-2-1
Relay Events: Places 1-8 18-16-12-10-8-6-4-2

DISTANCE

EVENTS: Swimmers must provide one timer (mandatory) and one lap counter for the 800 and the 1500 meter events. Entries for these events will NOT be limited!

ISI Swim Suit Legislation:

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

NOTICE TO ALL PARENTS AND COACHES

The Vincennes Swim Team (VST) is very grateful to the Vincennes Parks and Recreation Board for the opportunity to use the facilities and pool at Rainbow Beach. We all have a responsibility to protect and maintain these facilities. Therefore, we reserve the right to expel, for the remainder of the meet without refund of entry fees, any swimmer in unauthorized areas, for being rowdy or destructive, or in any jeopardizing safety.
