



# Black and Gold Bash 2019

## Noblesville Swim Club

### February 17, 2019

- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction #IN19171
- HOST:** Noblesville Swim Club (NOB-IN)
- TEAMS:** This meet is a dual meet between Noblesville Swim Club (NOB-IN) and Boilermaker Aquatics (BA-IN).
- LOCATION:** Noblesville High School, 18111 Cumberland Road, Noblesville, IN 46060
- FACILITY:** The venue consists of an indoor 25 yard, 8 lane competition pool with 3 lane warm-up area in the diving well. A Daktronics timing system with touch pads will be used for this meet. Stadium seating will be available for spectators. The minimum water depth in accordance with Article 103.2.3 is 4 ½ feet at the start end. The competition course has not been certified in accordance with Article 104.2.2C(4).
- Access to the facility will be through Gate 7 on the south side of the building.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet.
- Coaches and officials must display their current USA Swimming coach credential or Deck Pass to gain deck access. The Meet Referee and/or Meet Director reserves the right to ask for coach credential or Deck Pass and/or deny deck access if coach does not comply or card is no longer valid/current.
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Article 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.
- At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.
- Any swimmer entered in the meet, must be certified by a USA Swimming-member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms.
- Deck changes are prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of Sunday, February 17, 2019 shall determine swimmer's age group for the entire meet. Indiana Swimming does not process on-site memberships.

- FORMAT:** This meet will follow a dual meet format, with teams seeded in alternating lanes. All events are timed finals events. The host reserves the right to use fly-over starts for all events.
- ENTRY LIMIT:** All swimmers will be limited to 2 individual events plus 3 relay events.
- ENTRY FEE:** The entry fee is \$5 per swimmer. Make checks payable to Noblesville Swim Club. Submit entry fee with a signed Release and Hold Harmless Agreement to Entry Chair or designee prior to the start of the meet.
- REFUNDS:** In any meet sanctioned by Indiana Swimming other than Championship Meets, the host team may limit the number of swimmers in any one or more events to maintain a reasonable length of the meet. In the event that entries are limited, the host club must return the entry fees to the club(s) whose swimmers are not allowed to compete in the specific event(s).
- ENTRY PROCEDURE:** All entries must be received via email by the Entry Chair. Entries or changes to entries will only be accepted from a coach or designated meet entry chair from a club.
- ENTRY DEADLINE:** Entries will be accepted starting Monday, February 4, 2019 at 8:00 AM. Entry and update deadline will be Friday, February 15, 2019 at 12:00 PM.

- POSITIVE CHECK-IN:** There will not be positive check-in for this meet.
- SCORING:** Scoring for age group individual events will be 9-4-3-2-1, with only the fastest three swimmers from each team scoring. Scoring for age group relay events will be 11-4-2, with only the fastest two relays from each team scoring. Open events will not be scored.
- AWARDS:** The team with the top combined score will take possession of a traveling trophy.
- ADMISSIONS:** There will be no charge for admission.

**SAFETY:** The safety of all participants and spectators is of the highest priority. All persons using the facility are required to obey the facility management staff at all times regarding safety issues. Any persons not following these instructions will be removed from further participation in the event.

**TIME TRIAL:** There will be a time trial session immediately following the conclusion of the dual meet. Swimmers may not exceed 6 individual events **combined** in the dual meet and the time trial. The entry fee is \$5 per swimmer for the time trial, regardless of the number of events entered. Events may be combined by age, gender, stroke, and/or distance. The number of entries accepted may be limited if the timeline exceeds 1 hour.

- ADDITIONAL INFORMATION:**
- Locker rooms with shower and restroom are available; however, no lockers are available. Noblesville Swim Club will not be responsible for any lost or stolen items.
  - No parents are permitted to pass through the locker rooms, unless appropriately credentialed.
  - No smoking or tobacco use is permitted at the facility.
  - No glass containers are permitted in the pool area.
  - No folding chairs or other obstructions are permitted in the spectator viewing area.
  - Heat sheets will be posted in the spectator viewing area, and available free through the Meet Mobile app and the Noblesville Swim Club website (noblesvilleswim.com).
  - All times are in Eastern Standard Time.
