The facility is located approximately 1/2 mile southwest of downtown Crawfordsville.

**Directions:** **If you are coming from the Indy area:**

Follow I-74 West to Exit 34, SR 231 South (Many hotels are near this exit.) \*This road is re-named Washington Street as you drive through downtown Crawfordsville. Turn RIGHT on South Boulevard at the National Guard Armory. Bear LEFT onto Highway 47 (toward Waveland); Crawfordsville High School will be on your left in 1/2 mile. The Aquatic Center is located on the right hand side of the building.

**If you are coming from the Lafayette area:** Follow SR231 South. Then use the directions after the \* from above.

**Facilities:** The competition course has been certified in accordance with 104.2.2C(4). Eight lane, 50-meter pool for competition, with additional space for continual warm-up and warm-down. Pool depth ranges from 7 feet to 14 feet at the start end and is 3.5 feet deep at the turn end. Colorado automatic timing system with touch pads at start and turn ends, backup buttons, and 8-lane scoreboard. Balcony seating for 500 spectators overlooks the pool. Concessions will be available. A swimmer camping area will be set up in the auxiliary gym adjacent to the pool.

**Spectators:** Per USA Swimming Rules and insurance regulations only athletes, registered coaches, certified officials volunteering to officiate and meet volunteers are allowed on the pool deck. Balcony seating for 500 spectators, parents and family members overlooks the pool. **Due to limited seating SCSC requests that coolers, folding chairs and other large items not be taken into the balcony.** These can be set up in the auxiliary gymnasium area.

Spectator Admission Fees: \$5.00 per person, 12& Under children – Free

**Meet Director:** Naomi Horton

**Eligibility:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of June 4, 2019 will determine the swimmer's age for the entire meet. Indiana Swimming does not process on-site registrations.

**Rules:** Current USA Swimming and Indiana Swimming rules will govern this meet.

- At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.
- Any swimmer entered in the meet, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces as provided in USA Swimming rule 201.20.1. All swimsuits shall be made from textile materials. For men,

the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

- Coaches and Officials MUST display their current USA Swimming credential or Deck Pass to gain deck access. The meet referee and/or meet director reserves the right to ask for credentials or Deck Pass and/or deny deck access if coach/official does not comply or card is no longer valid/current.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms.
- Deck changes are prohibited.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

**Entry Limits:** Each swimmer may enter **4 individual events**.

**Entry Fees:** \$4.00 per individual event. An additional \$2.00 Indiana Swimming surcharge will be collected per athlete. Fees must accompany all entries. Deck entries, if accepted, will be double the regular fee. SCSC reserves the right to limit entries in an event in order to maintain a reasonable timeline. Any entries cut from an event will be refunded. **Please make all checks payable to Sugar Creek Swim Club.**

**Entry Format:** E-mail entries will be accepted for this meet. The Team Manager Entry Export or .sd3 file should be e-mailed to: Sarah Dowd [sdowd@cville.k12.in.us](mailto:sdowd@cville.k12.in.us). Work (765) 364-3247.

**Times should be submitted in Long Course Meters.** No times (NT) and nonconforming times will be accepted, but will be seeded slowest.

- Executed release and hold harmless form (included in this packet).
- Check for payment of all entry fees.

**Deadline:** Entries will be accepted starting at **8:00 am, May 6, 2019**. Entry deadline will be at **5:00 pm, May 24, 2019**. SCSC will extend the deadline if the meet is not full. In the event of a full meet, teams not accepted will be notified by **12:00 Noon, May 28, 2019** at the e-mail address or phone number of the person submitting the entry. If the meet is over-entered, SCSC has the sole discretion in determining which entries to accept. Criteria we will use in making this decision include but are not limited to: balance of age groups and gender in entry, level of competition, geographic diversity, time-line of the meet.

**NO Positive Check-In:** This is a **Pre-Seeded MEET**. If the meet becomes full, SCSC reserves the right to change to a Positive Sign-In. Notification will be posted at [www.scscswim.org](http://www.scscswim.org).

- Clerk of Course:** Clerk of Course will be available for 8 & Under Events only. Eight and under swimmers must report to the Clerk of the Course to learn their lane assignments and be lined up to swim the event. For all other events, there will be no Clerk of the Course. Seeded heat sheets will be posted on deck immediately before the start of each session. It is the swimmer's responsibility to appear at the correct starting block ready to swim in time for the start of his/her heat.
- Awards:** Ribbons will be given for the first 8 places in each individual event. Individual High Point will be awarded to the top three swimmers in each single age group (6 & Under, 7, 8, 9, 10, 11, 12) and the top two visiting teams will receive trophies.
- Scoring:** Individual scoring: 9-7-6-5-4-3-2-1 points. All events will be scored separately in the following age categories: 6 & Under, 7, 8, 9, 10, 11, 12 years old.
- Volunteers:** SCSC welcomes any officials would like to work during the meet. Officials who volunteer will be given complimentary food from the hospitality room in appreciation of their help.
