

CPSC Terms & Conditions Winter SC Season 2023-2024

- % USA Swimming-Indiana registration fees are due in full at registration and are non-refundable. This fee must be paid prior to your swimmer(s) entering the water.
- &" When a swimmer is moved from one group to another, he/she must pay the monthly training fee for the highest group in which he/she participates. ***ALL FEES FROM THE PREVIOUS SEASON MUST BE PAID IN FULL PRIOR TO SIGN-UPS FOR THE NEXT SEASON.***
- ' " Training fees, parent participation check and Birth Certificate (if required) are due and payable in full on the ***FIRST DAY OF PRACTICE FOR THE SEASON (September 25, 2023)***; However, Training fees may be paid in ***MONTHLY INSTALLMENTS (Sept-Feb) for all groups.*** ***IN THE EVENT THAT TRAINING FEES ARE NOT PAID A "NO SWIM POLICY" WITH BE ENFORCED.*** Special payment arrangements may be made in advance for families with multiple swimmers or special finance circumstances.
- (" Any late payments or checks returned to the Club for non-payment will be **subject to a system generated monthly \$25.00 handling fee until obligations are satisfied.**
-)" **All families will be required to place their swimmers' Meet availability using the online system.** Please refer to the CPSC Meet Entry Policy for further information. All fees incurred for each meet will be placed on your monthly statement and must be settled immediately upon receipt otherwise they will be subject to a late fee. The Head Coach will select and register meet events for all swimmers. No changes will be accepted after the stated deadlines. Refunds cannot be made to accounts after team registration is processed.
- *" The Club hosts various meets and events throughout the season. All Age Group families are required to accept and abide by the Participation Policy of the Club (as amended from time-to-time). Failure to comply with the Participation Policy will result in the forfeiture of the Participation Deposit.
- + " All swimmers, parents and/or guardians must read and abide by the expectations outlined in the "Coaches Packet for Parents" located on the CPSC website with particular attention being paid to the "Swimmers'/Parents' Responsibilities" and "CPSC Swimmers Code of Conduct." Failure to comply with the guidelines may result in suspension of attendance by swimmers, parents and/or guardians in the pool area.
- , " You are committing to join the Crown Point Swim Club (THE "CLUB") for one full Season (September 2023- March 2024) until midnight the day before sign-ups for the Summer LC Season. Should a Swimmer decide to ***DISCONTINUE PARTICIPATION IN THE CLUB, THE TRAINING FEES ARE NON-REFUNDABLE AND ANY OUTSTANDING BALANCES OWED TO THE CLUB ARE CONSIDERED AN OBLIGATION OWED TO***

CPSC AND ARE PAYABLE ON TERMINATION OF PARTICIPATION. The Team fees cover the salaries of the coaches as well as many other items. Because we must commit to our Coaches for the entire season, it is expected that swimmers also commit to the entire season of fees, whether or not they are able to swim during all weeks or months of the season. Payment is expected in full unless a release from payment has been granted by the board, CPSC cannot release a swimmer from payment of USA Swimming fees or meet entry fees since these are fees that the club must pay to other organizations. Release of Season Team fees will be considered only upon written request of the board and are only intended for extraordinary circumstances beyond the control of the swimmer and parents **EXCEPT** for during the two week trial period for new swimmers.

- " One or more Fundraisers may be **required** this season **for all groups** *YI Wdhh YHk c` K YY_ HFJU UbX9`jhy < GGk Ja a Yfg*. Fundraisers help limit increases in swim fees for the current season. These commitments will not be reflected on your online registration total upon check out but will be billed at a later date. The minimum fundraiser fee for this season is \$75.00 per family.
- %\$" Parent Participation this season requires **ALL FAMILIES** with a swimmer who participates at any DUAL meet hosted by CPSC to work that (1) session meet. This policy applies to any/all Dual meets hosted by CPSC during the Summer 2022 season.
- %%" FAILURE TO COMPLY WITH THE TERMS OF THIS CONTRACT WILL BE SUBJECT TO THE PENALTIES AVAILABLE TO THE CLUB BY LAW.
