**Location:** RecPlex Aqua Arena, 9900 Terwall Terrace, Pleasant Prairie WI 53158

**Facility:** Indoor, 10 lane 50 meter pool with non-turbulent lane lines. Pool depth 7' at the shallow end and 12' feet at the deep end. Starting blocks are 29.5". The competition course has been certified in accordance with USA Swimming Rule 104.2.2C(4).

**Timing System:** Fully automated Colorado timing system.

**COVID-19** An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable.

USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease. Therefore, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID19.

BY ATTENDING OR PARTICIPATING IN THIS COMPETITION, YOU VOLUNTARILY ASSUME ALL RISKS ASSOCIATED WITH EXPOSURE TO COVID-19 AND FOREVER RELEASE AND HOLD HARMLESS USA SWIMMING AND WISCONSIN SWIMMING, INC. AND EACH OF THEIR OFFICERS, DIRECTORS, AGENTS, EMPLOYEES OR OTHER REPRESENTATIVES FROM ANY LIABILITY OR CLAIMS INCLUDING FOR PERSONAL INJURIES, DEATH, DISEASE OR PROPERTY LOSSES, OR ANY OTHER LOSS, INCLUDING BUT NOT LIMITED TO CLAIMS OF NEGLIGENCE AND GIVE UP ANY CLAIMS YOU MAY HAVE TO SEEK DAMAGES, WHETHER KNOWN OR UNKNOWN, FORESEEN OR UNFORESEEN, IN CONNECTION WITH EXPOSURE, INFECTION, AND/OR SPREAD OF COVID-19 RELATED TO PARTICIPATION IN THIS COMPETITION.

In applying for this sanctioned event, the Host, Mundelein Mustang Swim Club agrees to comply and to enforce all health and safety mandates and guidelines of USA Swimming, Wisconsin Swimming, Inc., the State of Wisconsin, Kenosha County and the Village of Pleasant Prairie.

**MAAPP Policy:** All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. An athlete member at a sanctioned meet who is over 18 years of age, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered “not in good standing” and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

**COVID-19 Safety Plan**

**According to Rule**

**202.4.16:** This plan is for a sanctioned swim meet using semi-automatic timing competing in 10 competition lanes and manual back-up timing. The competition pool is a 1 x10 lane 50-meter indoor pool.

**Health Monitoring:** It is expected that all swimmers, coaches, officials, and volunteers are COVID symptom free and without known exposure with someone with COVID symptoms or diagnosis within the last 5 days.

**Entry and Exit:** Athletes, coaches, officials and volunteers will enter the pool through the Aqua Arena entrance of the Rec Plex. Swimmers will then travel onto the deck by walking through the locker rooms. Coaches, officials and volunteers must check in at the table in front of the Aqua Desk with credentials and/or volunteer confirmation. They will then enter the pool deck through the Shark Room. A meet marshal shall be placed at the Aqua Desk to ensure that only athletes, coaches, officials and volunteers are allowed past the Aqua Desk.

**Locker rooms:** Locker rooms will be available for swimmers to use, but marshals will ensure that no swimmers are using the locker rooms as a crash area. Showers and changing are not allowed at this time. Swim bags shall be placed in the designated swimmer rest areas. Bathrooms will be cleaned regularly per Rec Plex facilities safety plan.

**Spectators:** Spectators will be allowed inside the facility.

**Warm-up:** Warm up lanes and times will be assigned and sent out prior to the start of the meet.

\*Approximate times: warm-ups will begin immediately after the conclusion of the morning session, but not

before noon. All events are Positive Check In. Check In will close 20 minutes after the start of warm-ups. The meet will begin 1 hour after the start of warm-ups.

- Eligibility:** All swimmers must be current (2022) members of USA Swimming. USA swimming deck registrations will not be accepted. A swimmer's age for the meet will be his/her age as of July 8, 2022
- Disabled Athletes:** Please notify the meet director and meet referee for any special requirements of athletes prior to the start of the first session.
- Coaches:** Coaches must be current (2022) members of USA Swimming to be allowed on deck and will be asked to show proof of current registration.
- Meet Rules:** All USA Swimming Inc. and WI LSC rules apply, including safety rules which will be strictly enforced. Wisconsin Swimming warm-up procedures will be in effect. Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to policy 4.5.2(a). Teams will be assigned warm up lanes to use as they wish. Violators of the Wisconsin Swimming warm up procedure are subject to disqualification. In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

- Seeding:** All events will be Positive Check in, timed finals. Swimmers not checked in prior to the check in deadline will be scratched from that session. Swimmers will be seeded slowest to fastest. In events of 400m or longer athletes will be seeded fastest to slowest. For seeding purposes, please submit Long Course Meter times. NT's are acceptable. Special seeding procedures will be used for disability athletes. (see USA Rule 202.2.13)

**MMSC reserves the right to seed MMSC athletes in limited events regardless of seed time.**

For timeline considerations, meet management reserves the right to combine 13-14 and open events into a single event, scored separately by age groups.

- Conduct:** All clubs will be responsible for their own swimmers. Any swimmer entered into the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. In accordance with the Federal Video Voyeurism Prevention Act of 2004-the use of camera phones or video recording devices in the locker rooms is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair. This includes any underwater video equipment and or cameras.

Cell phone/camera usage will NOT be allowed behind the starting blocks for any reason.

Locker Rooms on the pool deck will be designated ATHLETE only. Use by coaches, officials and volunteers is strictly forbidden.

**Deck Changes:** *Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.*

**Teams:** This event is open to all USA Swimming sanctioned clubs and members.

**Entries:**

First 48hr of the entry period will be reserved for WI USA Swimming sanctioned clubs only. May 23, 2022 at 8:00am thru May 25, 2022 7:59am. On May 25, 2022, at 8:00am, entries will open to clubs outside the WI LSC and will be processed in the order they are received.

Entries will only be accepted via email. Entries will be accepted until June 5, 2022, or until the meet is full. Teams must submit hard copies, waivers, and payment within 72hrs of meet acceptance.

**Entry Fees:** Individual events are \$6.00 each. A WI Swimming surcharge of \$4.00 per swimmer entered into individual events must be included with your entry, as well as a \$7.00 per swimmer facility fee. An admission fee of \$13.00 per swimmer will be charged. **Please make checks payable to Mundelein Mustang Swim Club.**

**Entry Limit:** Swimmers may enter Two (2) individual events on Friday and Five (5) individual events on Saturday/Sunday.

\*\*Please note that the 800 free will be swum fastest to slowest and may be limited to the top 3 heats if time constraints occur. Timelines and seeding will be available on the host team website the week of the meet. Swimmers in the 800 free will be asked to provide a timer and counter.

Events of 200m or longer may be limited, if needed to comply with the USA Swimming 4-hour rule.

**In the event the meet reaches, or nears capacity, of 350 swimmers per session, MMSC reserves the right to limit entries in specific sessions affected by these limits.**

**Deck Entries:** Deck entries will be accepted to fill open lanes. Cost will be \$10.00 per event plus the all other applicable surcharges (\$4/WI, \$13/admissions, \$7/facility), if the swimmer isn't already entered into the meet.

**Awards:** Ribbons for 1-10th place in all individual events for 10 & under, 11-12. Swimmers in the 13-14 and Open category will not receive awards.

**Admissions:** Admission Fee is built into meet fees. No Admission will be charged at the door.

**Concessions:** Concessions may be available through the Rec Plex

**Timers:** MMSC will do our best to cover as many lanes as possible. However, some assistance with timing may be needed. If this occurs teams will be notified the Monday or Tuesday before the meet of timing needs.

**Officials:**
