**Location:** RecPlex Aqua Arena, 9900 Terwall Terrace, Pleasant Prairie WI 53158

**Facility:** Indoor, 10 lane 25 yard pool with non-turbulent lane lines. Pool depth 7' at the shallow end and 12' feet at the deep end. Starting blocks are 29.5". The competition course has been certified in accordance with USA Swimming Rule 104.2.2C(4).

**Timing System:** Fully automated Colorado timing system.

\*Approximate times: warm-ups will begin immediately after the conclusion of the morning session, but not before noon. All events are Positive Check In. Check In will close 20 minutes after the start of warm-ups. The meet will begin 1 hour after the start of warm-ups.

**Eligibility:** All swimmers must be current (2020) members of USA Swimming. USA swimming deck registrations will not be accepted. A swimmer's age for the meet will be his/her age as of January 24, 2020

**Disabled Athletes:** Please notify the meet director and meet referee for any special requirements of athletes prior to the start of the first session.

**Coaches:** Coaches must be current (2020) members of USA Swimming to be allowed on deck. Deck Pass is an acceptable proof of USA Swimming registration.

- Meet Rules:** All USA Swimming Inc. and WI LSC rules apply, including safety rules which will be strictly enforced. Wisconsin Swimming warm-up procedures will be in effect. Feet first, three point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to policy 4.5.2(a). Teams will be assigned warm up lanes to use as they wish. Violators of the Wisconsin Swimming warm up procedure are subject to disqualification. In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
- Seeding:** All events will be **Positive Check in**, timed finals. Swimmers not checked in prior to the check-in deadline will be scratched from that session. Swimmers will be seeded slowest to fastest. For seeding purposes please submit Short Course Yard times. NT's are acceptable. Special seeding procedures will be used for disability athletes. (see USA Rule 202.2.13)
- Conduct:** All clubs will be responsible for their own swimmers. Any swimmer entered into the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. In accordance with the Federal Video Voyeurism Prevention Act of 2004-the use of camera phones or video recording devices in the locker rooms or behind the starting blocks is prohibited. Only official meet volunteers, coaches, and swimmers will be allowed past the check-in or on deck. No parents will be allowed on deck if they are not volunteering. No parents will be allowed in locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.
- Deck Changes:** No admission will be charged for spectators. The meet fees include an admission surcharge of \$13.00 per swimmer. Heat Sheets for each session will be included in the admission fee. Meet mobile heat sheets will also be included.
- MAAPP:** All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- Entries:** Entries will be accepted beginning **Friday, December 20th at 8:00am**. Entries will only be accepted via email and will be accepted until the meet is full. Teams must submit hard copies, waivers and payment within 72hrs of sending final entry.

- Entry Fees:** Individual events are \$5.00 each. Relays are 12.00 each. A surcharge of \$3.00 per swimmer entered into individual events must be included with your entry, as well as a \$5.00 per swimmer facility fee. **Please make checks payable to Mundelein Mustang Swim Club.**
- Entry Limit:** Swimmers may enter 2 events on Friday night and 4 events each day Saturday/Sunday.

(not including relays)

- Deck Entries:** Deck entries will be accepted to fill open lanes. Cost will be \$7.00 per event plus the \$3.00 Wisconsin Swimming surcharge if the swimmer isn't already entered into the meet.
- Awards:** Ribbons will be given for 1st-8th place in all individual events and 1st-3rd place in relays for 10 & under and 11-12 age groups. Swimmers in the Open category will not receive individual or relay awards.
- Admissions:** No admission will be charged for spectators. The meet fees include an admission surcharge of \$13.00 per swimmer. Heat Sheets for each session will be included in the admission fee. Meet mobile heat sheets will also be included.
- Concessions:** Food and drink will be available from the Rec Plex concession stand during the meet. No glass containers are permitted on deck.
- Vendors:** Elsmore Swim Shop will be on site Saturday and Sunday.
- Meet Results:** A copy of the final results will be provided to each participating team via email and posted on both the MMSC and WI Swimming websites.
- Limitations:** The host club reserves the right to limit events, heats or distance in order to ensure completion of the session with the 4-hour time rule guideline. Any entries which are cut by the host club will be refunded.
- Timers:** MMSC will do our best to cover as many lanes as possible. However, some assistance with timing may be needed. If this occurs teams will be notified the Monday before the meet of timing needs. **\*\*Swimmers in the 1650 free will need to provide their own timer and counter.**
- Officials:** There will be a need for officials to help the meet run smoothly. Certified officials should contact Steve Fidanze, [SFidanze@yahoo.com](mailto:SFidanze@yahoo.com). Any assistance that can be provided would greatly be appreciated.
- Parking:** There is plenty of free parking available.
