**SANCTION** #: WI2022-214S

Current USA Swimming and WSI rules, including safety and Minor Athlete Abuse Prevention Policy ("MAAPP") will govern this meet. In granting this sanction it is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. *The Wisconsin Meet Reservation System will be used to secure entry into the meet.* 

All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. An athlete member at a sanctioned meet who is 18 years of age or older, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.. *Underwater photography of any kind is prohibited at all times during this meet in any pool.* 

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Operation of a drone, or any other flying apparatus, is prohibited over the venue anytime athletes, coaches, officials and/or spectators are present. Deck changing is prohibited. Training equipment or devices are not permitted during warm-up periods at this meet.

In applying for this sanction(ed event), the Host, Lake Forest SwimClub, agrees to comply and to enforce all health and safety mandates and guidelines of USASwimming, Wisconsin Swimming, Inc., the State of Wisconsin, and the North Shore Health Department.

We have taken enhanced health and safety measures for you, the other participants, and meet staff. You must follow all instructions while visiting the RecPlex. **FACILITY** The competition pool is an 8, 9, or 10-lane 50 meter course ranging from 7' 0" to 7' 1" in

depth. Lanes are 7' 4" wide with 6-inch Kiefer Wave Eater Lane Lines and Kiefer Elite Starting Platforms. Colorado timing system and display. The competition course has been certified in accordance with USA Swimming Rule 104.2.2C(4). A copy of such certification is on file with USA Swimming. Changing into or out of swimsuits in areas other than the locker rooms is

prohibited.

**ENTRY FEES** 

The individual event entry fee is \$5.50 per individual event. **Deck entries will not be accepted at this meet.** A Wisconsin Swimming surcharge of \$4.00, \$10.00 technology/administrative surcharge, and a RecPlex facility surcharge of \$5.00 per swimmer entered in individual events must be included with entry. **Make checks payable to "Lake Forest Swim Club".**

EVENTS, ENTRY LIMITATIONS and SEEDING An event schedule for this meet is included with this meet announcement. Swimmers may enter and swim six (6) individual events each day. The Sr 400 IM and 800 free will be swum in alternating fashion, fastest to slowest seeded heats Please submit LCM entry times.

All events will be conducted as pre-seeded timed final events swum slowest to fastest seeded heats. Swimmers competing in heat limited events are required to check in and positively declare their intent to swim for each event. Swimmers who do not check in will be scratched from that event. Special seeding procedures will be used for disabled athletes (see USA Rule 202.2.13).

The following events MAY be limited to three heats based on submitted entry times:

- 8/9/10-year-old 100m events
- Sr 400 free, 800 free and all 200m events
- 12 & under 200 IM and 400 Free

Heat limitations will *only* be imposed if necessary to manage the timeline. It is our intent to swim as many heats as possible. *All swimmers entered in heat-limited events must provide a seed time*. To check seeding for heat-limited events visit <u>www.swimlfsc.org</u> after May 26, 2022.

**AWARDS** 

Awards will be given for  $1st - 10^{th}$  place in individual events for 8/9/10, 11/12 and 12 & under age categories. There will be no awards for Sr events.

DECK ACCESS and CREDENTIALS

Only contestants, coaches, volunteer meet support, timers and working meet officials will be granted access to the competitive area. Current USA Swimming membership card must be continuously displayed while on deck.

SWIMMER SUPERVISION

Each team or coach is responsible for the supervision of his or her swimmers. The meet and/or facility host reserves the right to remove from the meet any swimmer entering an unauthorized area. In accordance with the Federal Video Voyeurism Prevention Act of 2004, the use of camera phones or video recording devices in the locker rooms is prohibited.
