It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. It is further understood that Indiana Swimming shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

**LOCATION:** IU Natatorium, 901 W. New York Street, Indianapolis, IN 46202

**FACILITY:** Competition Pool: Two eight-lane, 25-yard pools with a depth ranging from 9' - 10', Competitor lane lines with custom designed starting blocks, Colorado electronic timing equipment, and Daktronics scoreboard. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

Continuous eight-lane warm-up course available in the North pool (scoreboard end). Meet competition will be held in the South pool (diving well end) except for the 1650 freestyle events which will be swum in both pools by gender.

**PARKING:** Parking is available in the attached Natatorium Sports Garage for \$7 per entry, credit or debit card only (no cash). Prices are determined and retained by IUPUI Parking Services. Host is unable to negotiate pricing, nor does host receive any revenue from parking fees.

**RULES:** Current USA Swimming rules will govern. Swimmers must be ages 14 & Under and registered with USA Swimming in Lake Erie/Ohio, Kentucky, Michigan, Minnesota, Wisconsin, or Indiana to be accepted into this meet. Each LSC has its own team selection process. Age as of 01/04/20 shall determine the swimmer's age for the entire meet.

At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down.

Coaches MUST constantly display their current USA Swimming coach credential to gain deck access. Meet management and/or the meet referee reserve the right to ask for coach credential display and/or deny deck access if coach does not comply or membership is no longer valid/current. Deck Pass is acceptable proof of USA Swimming membership.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

In swimming competitions, the swimmer must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee. Only swimsuits complying with FINA swimsuit specifications may be worn in any USA Swimming sanctioned competition.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Deck changes are prohibited.

**EVENT LIMIT:** A swimmer may compete in a maximum of six individual events and two relays for the meet.

**MEET FORMAT:** All events are timed finals and will be seeded from slowest to fastest. There are 3 heats of each event with the exception of relays (2 heats) and 1650s. The 1650s will be swum as 11-14 events seeded by time but scored/awarded by age group.

The host will provide one timer per lane for the 1650 events. Teams are responsible for providing a counter for each 1650 participant. The counter should be a credentialed participant in the meet (coach/athlete).

All events will be swum in the south pool (diving-well end) except for the 1650 which will be swum in two pools by gender. **Flyover starts will be used in this meet.**

Wedges and backstroke ledges will be available for swimmer use.

**INDIVIDUAL EVENTS:** Each team will be entitled to enter four (4) swimmers in each individual event.  
*Exception:* 11-14 1650 is limited to 6 swimmers of each gender per team.  
There will be no on-deck registrations accepted at this meet.

**RELAYS:** Each team will be entitled to enter 2 relays per relay event.

**SCORING:** Individual Events: 20—17—16—15—14—13—12—11—9—7—6—5—4—3—2—1  
Relay Events: 40—34—32—30—28—26—24—22

**AWARDS:** Medals will be given for places 1-3 in each event. The 11-14 1650 Freestyle events will be awarded by age group (11-12 and 13-14). There will be no awards ceremonies. Team scores will be kept. There will also be record breaker recognition.

**ENTRY & DEADLINE:** Each LSC has its own unique team application, swimmer entry fees, and entry deadlines. Therefore, clubs and individual swimmers need to check with their LSC team contact (information listed below) regarding the application process, fees, and deadlines that are applicable to their team.

**Team entries are due via email to the Mid-States Entry Chair by Thursday, December 26, 2019, at 8:00 PM. HY-TEK OR TEAM UNIFY ENTRY FILE IS REQUIRED ALONG WITH A PDF OF THE TEAM ENTRY REPORT** to use if there are questions with the electronic file.

The meet will not be re-seeded; scratched swimmers may be replaced with swimmers already entered in the meet. If scratched swimmers are not replaced, affected lanes will be empty.
- OFFICIALS:** The Referee for this meet will be Dick Duncan. Indiana Swimming will have the primary responsibility for scheduling officials for the meet.
