The 2020-21 Lake Erie Silver Dolphins (LESD) swim year runs from September 1, 2020 to August 31, 2021. Please review the breakdown of team fees for the LESD that are involved in our team registration and potential adhoc commitments throughout the year.

LESD Coaching Fees are paid online via Team Unify (LESD’s team website) in one lump sum or a monthly payment plan for your convenience. The Coaching Fees payment schedule is as follows:

** Gold Group Coaching Fee reflects part-time training during winter season (i.e. already calculated into the season and monthly fees).

Any adjustments to the above LESD coaching fees will be communicated to the affected payment plan members in advance of the adjusted billing cycle, including but not limited to COVID-19 pandemic or other unforeseen occurrences.

Coaching Fee Payment Discounts

- A \$100 discount is eligible to swimmers registered on our website before November 1st who pay in full. Yearly paid dues are non-refundable. The yearly balance and discount will be deducted from your account on November 1st.
- A \$50 discount is eligible to swimmers registered on our website after November 1st who pay in full. Yearly paid dues are non-refundable.
- Families that register multiple swimmers will receive a 5% Multi-Swimmer Discount off the Coaching Fees for each swimmer. Multi-Swimmer discount may be used in conjunction with the “payment in full” discount.

Coaching Fee Payment Options

Option I – Payment of Coaching Fees In-Full. A \$100 discount is offered to those who register to pay in full by November 1, 2020. Your account will be debited on November 1, 2020. In the event of early withdrawal, no refunds are permitted.

Option II – Monthly Payments. Official billing will begin on November 1, 2020 and continues monthly until ten monthly payments have been received or August, 2021. A family may suspend membership at any time. Please see below for additional information.

Other Important Information

- Monthly Coaching Fees are retroactive, billed on the first of each month for the previous months coaching & meet fees. Example: September coaching & meet fees are paid on October 1. [Click here](#) for information on how to access your account's invoices and billing history.
- A family may suspend membership/training, and subsequent Coaching Fee charges, at any time. Please provide written notification 15 days prior to the anticipated stop date. In the event a swimmer voluntarily opts to suspend membership/training at any time prior to the receipt of ten (10) consecutive Coaching Fees installments, a \$25 reactivation fee will be assessed if the swimmer starts training again in the same swim season (the swimmer will not be charged Coaching Fees for the months not training provided notification is given 15 days prior to the "layoff"). For instance, if a swimmer trains from September to February, stops training/payments for March through May, and then starts back up in June, a \$25 reactivation fee will be charged in addition to monthly Coaching Fees for June through August.
- If a family chooses to suspend membership/training, the swimmer will be charged for the entire month coaching fees. There is no proration of monthly charges.
- If a swimmer is moved to a practice group that is different from the one initially registered for prior to payment of the tenth monthly installments, billing will be in the amount of the new group rate for each remaining month of the registration.
- LESD relies heavily on parent workers to provide your child with a great swimming experience. Our new Service Policy is intended to fairly distribute the work and communicate how we would like our families to be involved our competitive USA Swim Team. Other Fees

- **Registration Fee:** LESD is offering two levels of team registration:
 - An **Annual**, non-refundable registration fee of \$95 is due upon registering for the team. The annual registration allows swimmer(s) to participate in all swim meets (local, travel and championship level). The fee covers the cost of USA Swimming/Lake Erie Swimming membership, a subscription to “Splash” magazine, a LESD Team T-shirt and an LESD Team silicone swim cap and is open to all swim groups.
 - A **Flex**, non-refundable registration fee of \$45 is due upon registering for the team. The Flex registration allows swimmer(s) to compete in just two (2) non-championship and non-travel swim meets and is offered to only White, Red, or Blue group athletes. Once a swimmer has reached the two meet maximum an option to upgrade to the annual membership will be available. The fee covers the cost of USA Swimming/Lake Erie Swimming membership (for only two meets), a subscription to “Splash” magazine, a LESD Team T-shirt and an LESD Team silicone swim cap.
- **Boosters Club Fee:** The Booster Club assesses a \$212 yearly family booster fee. This fee can be paid in full at the time of registration or in two separate \$106 installments (first two months after registration is active). Booster Club fees help offset facility rentals, and the various operating costs/fines incurred by the club.
- **Late Fees:** A \$10 late fee will be automatically added on the 15th of each month if your account is not current. Please make sure your credit card is current in the system.
- **Delinquent Fees:** A \$10 fee will be assessed anytime your payment is declined. Example: insufficient funds, invalid credit card number or expiration date, or self-chosen declined payment, etc. LESD is charged every time a credit card is processed, regardless of if the payment goes through. In an effort to reduce the number of transactions. Please make sure your credit card is always current in the system.
- **Non-Recurring Fees:** Meet entry fees generally run between \$20 and \$40 per meet. In addition, each local meet entry includes a LESD surcharge of \$5 per swimmer. Championship and travel meets outside the district include a LESD surcharge between \$10 and \$20 per swimmer. Swimmers will not be permitted to register for meets if their account is not current.
