Those qualified and willing to officiate should immediately contact Dick Lennon, Meet Director, 5 Wiley Road, Woburn. A note to Dick stating which day you can help will be most welcome.

The All-Star Qualifying Meet (for the Quebec-New England All-Star Meet) will be held at Exeter March 15 & 16.

It is expected that the All-Star Meet will be held April 26.

Important: Swimmers must enter the qualifying meet in the age-group they are in as of April 26, not March 15. If you change age-groups between Mar.15 and April 26, please note. A list of events is given on Page 2.

The Board announces that efforts are under way to arrange a summer allstar meet with Connecticut (similar to the Quebec-New England Meet).

FROM PETER PLANTE, President of NEAAU Executive Committee:

With the growth of swimming in New England, it is becoming apparent that some youngsters are entering "C" Meets without proper preparation. In some cases the swimmer obviously cannot do the stroke at the required distance.

I feel strongly that the team coach is responsible for making certain that any member of his team entering an event can swim the stroke with some proficiency at the required distance. AAU Neets, even of the "C" calibre are for swimmers who have already demonstrated to the coach in practice, their ability to meet AAU swim standards.

Coaches are only doing disservice to a beginning swimmer by anticipating his abilities. It is suggested that the coach precede Meet entries by a time-trial.

MEMO FROM: Sob Pyatt, new Chairman of the NEAAU Competitive Swim Committee

A new year, another approaching swimming season, and many changes which should interest everyone!

First of all, on pehalf of the Swim Committee and all those interested in New England swimming, I would like to thank our outgoing chairman, Peter Plante. During the past year Peter has worked hard and long hours doing a sometimes thankless job.

Since the last NEWSLETTER was published, there have been two general meetings of the Swim Committee. The Annual Meeting was held on Saturday, May 10, at the Medford Community High School. Major topics discussed at that meeting were the financial status of the Committee, since a portion of the participation fee fom swimmer paid to AAU is no longer returned to the Committee for our operational expenses; the calendar of meets for the summer season; representation at the Quarterly and Annual meetings of the New England Association; the feasibility of having a paid, part-time secretary to handle correspondence and inquiries about New England swimming; the possibility of paying major officials (starter and referee) at seim meets, and the election of officers.

A discussion of the revisions of the Dy-Laws and Rules, on the agenda for the Annual Meeting, was postponed until a Special Meeting on Wednesday, May 21, again at Medford. Copies of the revisions were available at the Annual Meeting, and the membership was urged to be ready to discuss changes and amendments at the May 21 meeting. The major ammendments made and accepted included the following:

- i. Membership of the Swim Committee shall consist of one representative from each member A/U Swim Club who have ptid their annual NEAAU dues and their annual NEAAU Competitive Swim Committee dues (established at the annual meeting), members of National Swim Committees, and members-at-large. Note: To defray the operational expenses of the Committee (mailing, copying, etc.) and to insure a vote and receiving official reviews, each member club must send to the Committee Secretary a fee of \$5.00 for the year beginning May 1, 1975.
- 2. The formation of a Budget sub-committee to be chaired by the Treasurer. This sub-committee has, and will continue each year, to formulate a working budget by which the Committee can produce some income and meets its expenses each year.
- 3. Requests for dates for meets must be in writing to the Chairman of the Calendar sub-committee prior to that committee's semi-annual meetings. Requests for dates during the period of June I to December 31 must be made before April 1 of each year. Requests for dates during the period between Nov. I and July 15 should be made prior to October 1. (see note on the Summer Calendar of Meets).
- $4_{\circ}$  In order to conform to the current Mational Swimming Rules, trophies for team and individual high-point winners at 0 and 0 meets shall NOT be given.

Copies of the completed Symmass are now being produced and will be available free to all member clubs upon request, and to individuals for a charge of 50¢ per copy. Individuals please enclose self-addressed stamped envelope with request. Available from Secretary.

Approved at the last meeting was the addition of a surcharge of 5¢ per event, which will be paid to the Competitive Swim Committee, from ALL NeAAU sanctioned meets immediately. The entry fee will remain 75¢ for A meets, and 50¢ for B & C Meets, but entrants will pay 80¢ and 55¢ respectively for individual events. Surcharge does not apply to relays or to swimmers of the host club. The surcharge, which has been implemented in other AAUs is intended to meet swim committee expenses, and assist in all-star team and trip expenses, patches and other things which promote NEAAU swimming.
