AGE GROUPS

THE AGE GROUP MEET WILL RUN ON A FORMAT SHOWN ON ANOTHER PAGE OF THIS NEWSLETTER. DISTANCE EVENTS WILL BE HELD ON THURSDAY EVENING FOR THE 13-14 AND 15-18 AGE GROUP. THIS SEASON THE 1500 WILL BE ON THURSDAY EVENING. SWIMMERS WILL BE LIMITED TO THREE (3) EVENTS PER DAY AND NINE EVENTS FOR THE MEET. THERE IS A PROPOSAL TO LOOSEN THE CUTS IN THE 10 & UNDER AND 11-12 AGE GROUP. THE PROPOSED CUTS ARE ON ANOTHER PAGE ALONG WITH A BALLOT FOR CLUBS TO VOTE ON THEM.

THE CUTS FOR THE DOVER MEET WILL REMAIN AS PUBLISHED IN SEPTEMBER NO MATTER HOW THE VOTE COMES OUT.





Not for Officials Only

Better Late than Never (Sometimes)

For any meet to be successful, pre-planning is essential to identify potential problems, and to resolve them well in advance of the first day. There are, however, a few problems that always seem to crop up just before the meet starts, and nine times out of 10, the referee is the one summoned to resolve the situation.

Please note the word "sometimes" in the title. The following is one case where "better late than never" lust doesn't apply.

There are some officials who insist on showing up at 8:45 for a 9 a.m. meet start, looking for "Hall to the Chief" to be played upon their arrival. These are the same individuals who wind up waist-deep in problems at the last minute, and begin the meet on a sour note.

Controversy is the last thing any official needs at 9 a.m. of the first day, although I've seen a few strangely motivated people actually go out of their way to find or create situations just to demonstrate how well they think they know the rules. Problems will always surface on their own, and we sure don't need anyone generating new ones.

The solutions are relatively simple: 1. Meet directors need to invite key officials to pre-meet planning sessions. 2. All officials should arrive at least one hour prior to the scheduled starting time.

Socoool Get there early, and resolve the situations before they begome problems.

The Rules

Turn Judge Jurisdiction

We are informed of the following situation: At the pre-meet briefing turn judges were told only to "watch the last arm pull and kick into the wall for possible infractions on the turns and finish."

in a breaststroke race, a turn judge called a "head under" infraction on a swimmer coming in for a turn while still beyond the backstroke flag (15 feet from end of pool). The call was protested and the protest upheld by the referee because the swimmer had not started his

final arm pull and was not in the jurisdictional area of the turn judge. The stroke judge on that side did not see the swimmer, nor did the referee, so no violation.

Are Time Standard Tests Counted as Meet Events?

Situation: A preliminary and finals meet, with prelims scheduled at 9 a.m., finals at 4 p.m. The meet director also sets up some time standard tests in the same pool for any swimmer entered in the meet, to start at 1:30 p.m.

Johnny Eager enters three events scheduled on Tuesday, competes in all three prelims, but makes the finals in only one of them. The time standard tests include the same events scheduled in the meet that day, so he seeks to enter the two tests in the events he flunked in the prelims. Can he? The answer is no.

USS 103.3(1) reads: "In any combination of aquatic events conducted on a single day at the site and where preliminaries and finals are held, no swimmer shall be permitted to compete in more than three events (one event equals one preliminary plus one final) per day, exclusive of relays."

The preliminary in which he qualified, plus the afternoon final in that event, counts as one event in his available three events. The two preliminaries count as the other two events, so he has filled his quota of three. Had he made the other two finals and swum them, he still was in only three events. But, by entering an event of another category—even though the same stroke and distance—he is exceeding his quota.

Had the time standard tests been run in another facility away from the meet sile, he could have entered them. But as the LSC must sanction both the meet and the tests, it is assumed that this rather obvious evasion of the event-limit rules would not be approved.

The Shortest Distance Between Two Points Is A Straight (Time) Line

I've always thought most people involved in swimming really enjoyed it. If this is the case, why is it that the most frequently asked question is, "When are we going to finish today?"

Actually, this isn't such a silly question at all. If it comes from an inexperienced newcomer to our sport, usually it means that there could be an important commitment

elsewhere, or an effort to figure out when dinner might be.

On the other hand, if experienced coaches ask, "When is Event 16 going to start?" or "When will the preliminaries finish?" you can bet they are figuring out the optimum rest or warm-up for their athletes. In this case, a fairly accurate answer is a must.

The time line can be a most useful tool and, when prepared properly, will be valuable to all. Every referee or meet director I've met has had his/her own "surefire" method of calculating the line, and I'd be the last to criticize, although a few formulas I've seen would have made Einstein scratch his head. The point is, a time line is essential and should be used at all levels of competition.

Arriving at a usable line for preliminaries is a little more difficult than finals. Dealing with an increased exposure to potential problems because of the number of heats, and taking into account the experience level of both the athletes and officials, it is best not to be too conservative.

Finals are another matter. Although there is always the possibility of problems, the exposure is considerably less than in the preliminaries. This, coupled with the known finalists' times, makes preparing a finals time line relatively easy. However, one should not forget to include the opening ceremonies and the all-important awards festivities.

Remember, make sure everyone knows the line and, barring unforeseen disasters, stick to it.

UNITED STATES SWIMMING GENERAL LIABILITY INSURANCE PROGRAM, cont'd

The insurance company will defend any suit against any insured which seeks to recover damages for bodily injury or property damage which falls under the scope of the policy.

It is important to note the following exclusions:

- 1. There is no coverage for the operation, ownership, maintenance, loading or unloading, or use of any automobile.
- 2. There is no coverage to any obligation or liability under any workers' compensation, unemployment compensation or disability benefits law, or under any similar law.
- 3. There is no coverage of property damage to:
 - a. property owned or occupied by or rented to the insured(s).
 - b. property used by the insured, or
 - c. property in the care, custody or control of the insured or as to which the insured is for any purpose exercising physical control. (Bailee's coverage is provided for this exposure)

Extensions of Coverages:

- a. Personal Injury Liability
- b. Contractual Liability
- c. Broad Form Property Damage
- d. Fire and/or Explosion Legal Liability-Real Property-\$25,000 limit
- e. Delayed Notice of an Occurrence
- f. Worldwide Products Liability
- g. Incidental Malpractice Covergaeh. Host Liquor Liability
- i. There is no participant's liability exclusion.

ADMINISTRATION:

- 1. Certificates of Insurance are available from the following sources:
 - a. Your Local Swimming Committee
 - b. Kindler & Laucci Insurance Brokers
- 2. Third Party Additional Insured Endorsements will be issued only by Kindler & Laucci - Insurance Brokers.
- 3. Claims or Incidents should be reported immediately to US Swimming or Kindler & Laucci. It is imperative that no person admits liability or responsibility or discusses any aspects of the incident with anyone other than an authorized Fireman's Fund claims representative or police official.

QUESTIONS - CLARIFICATIONS:

We will attempt to answer the most commonly asked questions concerning the liability insurance program.

Q. 1. What types of club activities are covered?

- A. All United States Swimming related activities such as daily practices, dual meets, sanctioned competitions, approved competitions, club fund-raisers, club meetings, and learn-to-swim activities.
- Q. 2. Are weight training programs covered?
- A. Yes, provided there is a coach or other supervising individual present.
- Q. 3. Do all swimmers in a club have to be members of USS in order to have liability insurance coverage?
- A. Yes, membership in USS is necessary in order for an individual (swimmer, coach, parent, etc.) to have the benefit of coverage. The Swimming Club must also be a member in order to have liability coverage.
- Q. 4. Our club, in order to provide transportation to swimming competitions, either rents a school bus or depends on the swimmers' parents' private vehicle. Is the club covered under this situation?
- A. No, there is no coverage provided for any automobile liability either for the club or the parents. The club should arrange for this coverage locally or contact Kindler & Laucci for information and rates for the separate swimming club insurance program.

Many officials, coaches, etc. are required to sign agreements with municipalities, school districts or universities in order to utilize their pool facilities. Almost all of these agreements, in addition to requiring liability insurance, contain a hold-harmless clause that obligates the club and/or person signing to be responsible for any claim arising from the use of the pool. It is important that the persons signing such agreements realize that they are responsible when there is no insurance coverage applicable. We suggest that legal advice be obtained prior to signing such agreements.

Prior to terminating any existing insurance coverage, it is important that swimming clubs have their policies and exposures reviewed. Your local insurance broker or Kindler & Laucci should perform this review.

MORE ON INSURANCE

The difficulty in explaining our insurance coverage to most of our people lies sometimes in what seems so elemental to people in the insurance game. It is not so simple as asking, "Do we have insurance coverage?".

One must distinguish between Accident coverage and Liability coverage, although they are both present in most cases.

So, also, an event which is sanctioned carries with it the coverage but not necessarily if it is only "approved". Some events or activities need neither sanction or approval to carry the coverage.

The keys are found in the language of the policy:

<u>Accident</u>: "Sanctioned events and organized practices, supervised by a coach, manager or club official."

Liability: 'While acting for, or on the behalf of United States Swimming'.

This can best be explained through illustrations:

- 1. USS club holds dual meet with non-USS club. LSC approves the meet. Insurance would cover, both Accident and Liability. In effect this is "organized practice".
- 2. USS swimmer is member of USS club A. He is also member of non-USS club B (e.g., YMCA). Each club has <u>different</u> coaches. Club B enters non-USS meet (e.g., YMCA meet). ISC approves the meet. There is no insurance coverage for the swimmer on either Accident or Liability.
- 3. Same as No. 2, except that Club A and Club B have same coaches. Both Accident and Liability insurance covers. In effect, "organized practice" again.
- 4. USS swimmer individually enters a meet, not sanctioned but is approved. No coach present. No insurance coverage, either Accident or Liability. (Liability might cover USS in remote possibility that USS sued as a defendant in some incident involving the swimmer, but only for USS and not the swimmer).
- 5. Same as No. 4, but the swimmer's coach is present during the approved meet and supervises him (considering it a 'practice' perhaps). Both Accident and Liability would cover.

- 6. USS club holds an organized fund-raising event, supervised by club officials. Both Accident and Liability would cover.
- 7. USS club holds its annual post-season picnic, supervised by club officials. Both Accident and Liability would cover.
- 8. Number of the swimmers and their parents decide to linger around the pool after the last meet of the season to celebrate. Get beer, hot-dogs, and the works. Most everyone else has gone home. No coverage, either Accident or Liability (although a lawyer could have fun with this).
- 9. USS club enters local July 4th Parade with float and marching. No USS insurance coverage, Accident or Liability. This is an example of an activity "outside of USS meets or practices".
- 10. USS club owns its own pool. It must carry independent insurance at its own expense to cover premises liability; USS Insurance would enter if organized practice or USS sanctioned meet were held on premises, under terms of USS policy.

The key, then, is controlled supervision and organization in USS activity, and I need not explain to you, experienced in the insurance business, why this must be so from the viewpoint of the carrier. And there are always going to be situations in which the dividing line is extremely difficult to draw, particularly in Liability situations.

Not for Officials Only

When in Rome . . .

During the last few years, the number of foreign swimmers visiting the USA to compete in our meets has increased dramatically. Because of this, it is most important that we as officials and meet managers be prepared to work with these teams.

The rest of the above title, "... do as the Romans do," is most appropriate when operating under U.S. Swimming rules, and our international friends should become familiar with them before arriving at the meet.

However, it has been my experience that this is not always the case. To eliminate any potential rule difference problems, I would suggest that a short informational session be conducted by the referee, with all coaches or team managers present to explain the basic ground (water) rules. Actually, it's probably a good idea to have a brief meeting prior to the beginning of every competition, whether there are foreign teams competing or not.

Along with this is the matter of protocol. United States Swimming has worked very hard to project the proper image and extend every courtesy to our world guests. There are some very exact considerations which must be addressed, and it would be most wise to contact the National Office of United States Swimming for guldance when you are expecting teams from other countries.

No Wars, Please

The recent Senior Nationals held in Clovis was the scene of some of the most impressive hospitality I've witnessed in quite some time. My swimming friends from Houston might take some exception to this, claiming that Texas hospitality takes a back seat to no one, but I'm really not trying to start another war between the states. What I am saying Is, whether you're having a hamburger with grilled Walla Walla onlons in Seattle, fresh fruit in Clovis, a fantastic barbecue in Houston, hot chile in San Jose or schiepping a hero sandwich on the East Coast, the hospitality at our swim meets will never be equalled in any other sport.

To magnify this, when was the last time you saw a little league parent take a cold drink to an umpire, or offer a soccer official datenut bread and coffee during a match? Fat chance!

Remember, like Rodney Dangerfield, we all need a little respect and recognition once in a while. We do have the greatest hospitality of any sport no matter where we are, and we should make these people working hospitality aware that we do appreciate their efforts.

Negatively Positive

You may have noticed that a few of these articles I've written for this column have been centered around personal attitudes and philosophies rather than the straight technical aspects of officiating.

By now, those of you with whom I've had direct contact, either in person or writing, and those who have just read these articles, are probably aware that one of my basic perceptions of officiating is that 50 percent of it is mental attitude.

is it possible that we have been a little remiss in our training methods? Most officials' clinics have been stressing the technical disciplines which are primarily negative, when a balance of proper attitude reflection is really needed. This coming year will see greater emphasis placed on positive attitude posture.

Correcting the improper position of a turn judge takes but a few minutes. Trying to change an old adversary attitude is another matter, but it can be done.

There are two basic questions we need to ask ourselves: 1) Why am I involved in officiating? and 2) Where do I want to go in officiating, and for what reasons?

Olympic Check-off Bill Needs Your Voice

The Olympic Check-off Bill (HR-1984 and SB-1984) has over 260 sponsors in Congress, yet it is still pending in the House Ways and Means Committee.

This legislation will make it possible for all American tank tyers to voluntarily donate \$1 of their tax refund to the United States Olympic Committee for the purpose of funding the Olympic Training Centers in Colorado Springs and Lake Placid, developmental programs, the National Sports Festival, sports medicine programs, and developmental grants to the national governing bodies of individual sports.

The check-off would allow an individual with a tax refund to give \$1 to the USOC (\$2 on a joint return) or would allow an individual who owed money to add \$1 to his tax payment. (Last year, 74 percent of the 94 million Americans who filed 1040 tax forms were entitled to a refund.) Since the bill requires the USOC to pay all the administrative costs of the check-off bill, it will not cost the U.S. government one dime, and could provide U.S. athletes with the necessary funding to continue their training.

Please, write your congressman and your senator in Washington, D.C., and ask them to support HR-1984 or SB-1984. Encourage your friends to do the same, and hopefully 1984 will be the year the gold stays in Southern California.

The Rules

New Rule Changes: We are not alone in our eternal restless search for perfection. It was comforting to read recently that, "Lawmakers of the Royal and Ancient Club, together with the U.S. Golf Association, have announced the most comprehensive change of rules since 1952. Among those to become effective in the United States on Jan. 1 are modifications on dropping, lifting and placing the ball." Others itch and twitch as we do.

At the United States Swimming annual House of Delegates meeting on Sept. 30th the most warmly debated issue was adoption of the "One False Start" regulation that has been in an experimental stage in USS swimming for two years. In the unlikely event that you have not heard about it, the rule would disqualify a swimmer from swimming the event if he or she made one false start. No change would be made in the rule allowing a swimmer to be relieved of a false start charge if his action was deemed to be accidental or unavoidable.

Notwithstanding a mass of documented success in the elimination of false starts by using this rule, including over 100,000 "splashes" in one area alone in five months, there were yet those to whom it did not appeal.

All had their say in open discussions but it appeared that support by the many athletes attending had a marked effect on the outcome. They stated that the elimination of the need to out-psyche their opponents, and to watch others for the

same reason, would allow them to fully concentrate on their start and their race on a much fairer basis. From the coaching viewpoint a world class coach said this writer's claim that almost all faise starts are deliberate was a but overblown, but that in his opinion at least 50 percent and perhaps more are deliberate and avoidable... and are aided and abetted by the swimmer's coach.

To beef up the now more-important DQ call, the rule was modified so that the referee must agree with the starter that it truly was a false start and not "relievable." The rule was accordingly adopted by a goodly majority with the exceptions added that it would apply to all USS-sanctioned competition except the Trials for the Olympic, Pan American and World Championship teams. It was felt that so long as the FINA allows two free jumps to the whole field, our swimmers would be better prepared if they approached those important events using the same tactics as the competition. Some of them, may we add, have been and are exceptionally good at it. All USS international meets are also exempt.

The 1984 rulebook will not be available for another month or so, and we have received many calls asking for the exact language of the new rules, which become effective Jan. 1, 1984, in all USS-sanctioned competition by the House of Delegates.

The language will be the same for both long course and short course, so we print here the short course rule as it will read:

"103.16 STARTER

(2) The Short Course Start

(d) If, in his opinion, a false start has been committed, the starter shall give a signal to recall the swimmers. With the concurrence of the deck referse the false start shall be called on the individual(s). Any swimmer who commits or causes a false start shall be disqualified and shall not be permitted to swim the event.

This rule shall not apply to U.S. Swimming international events or to the Trials for Pan American, World Championship or Olympic teams, where current FINA false start rules shall apply."

Taken together with 103.16(5) Deliberate Delay or Misconduct, and with the additional provisions under 103.16(6) False Starts, swimmers, starters and referees should have no doubt about their individual responsibilities on the start.

The phrase "deck referee" has been used because in many large meets an administrative referee is named to oversee matters not directly related with the competition itself, and the deck referee becomes the party in authority over the race.

Of the 46 legislative changes presented by the Rules Committee, 44 were either adopted as written or approved with adjustments. Only two were rejected. We feel this 95 percent was indeed welcome support and is evidence that the committee does its homework and is not only tuned in to but listening to the many voices of swimming. The committee, by the way, through other lealslation introduced by the atimies, will henceforth comprise 20 percent of the rules membership instead of having only one official spokesman as currently. This cannot fail to help us further in our work for the athletes.

Some 40 "housekeeping" changes were presented and approved, cleaning up many (we hope most) of those nasty little things that have accumulated over the years which are outdated, or not in accord with reality.

It would be impractical to print fully the many rule changes in the newsletter. Your delegates to Cincinnati have the full text. Contact them. National Championship rules will take effect March 1, and they will be widely publicized well in advance. Changes of importance included: dropping the words "upright" from the start rules and "perfectly" from the breaststroke, new scratch rules, bulkhead measurements, etc.

Old Problems: Before the advent of the LSC Board of Review system, devised and developed by legislative chairman Bernard J. Favaro, many protests came to us for adjudication.

That these local courts are doing a very good job is indicated by the fact that only two formal appeals to LSC board decisions have come to us in 1983. We commend them on their work and hope they continue to function so well.
