ACADEMIC ALL-AMERICA honors are based on a combination of high school GPA and placement at National Championships or Junior Championships.

COACH EDUCATION TEST:

All new USA Swimming coaches must pass the coach education test before they reregister for their second year of coaching. (Coaches who were registered in 1998 or before are grandfathered.)

"The Foundations of Coaching Test, 2nd Edition" has recently been published and is now available through the New England Office. The new test includes 181 question with no more that 20 to be missed. The test is still based on the USAS Rules and Regulations, the "Progressions for Athlete and Coach Development," and the "Foundations of Coaching Home Study Course."

The original test is still in the back of the Foundations and is still accepted, but it is preferred that coaches use the revised edition. The answer sheet still will go to ASCA for grading. (The address is on the answer sheet.) The new test is abailable to be taken on line by going to the ASCA web site at www.swimming coach.org.

SAVE THE WEEKEND!!!! MAY 4, 5, 6: This weekend will be full of activities for all members of the New England Swimming community to be held at the Wellesley Community Center and other venues in the Wellesley area.

The traditional Annual Meeting will be held on Saturday, May 5 at the Wellesley Community Center with election of officers, approval of budget, etc.

Stroke and Turn officials will be able to attend a recertification clinic.

The Meet Managers clinic will be available to all who are managing meets or entering meets and will feature guest appearances by members of the Web Site Development Committee and other guest experts, including our web master, Cathy Mosca. They will arrive with their lap tops, perform demontrations, amazing you with their knowledge and revealing all kinds of short cuts and other "tricks of the trade." Everyone is welcome to come ready to learn and ask questions.

The Coach Representatives, Amy Parratto and Ray Grant, have been working with ASCA to prepare a weekend full of coaches classes, clinics and other meetings.

It is expected that the athletes will be treated to a swim clinic on Sunday.

REIMBURSEMENT POLICY FOR NATIONAL AND SECTIONAL MEETS, 2000-2001

ATHLETE REIMBURSEMENT POLICY:

A New England registered swimmer who qualifies for and swims in an individual event at the US Open will be reimbursed \$150 by New England Swimming. A New England registered swimmer who qualifies for and swims in an individual event at national championships will be reimbursed \$300 by New England Swimming. A New England registered swimmer who qualifies for and swims in an individual event at the Sectional meet will be reimbursed. For this meet, an amount of \$5,000 will be shared by the qualified swimmers who apply and submit receipts within the eight week period, with a maximum of \$50 per swimmer. Please note that this amount is for this year only.

During the short course season a swimmer must fully participate in three New England calendar meets to be eligible for reimbursement. During the long course season a swimmer must fully participate in two New England calendar meets to be eligible for reimbursement. "Full reimbursement" means participation in all or at least two days of competition and at least one individual event at each day of participation.

If the New England Senior Championships is in place with a named facility by a certain date (90 days preceding the first day of the meet for long course; 120 days preceding the first day of the meet for short course), mandatory participation in the Senior meet is required in order for a swimmer to receive reimbursement. The New England Board may waive this requirement for good cause, such as illness or conflict with the National Team requirement. This requirement will be waived for short course.

A swimmer must request the reimbursement within eight weeks of the meet. The request must include the stub from the swimmer's plane ticket or receipt of other expense to equal or exceed the amount of requested reimbursement.

To be eligible for reimbursement, an athlete must have been registered in New England and have competed in a New England calendar meet at least six months prior to the meet for which reimbursement has been requested.

Waivers for the US Open and National Championships: A swimmer who does not participate in three New England calendar meets during short course season may request a waiver for a championship meet during that season only if he/she participates in three New England calendar meets during the long course season. A swimmer who does not participate in two New England calendar meets during the long course season may request a waiver for a championship meet during that season only if he/she participates in three New England calendar meets during the short course season. All requests for waivers will be considered following the long course season.

Waivers for the Sectional Meets: For the Sectional Meets there will be no waivers.

COACH REIMBURSEMENT POLICY:

For each team that sends a swimmer to the National Championship or the US Open, New England Swimming will provide \$150 to reimburse coach expenses. The \$150 per team may be used to reimburse one coach or be split among several team coaches at the team's discretion. The team will have to provide New England Swimming with receipts for coach expenses which equal or exceed the \$150 reimbursement.

For the Sectional Meet an amount of \$1,500 will be shared by the coaches who attend the meet and apply and submit receipts within the eight week period (one coach per team) with a limit of \$100 per coach.

CPR COURSES: There has been some confusion about AHA (American Heart Association) which are acceptable for coach certification. In 1998, USA Swimming approved Heart Saver PLUS as meeting the requirements for CPR for coach membership. AHA Heartsaver is not acceptable as a course because is is an "audit" course with no written test and no skills demo. For the same reason, the EMP America Medica/First Aid course is not acceptable.

A MESSAGE FROM THE CHAIRMAN OF NEW ENGLAND SWIMMING

The New England Swimming Board met on March 20th and approved the championship calendar for the long course season. This calendar, which is outlined elsewhere in the newsletter, is the culmination of much work by Calendar Chair Pam Warner and the Calendar Committee with input from many coaches at the Age Group Championships, the Sectional Meet and the New England District Meets. The long course championship format represents a departure from our traditional 13-19 Age Group and Senior Championships for the summer season. With the addition of the USA Swimming Sectional Championships, it was felt that a new single New England Championship Meet was far preferable to two meets that might not be well attended. The coaches have been very helpful in designing a meet format that will address the needs of differing levels of swimmers in one championship meet. In general this meet, to be held one week after Sectionals, August 2-5, will be a trials/finals format with one set of cuts for athletes of any age reasonably close, in most events, to the current 13-14 age group cuts. All ages will swim together in prelims seeded by time. The top 24 of all ages from prelims will come back at night in Bonus/Consols/Championship finals. As a separate event, the next 8 fastest 13-14 swimmers from prelims after the top 24, will swim a separate finals heat at night. There are many details about the meet yet to be worked out, but it poses a great opportunity for an exciting long course championship for our older athletes. The 12 & Under Championship Meet is unaffected by this change but will include longer distance events consistent with USA Swimming policies.

"Keys to Success"

From Four Coaches of Olympic Swimmers
Sharon Power, Don Lemieux, Josh Stern, and Mike Parratto

The theme of the coaches clinic this year is "Keys to Success." In each session we will strive to present succinct, to-the-point, strategies for success that you can use starting Monday morning.

Session 1: Friday, May 4, 5pm to 9 pm. Stroke Technique: How and What to Teach. This is a good course for both new and experienced coaches. Bill Sweetenham, one of the World's great coaches from Australia said, "We do the exceptional things exceptionally well, but we only do the basic things basically well." This course is about teaching the basics exceptionally well. Fundamentals of each stroke, starts, and turns are presented along with recommended progressions and specific teaching techniques for each. New Coaches will learn stroke drills or teaching techniques to use for fixing specific stroke problems. Experienced coaches will enjoy a fresh look at the strokes and perhaps pick up some new techniques and drills. The ASCA Level 2 Stroke School manual is included and Certified ASCA members who complete the take home test will receive credit. Taught by Guy Edson, ASCA Staff. Speakers include Sharon Power, coach of Gold Medalist Ian Crocker; Don Lemieux, coach of Gold Medalist Samantha Arsenault; Mike Parratto, coach of Golds Medalist Jenny Thompson; and Josh Stern, coach of Olympian Erik Vendt. Non members will receive a complementary 1 year membership in ASCA if attending at least two paid sessions.

Session 3: Saturday, May 5, 6:45 pm--9:00 pm. Keys to Success: Becoming a Successful Professional Coach. In part 1 Harvard University Head Coach Tim Murphy will moderate a round table discussion with Sharon Power, Don Lemieux, Josh Stern, and Mike Parratto. The topic of the round table will be to discuss the keys to making your position and your work successful by working sometimes within the system, and sometimes stepping out of bounds. MEET DATA MANAGEMENT--updates and revisions:

- 1. All meet invitations will be posted on the web site and will not be mailed to teams. If a team needs a paper copy of the meet invitation, the club should contact the contact person listed in the newsletter and on the web site.
- 2. Teams running meets will not accept entries for four days after the meet invitation has been posted on the web site. Any entry received prior to the 4th day following posting will be considered received on the 4th day.
- 3. A paper copy of the meet entry and payment for the entry must be received within four days, not including Sundays and holidays, of the receipt of the meet entry. If the payment and paper copy are not received within this period, the host team may decline the entry.
- 4. Teams entering meets must be notified by the host team within seven days of the receipt of the entry if they are in the meet or if they have had to be cut from the meet because of over-subscription. If a team is cut from a meet, the entry fees must be returned in a timely fashion. As soon as the meet is full, the host team must notify the web master so that the calendar can reflect this.
- 5. Meet results must be submitted to the webmaster within three days of the completion of the final day of the meet. Paper results will not be sent to the teams attending the meet, but eight copies must be submitted to the New England office.

The original "Meet Data Management" document was published in the September 2000 issue of "Newsletter Plus." A new "MeetData Management" document incorporating the above updates and revisions will be available at the Annual Meeting and the Meet Manager's Meeting and will be printed in the next issue of the newsletter and also on the web site.

TOP 16 NATIONAL AGE GROUP REPORTABLE TIMES and NEW ENGLAND SWIMMING RECORDS.

Coaches, Parents, and Swimmers:

With the conclusion of the 2000-01 Short Course Season, I am now busy tabulating New England Swimming's Top 16 National Age Group Reportable Time List and updating New England Swimming Records. In order to accomplish this task, I need your help.

Please submit all out-of-LSC and non-calendar meet results to Mary Riddell at the New England Swimming Office as soon as possible. Some host teams are no longer mailing hard copies of results to attendees since results can be found on-line, but if this is the case, please email me where the results can be found. However, you still must mail a hard copy of the results to Mary! Not only are these results used to verify Top 16 and New England Record, but also to create the Top Ten lists and determine Outstanding Swimmer winners.

For non-calendar meets both within and outside of New England, please do not assume that I know where every team in New England swam this past season. Also, please do not assume that another team has provided me with the results of a particular non-calendar meet. It can be upsetting for swimmers when they are left off a Top 16/Top Ten list, especially the younger ones, simply because their coach failed to submit the meet results. When everyone assumes someone else is doing it, it doesn't get done!

Also, in addition to your sending the results, I need to be notified of record-breaking and/or Top 16 reportable swims. A form is located on the New England Swimming web page.

You may print out and complete this form. You may mail the form or put the same information into an email message to me. This will help to avoid any "missed" swims. The 2001 National Age Group Reportable Times plus an explanation of Top 16 can be found on the USA Swimming web site under "Fast Times".

Please remember.....

Since Top 16 is an Age Group Program sponsored by USA Swimming, a swimmer must be registered at the time of his/her swim to have that time eligible for consideration. Not all times made at high school, YMCA, college and other meets are eligible for submission. Because of differences in rules, only swims that have been properly observed by USA Swimming officials and have been certified to be in accordance with USA Swimming rules and regulations can be used for Top 16. Times from conference championships and state championships are usually observed, but not always.

If a swimmer achieves a Top 16 National Age Group Reportable Time, there is no guarantee that he/she will be included on the final Top 16 list. When the final listing is released only the sixteen fastest swims in the nation will be included. Many times more than half the swimmers who submit Top 16 times do not make the final list.

As for New England Records, only swims from USA Swimming sanctioned meets are eligible. A New England record is the best time done in New England by a USS

registered swimmer, where a "Resident Record" is a best time done anywhere in the country in a USS sanctioned meet by a New England registered swimmer.

If you have any questions or need to speak to me, please do not hesitate to call. Thank you in advance for your assistance. For your information, I must submit our preliminary list to USA Swimming by May 15.

USA SWIMMING NATIONAL DISABILITY CHAMPIONSHIPS:

Wayne Ross brought home 2 Gold and 3 Silver medals from the USA Swimming National Disability Championships in Phoenix, Arizona, June 22--24 in the Men's S2 classification. In spite of the 100 degree plus temperatures and three days of preliminaries and finals, Wayne swam to three personal best times. He placed first in the 50 meter and 100 meter backstroke and second in the 50 meter, 100 meter and 200 meter freestyles.

It's that time of year again! We need to vote for the <u>ASCA 2001</u>

Introduction

Bill Geary gave a brief introduction, reporting that he is now the officials chair for NES. He stated that his goals as the new officials chair include continuing to ensure that NES has a high level of competence among its officials, improve recruiting of new officials, encourage retention and advancement of current officials, improve the level of meet participation by officials, and encourage large and meet-hosting teams to provide officials.

Issues Facing NES Officials

The key issues relate to officials recruiting, retention, and participation, as well as encouraging large and meet-hosting teams to develop officials. Several ideas were offered to achieve these goals. These ideas included:

- NES should monetarily reward teams who supply meet officials, e.g., by discounting meet entry fees.
- Set a goal for the suggested number of officials that a team should have per swimmer, e.g., 1/25.
- Require a standard ad in all meet programs encouraging parents to become officials and providing the necessary information for certification.
 - Provide awards/recognition to officials for long-term service.
 - Offer officials training clinics between sessions at selected swim meets.
- Establish a rule, to be effective in x months/years, that teams will not be awarded meets unless they have a meet ref and/or can guarantee a specified number of officials.
- Establish in advance a calendar of officials training clinics and assign facilitators to these clinics.
- Fine a team that requests a clinic, promises a minimum number of attendees, and fails to meet the minimum.

It is my duty, as Officials Chair, to make sure that NES officials meet the high standards that USA Swimming requires of its officials. I believe that NES officials are already among the most knowledgeable and capable swimming officials in the country. With your support we can be even better!

I am now in the process of forming an Officials Committee for New England Swimming. This committee will be responsible for a variety of things, including recruiting, retaining and promoting officials, training new and current officials, and communicating rules and procedures to all NES officials. In a large LSC such as New England, communication can sometimes be difficult. Hopefully, communication of news and information that concerns officials will be improved with the implementation of an Officials Committee, together with the use of an Officials Liaison for NES registered teams. More information on the Team Officials Liaison was sent out to all NES teams with the new registration materials.

I am quite happy with the state of officials in NES. But, there are still some problem areas that will require a lot of attention. For example, we still find ourselves short staffed at some swim meets. Poor staffing is a problem because it is difficult to run a meet properly without a full deck of officials. This has the potential to hurt our swimmers because they will not be accustomed to the procedures and rule enforcement that are in place during a properly officiated meet. We don't want our swimmers to be surprised and unprepared when they attend a large meet within our LSC or one outside of New England.

Two immediate goals that I have set for NES are to increase the number of certified officials in New England Swimming and to ensure that all NES swim meets have a sufficient number of officials. Please help us achieve these goals. If you are not already an official, please consider becoming one. If you are an official already, please consider training for a higher position, and try to work more meets than you did last year.

REIMBURSEMENT POLICY FOR NATIONAL AND SECTIONAL MEETS, 2001--2002

ATHLETE REIMBURSEMENT POLICY:

A New England registered swimmer who qualifies for and swims in an individual event at the US Open will be reimbursed \$150 by New England Swimming. A New England registered swimmer who qualifies for and swims in an individual event at National Championships will be reimbursed \$300 by New England Swimming. A New England registered swimmer who qualifies for and swims in an individual event at the Disability Championships will be reimbursed \$300 upon request. Disabled swimmers are strongly urged to participate in New England meets. However, the Board will consider waiving the minimum meet requirement on a case by case basis. A New England registered swimmer who qualifies for and swims in an individual event at the Sectional meet will be reimbursed. For this meet, an amount of \$5,000 will be shared by the qualified swimmers who apply and submit receipts within the eight week period, with a maximum of \$50 per swimmer.

During the short course season a swimmer must fully participate in three New England calendar meets to be eligible for reimbursement. During the long course season a swimmer must fully participate in two New England calendar meets to be eligible for reimbursement. "Full participation" means participation in all or at least two days of competition and at least one individual event at each day of participation.

If the New England Senior Championships is in place with a named facility by a certain date (90 days preceding the first day of the meet for long course; 120 days preceding the first day of the meet for short course), mandatory participation in the Senior meet is required in order for a swimmer to receive reimbursement. The New England Board may waive this requirement for good cause, such as illness or conflict with the National Team requirement. This requirement will be waived for short course.

A swimmer must request the reimbursement within eight weeks of the meet. The request must include the stub from the swimmer's plane ticket or receipt of other expense to equal or exceed the amount of requested reimbursement.

To be eligible for reimbursement, an athlete must have been registered in New England and have competed in a New England calendar meet at least six months prior to the meet for which reimbursement has been requested.

Waivers for the US Open and National Championships: A swimmer who does not participate in three New England calendar meets during short course season may request a waiver for a championship meet during that season only if he/she participates in three New England calendar meets during the long course season. A swimmer who does not participate in two New England calendar meets during the long course season may request a waiver for a championship meet during that season only if he/she participates in three New England calendar meets during the short course season. All requests for waivers will be considered following the long course season.

Waivers for the Sectional Meets: For the Sectional Meets there will be no waivers.

COACH REIMBURSEMENT POLICY:

For each team that sends a swimmer to the National Championship, the Disability Championships, or the US Open, New England Swimming will provide \$150 to reimburse coach

expenses. The \$150 per team may be used to reimburse one coach or be split among several team coaches at the team's discretion. The team will have to provide New England Swimming with receipts for coach expenses that equal or exceed the \$150 reimbursement.

For the Sectional Meet an amount of \$1,500 will be shared by the coaches who attend the meet and apply and submit receipts within the eight week period (one coach per team) with a limit of \$100 per coach.

NEW ENGLAND SWIMMING ANTI-RECRUITING POLICY

Active recruiting – the solicitation of an athlete of one USS member club by another USS member club – is contrary to the best interests of New England Swimming and its more than 5000 athlete members.

USS member clubs within New England Swimming shall be prohibited from directly or indirectly soliciting or encouraging an athlete of another USS member club to leave his or her existing member club to join the soliciting club. This anti-recruiting policy shall prohibit a USS member club officer, employee, or coach from directly or indirectly initiating control with an athlete from another USS member club in New England Swimming, or the athlete's family, with the intent that the athlete join the soliciting club.

For any new USA Swimming club, conduct in violation of this rule in the year prior to becoming a USA Swimming Club may result in the sanctions provided herein.

The intent of this anti-recruiting policy is to prevent organized and club-sanctioned efforts to persuade a member of one USS member club to leave his or her member club to join the other member club. It is not the intent of this anti-recruiting policy to prevent athletes or parents of athletes of one member club from initiating contact with coaches, officials or athletes of another member club for the purpose of inquiring about joining the other member club. Once such contact is initiated, the restrictions of this anti-recruiting policy shall not apply to any contact with that athlete or family by that member club. Nor is it the intent of this anti-recruiting policy to prevent athletes or parents of athletes from different clubs from discussing any aspect of their respective USS member clubs, or incidental contact, such as may occur at a competition when a coach, parent, or athlete of one club offers to congratulate an athlete from another club. However, any such activities which are shown to have been promoted, encouraged or facilitated by a USS member club officer, employee or coach with the intent of recruiting shall be in violation of this anti-recruiting policy and subject the member club and/or its coach to the sanctions of this anti-recruiting policy.

Nothing in this anti-recruiting policy shall prevent a USS member club from conducting self-promotional activities such as advertising, team tryouts or camps for the purpose of recruiting athletes, as long as there is no direct solicitation of athletes of another member club.

Violation of the this anti-recruiting policy may be reported to the New England Swimming Board of Review which, upon review of the complaint, may conduct hearings under the by-laws of New England Swimming. Any USS member club or USS member coach found to have violated this anti-recruiting policy may be suspended from New England Swimming for up to one year for a first offense and for up to two years for a second or subsequent offense. Suspension of a member coach for a violation of this anti-recruiting policy shall prohibit that coach from being on deck for any USS competition sanctioned by New England Swimming during the period of suspension. Suspension of a USS member club for a violation of this anti-recruiting policy shall not prohibit the registration of the

club, athletes or coaches, but shall prohibit the member club from competing as a team in USS competition sanctioned by New England Swimming, including all championship competition during the period of suspension. Athletes agistered with any such suspended club may compete in any USS competition sanctioned by New England Swimming, but may do so only as an unattached athlete.

This policy is in addition to the requirements of USA Swimming. Please refer to the Code of Conduct printed in the USA Swimming Rules and Regulations, sections 304.1, 304.2 and 304.3.13.

Meet Data Management

The following activities relate to the posting of the meet, accepting entries and publishing results.

Create the meet invitation

Be sure to include the following milestone dates:

- The first day that entries will officially be accepted. This must be at least four days after the meet is posted on the New England Swimming website. They can be received before this date, but this date will count as the first day of acceptance of entries.
- The last date that entries will be accepted for the meet.

Other information that should be in the invitation

- What are acceptable payment options and how do they affect the acceptance date of the entry. The New England Swimming policy is that the date of your e-mail is the date of your entry assuming that your check arrives within 4 days of the e-mail entry excluding Sundays and holidays. If the check does not arrive within the required time, the date that your check arrives is the date your entry is considered received.
- Ensure that a hard copy of the entry and release form are sent with the check. (Some teams are forgetting to send the release form.)
- State clearly your policy on updating times. The invitation should define the acceptable format and the deadline for receiving updated times. Think this one over carefully before you commit to anything. New England Swimming encourages teams to accept updated times but it does not require host teams to do so.
- It should be clear in the invitation whether you will accept entries on disk in addition to e-mail entries. It is extremely important that the computer that is being used to accept the entries, either via e-mail or on a disk have an up-to-date virus checking program running. The teams sending entries must also ensure that the files that are sent are virus free.
- It should be made clear that entry files have to be in a standard meet entry format, either .cl2 or .sd3. You do not want a text file of an entry that you have to type in by hand.

Information regarding the invitation and entries

- A hard copy of the meet invitation will not be sent to individual teams in the New England LSC. The sole required announcement of the meet is on the current season meet calendar of the New England Swimming Website. Teams may request a hard copy of the invitation by contacting the host team.
- Teams entering meets must be notified by the host team within 7 days of the receipt of the entry if they are in the meet or if they have had to be cut from the meet because of over subscription.
- If a team is cut from a meet, the entry fees must be returned in a timely fashion.
- As soon as the meet is full, the host team must notify the webmaster so that the calendar can reflect this.

Send the following information to the webmaster

- The date when the webmaster is to post the meet invitation on the web.
- The meet invitation. To post the invitation she needs a file in Word format, a text file or a PDF file. If you have the document posted on your own website, a URL to that document will work. A link to the home page of your team is not acceptable. The meet invitation must be sent to the webmaster seven days in advance of posting. If significant reformatting of the invitation is required, the host team will be billed for this activity by the webmaster. It is important to note that this invitation is the only way teams are going to know about the meet.
- Also, if possible, e-mail to the webmaster a file containing the events of the meet that can be imported directly into team management programs. Most Meet Management programs will do this.
- If you have the capability, send a PDF file of the entry to the webmaster. This is a format that can be easily printed

Getting the results to the masses

- If you are using hy-tek send a flat html file of the results to webmaster. This must be done within three day of completion of meet.
- Send a file of the results that can be imported into Team Management Programs to the Webmaster. It is best if this is in the zipped file format.
- If you have the capability, send a PDF file of the results to the webmaster in case a team wants to print out a copy.
- Eight printed copies of the results are to be sent to the New England Swimming office.
- The former practice of selling a copy of the results is still at the option of the host team.

TECHNICAL COMMITTEE REPORT:

At its meeting on September 18, 2001, the Board of New England Swimming accepted the following recommendations of the Technical Committee:

OPEN CHAMPIONSHIPS: Time standards will be more difficult, and athletes will be limited to 9 events. In order to balance the sessions, the 1500 for girls and the 800 for boys will be offered one day, and the 1500 for boys and the 800 for girls will be offered on a different day. The question of scoring high points for 13 and 14 swimmers will be revisited befroe long course. No awards for 13 and 14 swimmers will be added for this past season.

EXHIBITION SWIMS: There will be no exhibition swims at Championship Meets.

ADMINISTRATIVE DQ'S: Coaches at the Open Championships will be encouraged to scratch swimmers rather than request administrative DQ's.

TIME TRIALS: All "end of season" meets will offer time trials at the discretion of the Meet Referee. The meet invitations will reflect this policy. There will be no sanction fee charged for the time trial sanction for the teams running these meets.

New England records can be set at time trials at calendar meets. Beginning with short course 2001--2002, Top Ten Times can be achieved at time trials at Championship Meets. All time trials must be published with results.

Fees for time trials will be no more than \$5\$ for individual events and \$10\$ for relays.

CHAMPIONSHIP MEETS: The fees for trials and finals championship meets will increase:

The cost for timed finals championship meet events will be as follows:

Individual events, \$3 (\$3.50 for hand entries)
*Distance events, \$5 (\$5.50 for hand entries)
Relays, \$7

The cost for trials and finals championship meet events will be as follows:

Individual events, \$4 (\$4.50 for hand entries)
*Distance events, \$5 (\$5.50 for hand entries)
Relays, \$7

*400 and longer

At 12 and under Age Groups, swimmers will be limited to 9 events. Relays will be limited to 2 per team per event. 200's will continue to be offered at 12 and unders. Tentatively, the 1650 will be offered on Thursday and the 1000 on Sunday. There will be different time standards for the Age Group meets and the Open Championships for short course and long course.

The acceptance of late entries will be at the discretion of the meet director of each championship meet.

AGE GROUP QUALIFIERS: Time standards for the Age Group Qualifiers will extend up to the time standards for the Sectional meet.

TIMERS: Timers may be assigned for the Age Group Qualifiers and all other "end of season" meets (bronze, districts, age group, senior and open championships). Teams may ask for volunteers for other meets, but may not assign timers. Teams that violate this requirement may be refused future meets.

Top Ten Times are compiled using results from New England calendar meets held during the past year. Short course (25 yard) times run from June 1, 2000 through May 31, 2001; long course (50 meter) times run from October 1, 2000 through September 30, 2001.

In addition to the New England sanctioned calendar meets, we also use times from out of district sanctioned meets if the results are sent to the office and if the meet is open to all USA Swimmers. We consider all times from the meet--trials, finals, and swim-offs--except time trials. We also consider lead-off splits from individual events and relays when they are printed in the results.

We do not include meets that are closed--restricted to certain teams, league members, etc. For this reason, we do not consider high school meets, "Y" meets, etc.

OUTSTANDING SWIMMERS are those who have accumulated the most points through their top ten standings. The scoring is as follows:

12 9 8 7 6 5 4 3 2 1 POINTS:

ARTICLE 103 FACILITIES STANDARDS

EFFECTIVE DATE: NOVEMBER 1, 2001

Approved by USA Swimming House of Delegates September 14, 2001 This language will appear in the 2002 USA Swimming Rules & Regulations as well as be published separately.

103.1 DEFINITIONS [no change]

103.2 WATER DEPTH [was part of 103.2.3 Racing Course Dimensions/ now a separate section]

.1A /NC/ 2 meters (6 feet 7 inches) deep throughout the course.

- .2 /M/ Teaching Racing Starts Minimum water depth for teaching racing starts in any setting from any height starting blocks or the deck shall be 5 feet (1.53 meters) measured for a distance of 3 feet 3 ½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from the end wall.
- .3B /M/ Racing Starts Minimum water depth for racing starts during practice and competition and practice shall be measured for a distance 3' 3 ½" (1.0 meter) to 16'5" (5.0 meters) from the end wall. Starting requirements and height of starting blocks shall be:
 - $\underline{A(1)}$ In pools with water depth less than 3' 6" (1.07 meter) at the starting end, the swimmer must start from within the water;
 - $\underline{B(2)}$ In pools with water depth 3' 6" (1.07 meter) to less than 4' (1.22 meter) at the starting end, starting platforms shall be no more than 18" (0.46 meter) above the water surface;
 - <u>C(3)</u> In pools with water depth 4' (1.22 meter) or more at the starting end, starting platforms shall meet the height requirements of Section 103.11.1.

Note: Local, state and municipal statutes, ordinances, rules and regulations may have depth limitations in conflict with <u>this</u> Section 103.2.3. The LSC and all Member clubs should check for this at all times.

SUBJ: Changes in Water Depth Legislation

On September 14,2001, the USA Swimming House of Delegates approved an amendment to the facilities standards section of the USA Swimming Rules and Regulations regarding water depth. This amendment has an effective date of November 1, 2001. Thus, we are giving you notice of this change now.

You may have questions after reading the changes. We are preparing an FAQ (frequently asked questions) sheet, which should answer your questions. As soon as it is ready, we will distribute it to all involved as well.

Part of the new language states "Minimum water depth for teaching racing starts in any setting from any height starting blocks or the deck shall be 5 feet ..." Please note that "in any setting" includes both practice and competition. It implies as well that teaching of racing starts must be under the direct supervision of a USA Swimming coach member.

MEET DATA MANAGEMENT:

The Meet Data Management document which was printed in the September News-letter has been reprinted in this issue. There was some confusion about when email dentries will be accepted. When the entry is posted on the web site; there is a stated number of days before entries from teams will be accepted. (The minimum number of days is four.) During that period, teams may submit entries; but they are all considered to be received on the first day of acceptance. If the meet is oversubscribed on this first day of acceptance, a "lottery" must be held to determine which of the entries will be accepted. If a tream running the meet is uncomfortable with running the lottery, the New England Office will do it for the team.

STROKE AND TURN CLINIC:

The first Saturday session at SSSC will begin in the afternoon to be followed by the second session in the late afternoon. The order of events at both NCAC and SSSC will remain the same with the exception Of the 1650 which will be on Saturday at NCAC and Sunday at SSSC.

ASSIGNMENT OF TEAMS: Teams will be assigned to the meets that have two sites (Bronze, 8 and under Age Groups, Districts). Swimmers that are UN should contact the office for assignment.

A reregistering team that expects to participate in any of these meets must be fully registered by January 15, 2002 including a fully certified coach (CPR, First Aid, Safety Training for Swim Coaches and education requirement if not grandfathered), registered athletes, and all fees paid. Any reregistering team that does not adhere to this deadline will be required to swim all swimmers in these meets as "unattached" with no team points or relays.

TIMERS and OFFICIALS: In order to facilitate the smooth running of the meets, host teams will assign timers for all "end of season" meets, including the Age Group Qualifier. The assignment will be based on the number of swimmers per team in the meet. Officials volunteering to work in a meet will be counted toward the timing assignment IF the official's name and sessions to be worked are submitted with the team's entry to the meet. Officials are expected to work the sessions volunteered unless they hear otherwise from the meet management.

All officials must display their New England membership cards while on deck.

Meet Data Management

The following activities relate to the posting of the meet, accepting entries and publishing results.

Create the meet invitation

Be sure to include the following milestone dates:

- The first day that entries will officially be accepted. This must be at least four days after the meet is posted on the New England Swimming website. They can be received before this date, but this date will count as the first day of acceptance of entries. If the meet is oversubscribed at the end of the first day entries are accepted, a lottery must be used to choose the teams that can be entered into the meet.
- The last date that entries will be accepted for the meet.

Other information that should be in the invitation

- What are acceptable payment options and how do they affect the acceptance date
 of the entry. The New England Swimming policy is that the date of your e-mail
 is the date of your entry assuming that your check arrives within 4 days of the email entry excluding Sundays and holidays. If the check does not arrive within
 the required time, the date that your check arrives is the date your entry is
 considered received.
- Ensure that a hard copy of the entry and release form are sent with the check. (Some teams are forgetting to send the release form.)
- State clearly your policy on updating times. The invitation should define the acceptable format and the deadline for receiving updated times. Think this one over carefully before you commit to anything. New England Swimming encourages teams to accept updated times but it does not require host teams to do so.
- It should be clear in the invitation whether you will accept entries on disk in addition to e-mail entries. It is extremely important that the computer that is being used to accept the entries, either via e-mail or on a disk have an up-to-date virus checking program running. The teams sending entries must also ensure that the files that are sent are virus free.
- It should be made clear that entry files have to be in a standard meet entry format, either .cl2 or .sd3. You do not want a text file of an entry that you have to type in by hand.

Information regarding the invitation and entries

- A hard copy of the meet invitation will not be sent to individual teams in the New England LSC. The sole required announcement of the meet is on the current season meet calendar of the New England Swimming Website. Teams may request a hard copy of the invitation by contacting the host team.
- Teams entering meets must be notified by the host team within 7 days of the receipt of the entry if they are in the meet or if they have had to be cut from the meet because of over subscription.
- If a team is cut from a meet, the entry fees must be returned in a timely fashion.

QUALIFYING FOR "END OF SEASON" MEETS: Qualifying times may be achieved at New England calendar meets and at most other meets (high school, Y, boys and girls clubs, rec leagues) if there are results either brought to the meet or sent to the office. (See verification rules below.) Time trials or dual meets may be used if there are at least two teams with at least five swimmers from each club and if the referee signs the results.

There is no minimum number of New England meets in which a swimmer must participate in order to enter an "end of season" meet. However, if a swimmer wishes to swim with the Zone Team or receive reimbursement for Sectionals, US Open, or national championships, he/she must participate in three new England calendar meets during the season (two during long course season).

VERIFICATION: There will be a verification table at 9--12 Age Group Championships and 13 and over Age Group Championships. At these meets teams must submit to the verification table a copy of their meet entry with verification of all times indicated. Teams must also include a copy of any non-New England calendar meet results used for entry times.

At the 8 and under Age Groups, Bronze, and District meets, there will be no verification table, but teams are expected to have a copy of the meet entry with verification of times indicated and a copy of any non-New England calendar meets used in case they are asked for verification by the meet management

COACHES ON DECK: Any "coach" on deck at a New England meet who does not display his/her valid 2002 membership card will be asked to leave the deck, without exception. The referee will make a list of these "coaches" which will be sent to the office to be checked. If a "coach" who was asked to leave the deck is not fully registered (current certifications in CPR, First Aid, Safety Training for Swim Coaches and completed education requirement for second year coaches), the "coach" will be fined \$100 and the team \$200 to be paid within 30 days. Any "coach" who refuses to leave the deck will cause the team's swimmers to swim unattached for the remainder of the meet.

TIME TRIALS: All "end of season" meets will offer time trials at the discretion of the Meet Referee. New England records can be set at the time trials at calendar meets. Beginning with short course 2001--2002, Top Ten Times can be achieved at time trials at Championships Meets.

EXHIBITION SWIMS: There will be no exhibition swims at Championship Meets.

 As soon as the meet is full, the host team must notify the webmaster so that the calendar can reflect this.

Send the following information to the webmaster

- The date when the webmaster is to post the meet invitation on the web.
- The meet invitation. To post the invitation she needs a file in Word format, a text file or a PDF file. If you have the document posted on your own website, a URL to that document will work. A link to the home page of your team is not acceptable. The meet invitation must be sent to the webmaster seven days in advance of posting. If significant reformatting of the invitation is required, the host team will be billed for this activity by the webmaster. It is important to note that this invitation is the only way teams are going to know about the meet.
- Also, if possible, e-mail to the webmaster a file containing the events of the meet that can be imported directly into team management programs. Most Meet Management programs will do this.
- If you have the capability, send a PDF file of the entry to the webmaster. This is a format that can be easily printed

Getting the results to the masses

- If you are using hy-tek send a flat html file of the results to webmaster. This must be done within three day of completion of meet.
- Send a file of the results that can be imported into Team Management Programs to the Webmaster. The format of this file is .cl2. It is best if this is in the zipped file format.
- Send an email to whitney@seacoastswimming.com stating that you have sent the
 results to the webmaster at New England Swimming. DO NOT SEND THE
 CL2 FILE TO THIS ADDRESS.
- If you have the capability, send a PDF file of the results to the webmaster in case a team wants to print out a copy.
- Eight printed copies of the results are to be sent to the New England Swimming office
- The former practice of selling a copy of the results is still at the option of the host team.
