Current fiscal year results impacted by COVID-19 Relief Grant and LC Season sanction reductions

Impacts to Fiscal 2020-21 Budget include:

- approximate 9% reduction in full paying membership (flex / outreach increases)
- freezing of Registration Fees to current year levels (absorbing \$2 USA Swimming fee increase)
- COVID-19 related capacity restrictions continuing into SC season, limiting sanctioned revenues to ~30% of historical
- 'return to normal' for LC season, including National Meet schedules and associated program support
