

**Utah Swimming, Inc.**  
Board Meeting  
Tuesday, 8 April 2008 @ Conference Call

The meeting was called to order at 7:05 p.m.

**February's Minutes** were approved by an email vote; they were previously posted on [www.swimutah.com](http://www.swimutah.com).

**Officer Reports**

**General Chair:** Corynne had a suggestion from a coach to have this year's Long Course BC meet between the sessions at Long Course JOs. We discussed at great length, and explored various options to accommodate being able to do this. It was generally agreed not to change the starting or ending time. After much consideration it was decided that Utah Swimming would host the BC meet between the sessions of the JO Championships.

There was also a separate discussion about changing the number of events each swimmer would be able to swim at JOs. The reasons for this are as follows:

1. LCS's comparable to our size have a six event championship format.
2. Meet length: We want to give swimmers more rest and get them out of the sun.

A motion was made to change the number of events to 7 for this year only. It was seconded and passed. We also discussed adjusting the time standards.

**Administrative Vice-Chair:** Jim reported the audit is complete. The taxes have also been completed and need to be signed and sent in. All of the financial records are back.

**Secretary:** Bob had nothing to report.

**Treasurer:** Kyle has been reorganizing reports and setting up the checkbook. He asked about a statement from the self storage unit. He is going to make contact to have arrangements made through Jim, to keep it or move to a new one. The storage unit contains items for swim meets, some office supplies, signs and financial records. He also mentioned that reimbursements can be submitted by email. He does; however, need a copy of the invoice for his files.

**Age-Group Chair:** Lela was not present; however, we all agreed that she did a great job at Short Course Jos. We will make sure that clean up after a meet will not be an issue again. Corynne had mentioned that she had received a lot of positive feedback about the way the psych sheets were done.

**Coach Representative:** Lela was not present.

**Membership/Registration Coordinator:** Martha was not present.

**Officials Chair:** Emily is still working on re-wording the rule about no times in a scored meet. Jim made a motion that we vote by email to accept the new wording. It was seconded and passed. Chanin will be able to do express clinics after April 26<sup>th</sup>.

**Safety Chair:** Lyse' was not present.

**Technical Planning Chair:** Krissy has received some meets for the year long calendar. Some of these were still looking for officials, so they may need to be removed. She reported that Lela is still working on details for JOs for next March.
