## Treasurer's Report

Holly Hatch: As of 1/6/20 there was 154,643.43 in the bank (\$125,064 in Savings, \$24,000 in CD) Checking account closed, operating out of savings until new Treasurer is named and a new checking account can be opened.

Check writing protocol had not been followed, which led to unauthorized funds being withdrawn from the checking account by an unknown agent. We have insurance against this but it carries a \$25,000 deductible, which was not met. We will have a new treasurer in place as soon as possible.

## Athlete Report

TJ Willis: The Athlete Committee would like to support athletes who wish to go to the Eastern Zone meet at Liberty University but they do not support the University's controversial positions. They would like to write a statement letter supporting their stance. Mary Ellen cautioned the athletes to base their letter on facts not here-say.

There will be a spring clean-up day and Preble Street volunteer day over February break.

The Athlete Committee is writing a grant proposal for hosting a Leadership Summit. The award would be \$2000, which would need to be matched by our LSC.
