New Club: Chelsea Aquatic Club (CAC) has rejuvenated their USA Swimming club and received club approval from USA Swimming. Andrew Thomson is the head coach.

LEAP: We have received word that Michigan Swimming must complete Level 1 of the LSC Evaluation and Achievement Program (LEAP) by April 30, 2012. The Bylaws revision is a big first step in this process.

ConocoPhillips Outstanding Service Award: Nominations are open for this award (one per LSC). Recipients receive the award and an Outstanding Service Award pin. If you have someone you'd like to nominate send the description of the honoree's contributions to Julie.

2010 Club/Coach Renewals: There are still a few entities with registered athletes who have not registered coaches or club for 2010. And the number of coaches registered by several clubs are not in proportion to the number of their registered athletes. See USA SWIMMING RULE 502.4.3.

Coaches who are not registered or not up to date with credentials are a huge issue for me. I have threatened clubs that I will unattach all athletes who are entered in meets if a coach is not registered by the time I check the meet (and there will be a charge to the club to reattach them to the club). In some cases I have had to refuse to post meets until AT LEAST one coach is properly registered or credentialed.
