Sanction: This meet is sanctioned by Michigan Swimming, Inc., as a timed final meet on behalf of USA Swimming, Sanction Number **MI101122**. Michigan swimming rules, safety, and warm up procedures will govern the meet as if fully set forth in these meet rules.

Facilities: Howell Area Aquatic Center is a 6 lane pool with a diving well which will be available for supervised warm-up and warm down. Depth at start is 10 feet and 3 feet 6 inches at turn. Permanent starting blocks and non-turbulent lane markers will be used. Daktronics Timing System will be used. There is bleacher seating for spectators. Lockers are available (you must provide your own lock). The competition course has not been certified in accordance with 104.2.2C(4)

Eligibility: This meet is for those swimmers ages 10 and under. All swimmers must be currently registered with United States of America Swimming (USA). A swimmer's age on December 4, 2010 will determine his/her eligibility for a particular age group. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement

Meet Format: All events are timed finals.

Entry Limits: Entries will be accepted on a first come first serve basis by date of email for electronic entries and date of receipt by the entry chair for hard copy entries until the Michigan Swimming Four (4) hour per session maximum time limit is met. As set forth in entry procedures below, (A) a hard copy of your club's entry summary sheet, (B) a hard copy of your club's signed release/waiver agreement (C) your club's certification of entered athletes and (D) your club's entry and entry fees must be received by the Entry Chair in a timely fashion prior to the start of the meet, or your swimmers will not be allowed to swim in the meet. Entries received after the four (4) hour per session time limit has been met will be returned even if received before the entry deadline.

Individual

Entry Athletes will be limited to five (5) individual events per day, plus relays.

Limits:

Electronic Entries: **\$4 per individual event and \$12 for relays. Please include a \$1.00 Michigan Swimming surcharge for each swimmer entered.**

Paper Entries: MS rules regarding non-electronic entries apply. \$5 per individual event. There is a \$1.00 additional charge per individual event paid if the entry is not submitted in Hy-Tek format. The Michigan Swimming \$1.00 general surcharge for each swimmer also applies to paper entries. Paper entries may be submitted to the entry chair on a spreadsheet of your choice however the paper entry *must* be logically formatted and must contain all pertinent information to allow the entry chair to easily enter the swimmer(s) in the correct events with correct seed times.

Entry

Procedures: Entries may be submitted to the entry chairperson as of Saturday, November 6, 2010 at 12:00 PM (noon). The entry chairperson must receive all entries no later than Wednesday, November 24, 2010 at 11:59PM (midnight). Entries must include correct swimmer name (as registered with USA/MS Swimming), age and USA number. You can import the order of events/ event numbers from the Michigan Swimming website <http://www.miswim.org/> All individual entries should be submitted via electronic mail to the entry chairperson at hssentries@gmail.com. All entries will be processed in order by email date code or mail date code. Any entries submitted will be considered provisional until such time as the entry chairperson has received a hard copy of: (a) your club's entries (Team Manager Meet Entries Report), (b) a hard copy of your club's signed release/waiver agreement (c) your clubs signed certification of entered athletes and (d) your club's entry fees. This must be received in a timely fashion prior to the start of the meet or your swimmers will not be allowed to swim in the meet. Refunds: Once a team or individual entry has been received and processed by the entry chair there are no refunds in full or in part.

Check In: Check In will be available 15 minutes prior to warm-up, until 15 minutes after warm-up has begun. Check in is mandatory for all events and is required by the time set forth in this meet announcement. Failure to check in will cause the

swimmer to be scratched from **all** events in that session. . Also note that pursuant to MS Rules that failing to swim an event after checking in for that event will disqualify a swimmer from his or her next event. Check in sheets will be posted in the hallway outside the locker rooms

Scratch Rules: Swimmers who have not checked in during the times listed above will be scratched from that session's events. Prior to check in close a swimmer may scratch events at the Clerk of Course. After check in closes, you must see the Meet Referee to scratch an event. Once a swimmer has checked in for an event that swimmer must compete in that event or the swimmer will be scratched from his/her next event.

Marshaling: All events will be self-marshaled. Heat sheets will be posted in conspicuous places on deck and distributed to coaches at the start of each session. All swimmers will be expected to find their heat and lane independently. If a swimmer does not show up for the correct heat of the event, that swimmer will be scratched from his/her next scheduled event.

Seeding: Seeding will be done after check in closes. Swimmers who fail to check in for an event will be scratched from that event. All events are timed finals and will be seeded slowest to fastest.

Deck Entries: Deck entries will be taken if time is available within the Michigan Swimming 4 hour per session maximum time limit and at the discretion of the Meet Director and the Meet Referee. \$7 per individual event and \$14 for relays Deck entry swimmers are subject to the Michigan Swimming \$1.00 surcharge. For deck entries, registration status must be proven by providing current USA swimming membership card or a current print out of athlete roster from club portal. The club portal is located on the USA swimming website.

Meet Programs/

Admissions: **\$4.00 per day for persons over age 12. Children age 12 and under, with adult, are free. Programs are available for \$5.00**

Scoring: No individual or team scoring will be kept.

Awards: Individual Awards: Medals for 1st thru 3rd place, Ribbons for 4th thru 16th place
Relays will receive Medals for 1st thru 3rd and ribbons for 4th thru 8th place
Coaches can pick up their teams awards at the end of the last session of the meet.
Unattached swimmers may stop by the Awards table at the end of their session to pick up their awards. **Awards will not be mailed!**

No Time (NT)

Entries: A swimmer who has no official time for an event may enter that event with no submitted time (an NT). In accordance to MS Rules and Procedures, NT's are not eligible to receive awards.

Results: Complete meet results will be posted on the Michigan Swimming website at <http://www.miswim.org/> Results will also be available on flash drive (HY-TEK Team Manager file) upon request. Teams must provide their own flash drive.

Concessions: Assorted foods, beverages, baked goods, fruit and vegetables will be available in balcony area of the pool. No food or beverage will be allowed on the deck of the pool, in the locker rooms or in the spectator areas. A hospitality area will be available for coaches and officials.

Lost and

Found: Articles may be turned in/picked up at the admissions table. Articles not picked up by the end of the meet will be retained by the Meet Director or a representative for at least 14 days and then donated to a local charity.

Swimming Safety: Michigan Swimming warm up rules will be followed. To protect all swimmers during warm-ups, swimmers are required to enter the pool feet first at all times except when sprint lanes have been designated. No jumping or diving. The same rules will apply with respect to the warm-down pool and diving well. Penalties for violating these rules will be in the sole discretion of the meet referee which may include ejection from the meet.

Deck Personnel: Only swimmers, registered coaches and meet officials/workers are allowed on the deck. Coaches and officials must display their registration cards at all times. Coaches must be current in all certifications through the final date of the meet.

Swimmers with

Disabilities: All swimmers are encouraged to participate. If any of your swimmers have special needs or requests please indicate them on the entry form and with the Clerk of Course and/or the Meet Referee during warm ups.

General Info: Any errors or omissions in the program will be documented and signed by the meet Referee and available for review at the Clerk of Course for Coaches' review. Information will also be covered at the Coaches' Meeting.

First Aid: Supplies will be kept in the lifeguard's room located on the deck.

Facility Items: (A) No smoking is allowed in the building or on the grounds of Howell Public Schools.
(B) Pursuant to applicable Michigan law, no glass will be allowed on the deck of the pool or in the locker rooms.
(C) No bare feet allowed outside of the pool area. Swimmers need to have shoes to go into the hallway to awards or concessions.
(D) An Emergency Action Plan has been submitted by the Host Club to the Safety Chair and the Program Operations Chair of Michigan Swimming prior to sanction of this meet and is available for review and inspection at the Howell Area Aquatic Center.

Certification of Registration Status Of All Entered Athletes Howell Shiver and Splash

Michigan Swimming Clubs must register and pay for the registration of all athletes that are contained in the electronic TM Entry File or any paper entries that are submitted to the Meet Host with the Office of Michigan Swimming **prior to submitting the meet entry to the meet host**. Clubs from other LSCs must register and pay for the registration of their athletes with their respective LSC Membership Coordinator.

A penalty fee of \$100.00 per unregistered athlete will be levied against any Club found to have **entered** an athlete in a meet without first registering the athlete and paying for that registration with the Office of Michigan Swimming or their respective LSC Membership Coordinator.

Submitting a meet entry without the athlete being registered and that registration paid for beforehand may also subject the Club to appropriate Board of Review sanctions.

The authority for these actions is:

UNITED STATES SWIMMING RULES AND REGULATIONS 302.4 FALSE

REGISTRATION – A host LSC may impose a fine of up to \$100.00 per event against a member Coach or a member Club submitting a meet entry which indicates a swimmer is registered with USA Swimming when that swimmer or the listed Club is not properly registered. The host LSC will be entitled to any fines imposed.

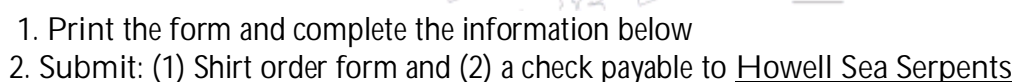
