

BEAT THE HEAT CHALLENGE
Hosted By: Bay Area Youth Swim Club (BAYS)
July 8, 9 and 10, 2011

Sanction: This meet is sanctioned by Michigan Swimming, Inc., as a timed final meet on behalf of USA Swimming, Sanction Number MI101173. Time Trials will also be offered if time allows. Time Trial Sanction Number MI101174. Michigan swimming rules, safety, and warm up procedures will govern the meet as if fully set forth in these meet rules.

Location: Bay County Community Center, 800 JF Kennedy Drive, Bay City, Michigan 48706.

Facilities: The Bay County Community Center Pool is a 6 lane 50 meter outdoor pool with a diving well which will be available for supervised warm-up and warm down. Depth at start is 6' 6" and 3' 6" at turn. Permanent starting blocks and non-turbulent lane markers will be used. Colorado timing with a one lane display will be used. The competition course has not been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. There is limited bleacher seating for spectators and they are urged to bring their own deck chairs. Lockers are available (provide your own lock). Public phones will be available. The Bay County Community Center, Michigan Swimming, Inc. and Bay Area Youth Swim Club are not responsible for lost or stolen items.

- Eligibility:** Beat The Heat Challenge is an open ABC meet for all swimmers. All swimmers must be currently registered with United States of America Swimming (USA). A swimmer's age on July 8, 2011, will determine his/her eligibility for a particular age group. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Meet Format:** The Beat The Heat Challenge is a timed finals format. 10 & Under's and 11-12 boys and girls swim in the AM sessions and the 13-14 and Open boys and girls will swim in the PM sessions.
- Entry Limits:** Entries will be accepted on a first come first serve basis by date of email for electronic entries and date of receipt by the entry chair for hard copy entries until the Michigan Swimming four (4) hour per session maximum time limit is met. As set forth in Entry Procedures below, entries are not deemed valid and will not be processed until such time as the entry chairperson has received: (a) a hard copy of your club's entry summary sheet, (b) a hard copy of your club's signed release/waiver agreement (c) your club's certification of entered athletes and (d) your club's entry and entry fees. Entries received after the four (4) hour per session time limit has been met will be returned even if received before the entry deadline.
- Individual Entry Limits:** Swimmers may enter a maximum of 2 events on Friday evening and a maximum of 4 events per day on Saturday and Sunday. Bay Area Youth Swim Club reserves the right to limit the number of heats of the Open 800 Free to comply with time limits.
- Electronic Entries:** \$4.00 per individual event. Please include a \$1.00 Michigan Swimming surcharge for each swimmer entered. Make checks payable to: BAYS.
- Paper Entries:** MS rules regarding non-electronic entries apply. \$5.00 per individual event. There is a \$1.00 additional charge per individual event paid if the entry is not submitted on Hy-Tek (or compatible) disk. The Michigan Swimming \$1.00 general surcharge for each swimmer also applies to paper entries. Paper entries may be submitted to the entry chair on a spreadsheet of your choice however the paper entry *must* be logically formatted and must contain all pertinent information to allow the entry chair to easily enter the swimmer(s) in the correct events with correct seed times.

Entry**Procedures:**

Entries may be submitted to the entry chairperson as of June 10, 2011 at 8:00 p.m. The entry chairperson must receive all entries no later than July 1, 2011. Entries must include correct swimmer name (as registered with USA/MS Swimming), age and USA number. You can import the order of events and event numbers from the Michigan Swimming website (www.uss-michigan.com). All individual entries should be submitted via electronic mail to the entry chairperson at mlanegreen@aol.com. Any entries submitted will be not processed until such time as the entry chairperson has received a hard copy of: (a) your club's entries (Team Manager Meet Entries Report), (b) a hard copy of your club's signed release/waiver agreement (c) your club's signed certification of entered athletes and (d) your club's entry fees. The complete Beat The Heat Challenge entry packet with entry forms is available on the Michigan Swimming Website at www.uss-michigan.com.

Refunds:

Once a team or individual entry has been received and processed by the entry chair there are no refunds in full or in part.

Check In:

Check In will be available 30 minutes before warm-ups begin and will close 15 minutes after the start of warm-ups. Check in is mandatory for all events and is required by the time set forth in this meet announcement. Failure to check in will cause the swimmer to be scratched from **all** events in that session. Also note that pursuant to MS Rules that failing to swim an event after checking in for that event will disqualify a swimmer from his or her next event. Check in sheets will be posted at the East end of the gymnasium.

Scratch Rules:

Prior to check in closes a swimmer may scratch events at the Clerk of Course. After check in closes, you must see the Meet Referee to scratch an event. Once a swimmer has checked in for an event that swimmer must compete in that event or the swimmer will be scratched from his/her next event.

Marshaling:

All sessions will be self marshaled.

Seeding:	Seeding will be done after check in closes. Swimmers who fail to check in for an event will be scratched from that event. All events are timed finals and will be seeded slowest to fastest other than the 800 meter freestyle and the 400 meter freestyle which will be seeded fastest to slowest (alternating genders-women/men).
Deck Entries/ Time Trials:	<p>Deck entries will be offered if time is available within the Michigan Swimming four hour per session maximum time limit. This will be at the discretion of the Meet Director and the Meet Referee. For deck entries, registration status must be proven by providing current USA Swimming membership card or a current print out of athlete roster from club portal. The club portal is located on the USA Swimming website. Deck entries are \$7.00 per event and will be subject to the Michigan Swimming \$1.00 general surcharge. If you need to deck enter a swimmer please do so at the sign-in table in the gym.</p> <p>Time Trials will be offered if time is available within the Michigan Swimming four hour per session maximum time limit. This will be at the discretion of the Meet Director and Meet Referee. Time Trials are \$7.00 per event and will be subject to the Michigan Swimming \$1.00 general surcharge. You may inquire about Time Trials at the sign-in table in the gym.</p>
Meet Programs/ Admissions:	Admission is \$4.00 per person over the age of 12. Children 12 and under, with Adult, are free. Full three day meet programs are \$6.00.
Scoring:	No individual or team scoring will be kept.
Awards:	Medals will be awarded for 1 st – 3 rd places and ribbons 4 th – 8 th places for all 12 and under events. No awards will be given for 13 and over events. All awards must be picked up by the coach at the end of the meet – they will not be mailed.
Results:	Complete meet results will be posted on the Michigan Swimming Website at www.uss-michigan.com . Results will also be available on flash drive (HY-TEK Meet Manager) upon request. Teams must provide their own flash drive.
Concessions:	Food and beverages will be available in the gymnasium. No food or beverage will be allowed on the deck of the pool, in the locker rooms or in the spectator areas. A hospitality area will be available for coaches and officials.

Lost and Found:

Articles may be turned in/picked up in the gymnasium. Articles not picked up by the end of the meet will be retained by the Meet Director or a representative for at least 14 days (any longer period shall be at the sole discretion of the Meet Director).

Swimming Safety: Michigan Swimming warm up rules will be followed. To protect all swimmers during warm-ups, swimmers are required to enter the pool feet first at all times except when sprint lanes have been designated. No jumping or diving. [The same rules will apply with respect to the warm-down pool and diving well]. Penalties for violating these rules will be in the sole discretion of the meet referee which may include ejection from the meet. To comply with USA Swimming privacy and security policy, NO CELL PHONES WITH CAMERAS OR ANY TYPE OF CAMERA OR VIDEO IS ALLOWED IN THE LOCKER ROOMS AT ANY TIME.

Deck Personnel: Only swimmers, registered coaches and meet officials/workers are allowed on the deck. Coaches and officials must display their registration cards at all times. Coaches must be current in all certifications through the final date of the meet.

Swimmers with Disabilities:

All swimmers are encouraged to participate. If any of your swimmers have special needs or requests please indicate them on the entry form and with the Clerk of Course and/or the Meet Referee during warm ups.

General Info: Any errors or omissions in the program will be documented and signed by the meet Referee and available for review at the Clerk of Course for Coaches review. Information will also be covered at the Coaches' Meeting.

First Aid: Supplies will be kept in the lifeguard shack near the scorers table.

Facility Items:

- (A) No smoking is allowed in the building or on the grounds of the Bay County Community Center.
- (B) Pursuant to applicable Michigan law, no glass will be allowed on the deck of the pool or in the locker rooms.
- (C) No bare feet allowed outside of the pool area. Swimmers need to have shoes to go into the hallway to awards or concessions.
- (D) An Emergency Action Plan has been submitted by the Host Club to the Safety Chair and the Program Operations Chair of Michigan Swimming prior to sanction of this meet and is available for review and inspection at the Bay County Community Center.

Certification of Registration Status Of All Entered Athletes Beat The Heat Challenge

Michigan Swimming Clubs must register and pay for the registration of all athletes that are contained in the electronic TM Entry File or any paper entries that are submitted to the Meet Host with the Office of Michigan Swimming **prior to submitting the meet entry to the meet host**. Clubs from other LSCs must register and pay for the registration of their athletes with their respective LSC Membership Coordinator.

A penalty fee of \$100.00 per unregistered athlete will be levied against any Club found to have **entered** an athlete in a meet without first registering the athlete and paying for that registration with the Office of Michigan Swimming or their respective LSC Membership Coordinator.

Submitting a meet entry without the athlete being registered and that registration paid for beforehand may also subject the Club to appropriate Board of Review sanctions.

The authority for these actions is:

UNITED STATES SWIMMING RULES AND REGULATIONS 302.4 FALSE REGISTRATION – A host LSC may impose a fine of up to \$100.00 per event against a member Coach or a member Club submitting a meet entry which indicates a swimmer is registered with USA Swimming when that swimmer or the listed Club is not properly registered. The host LSC will be entitled to any fines imposed.
