All athletes belonging to a club should register through the club. If you belong to a club DO NOT send applications directly to the MS Office.

Clubs should accept new registrations and renewals by having a parent or swimmer (if not a minor) complete and sign the current year's USA Swimming application. The club's registration officer should then process all registrations by entering all the information from these applications into the software that the club uses to manage their team.
