

- SANCTION:** Held under the sanction of USA Swimming/Metropolitan Swimming, Inc., # **191107**
Time Trial # **191151-T**
- LOCATION:** **Sachem North HS Pool, 212 Smith Road, Lake Ronkonkoma NY 11779**
- FACILITY:** **6 Lane x 25 yard competition pool, CTS6 Timing System, touch pads primary, with 6 lane numeric scoreboard. Competitor lane lines, Kiefer Evolution Starting Blocks**
The pool **Has NOT been** certified in accordance with Article 104.2.2C(4)
- SESSIONS:** **Session 1 – 11-12 & 15 & Over - 7:30AM Warm Up, 8:35AM Start Time**
Session 2 – 8 and Under 12:45PM Warm Up, 1:15PM Start Time – 2 Hour Max Session
Session 3 – 9-10 & 13-14 – 3:30PM Warm Up, 4:35PM Start Time
*** Time Trials may be available – Time Permitting, \$5 per event**
- FORMAT:** **This is a Timed Finals Meet. Events will be swum Slowest to Fastest.**
This meet will be Deck Seeded; Scratch sheets are due to the Administrative Table 35 mins prior to the start of the session.
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet.
No “Deck Registrations” will be accepted
Age on **November 16, 2019** will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration.
The athlete (or the athlete’s coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** All Athletes are limited to enter 3 events per session
Deck entries will not be accepted.
NT’s will not be accepted. Host team reserves the right to enter NT’s.
Entries are by invited teams only. Hy-Tek Email entries will be accepted

- DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro team’s entries must be received by **November 1, 2019**
2: The final entry deadline for this meet is **November 10, 2019**
3: Metro entries received between **November 1, 2019** and **November 5, 2019** will be entered first.
Entries from other LSC’s will be entered in the order they were received, as space allows.
An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days of your original email.
- ENTRY FEE:** An entry fee of **\$5.00** per individual event must accompany the entries.
Make check payable to: **Sachem Swim Club of Long Island, Inc.**
Payment must be received by **11/16/19** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- WARM-UP:** General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes will be available for the remaining 10 minutes. Lane assignments will be distributed along with the scratch sheet each session.
- SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches and which swimmers will not be participating in the session.

- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** **12 and Under Only will receive awards, 1st thru 6th place**

- RULES:** The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Prevention Policy (MAAPP) will apply.
The USA Swimming Code of Conduct is in effect for the duration of the meet.
The overhead start procedure may be used at the discretion of the meet Referee.
- SAFETY:** **All swimmers must wear footwear upon leaving the pool area.**
Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. **“Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer’s legal guardian, to ensure compliance with this requirement”**
- WATER DEPTH:** USA 2011 - 202.3.7 "The meet announcement shall include information about water depth measured for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."
1 Meter – 15 Feet, 5 Meter – 12 Feet
- DISCLAIMER:** **DISCLAIMER:** Upon acceptance of his/her entries, the participant waives all claims against **Sachem Swim Club of Long Island, Sachem Central School District**, Metropolitan Swimming Inc., USA Swimming Inc., their agents or representatives for any injury occurring as a result of the meet. "It is understood that USA Swimming, Inc. and Metropolitan Swimming, Inc. shall be free from liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event."
- AUDIO/VISUAL STATEMENT:** **Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms or behind the starting blocks.**
- DRONE OPERATION:** **Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.**
- DECK CHANGING:** Deck changes are prohibited.
- ADMISSION:** **Admission \$5.00 per session**
Programs \$2.00 per session
- MERCHANTS:** A concession stand may be available. No glass will be permitted on the deck.
A Swim Vendor may be available throughout the entire meet
- PARKING:** **Free Parking available in school parking lots**

DIRECTIONS: Long Island Expressway to Exit 60. Service Road to Hawkins Avenue Traffic Light. Turn Left. Continue North on Hawkins Avenue until Five Corners Intersection. Turn right on to Smith Street. School is on the right.

Purpose _____

Professional photographers/videographers will be allowed on deck at the discretion of the Meet Director and Meet Referee, and must adhere to the following guidelines:

Do not stand on the starting end of the pool, or in the starter's box; use of the bulkhead is at the discretion of the Meet Director and Meet Referee.

Do not stand on the edge of the pool (leave approximately two feet for officials and coaches).

Leave the deck when not actively photographing.

Respond immediately to direction from the Meet Referee.
