#### **SPECIAL CONSIDERATIONS:**

The Kroc Center will require all athletes and spectators to wear a bracelet while in the center in order to distinguish swim meet participants from Kroc Center members. There will be no cost to enter the swim meet. PLEASE ALLOW FOR ADDITIONAL TIME AT ARRIVAL TO THE KROC CENTER FOR CHECKING IN AND RECEIVING YOUR BRACELET. Coolers will not be allowed inside the pool area, but concessions will be available in the gym. There will be gym space available for swimmers and their families to use during the meet. Day passes will also be available to purchase for those who want to use the entire facility including the play pool, weight equipment and climbing wall. The cost will be Adults \$8, Teen/Senior \$5 and Youth \$4 per day. The climbing wall does have an additional fee.

#### **FORMAT:**

All events will be timed finals. The 1650 freestyle, 500 freestyle, 400 IM, and 12 and under 200 IM will be swum with combined age groups but scored separately. The meet will be a split session with 11-12 girls swimming with the 13 and overs and the 11-12 boys swimming with the 10 and unders.

**Positive Check In is required for the following everts**: 400 IM, 500 FREE by 4:30 pm Friday and the1650 FREE at the beginning of Session 2 on Saturday. Swimmers will be required to provide their own counters and timers for the 500 Free and the 1650. Meet Management reserves the right to limit the 400 IM, 500 Free and 1650 to allow completion within a timely manner each day.

#### COURSE

Indoor, 10 lane 25 yard pool equipped with eight starting blocks, backstroke flags, anti-wave lane lines and electronic timing using Colorado timing system with a full 10 lane scoreboard. Starting blocks meet 2009 USA Swimming height and water depth requirements. Touch pads will be installed at the dive end of the pool; 25 yard events will use the starting blocks and finish at the turn end. Deck marshals will be present for warm-ups. The competition course has been certified in accordance with 104.2.2C(4). The copy of a certification is on file with USA Swimming.

#### RULES:

Current USA Swimming rules will govern. The rules and procedures of Inland Empire Swimming will also apply. The Inland Empire scratch rule, whistle start protocol and the no recall rule will be in effect. The Meet Referee of the meet will be the final authority for the conduct of the competition. Coaches must be registered with USA Swimming for 2009 or 2010. Proof of coaching certification must be produced on request at any time to the meet referee. Only swimmers, coaches, and officials and meet workers will be permitted in the deck area. Spectators will not be allowed in the deck area without proof of current USA Swimming membership. The deck area is considered to be a 3 foot area from the edge of the pool and the area behind the starting blocks to the timer chairs.

Coaches must be 2009 members of USAS or Swimming/Nation Canada (SNC). All SNC coaches must complete and submit the USAS liability form prior to the start of warm-ups.

#### SCORING

Individual and relay events will score to 8 places.

AWARDS: Page 2

A participation award will be given to every swimmer entered in the meet. Ribbons will be awarded for 1st through 8th place in individual events and 1st through 3rd place in relay events. High point trophies will be awarded in each age group by gender. Plaques will also be presented to the top three teams.

#### **ELIGIBILITY:**

Open to currently registered (2009 or 2010) USA swimming athletes and SNC athletes. All SNC swimmers must complete and submit the liability waiver prior to the start of warm-ups. Registration numbers must be included with entries. Age on the first day of the meet determines the age group to enter. Each swimmer must swim in his/her respective age group. Athletes with a disability are welcome and are asked to provide advance notice of necessary accommodations.

#### **ENTRIES:**

Age 10 and under swimmers may enter 5 individual events per day. Ages 11 and over swimmers may enter 2 individual events per day on Friday and 5 individual events on Saturday and Sunday, in addition to one relay.

Enter swimmers best yard times. NT (no time) entries will be accepted and seeded in the first heats.

Entries should be submitted on 3 1/2" diskettes with Team Manager (Hy-Tek) Software. Please include the hard copy "Meet Entry Report" or the enclosed Master Entry forms as a back-up. Entries must include current (2009 or 2010) USA Swimming registration numbers.

The data will be sent to USA Swimming within 3 days of the end of the meet. Thanks for your cooperation.

#### **ENTRY FEES:**

Entry fees are 3 dollars (\$3.00) for each individual event and 12 dollars (\$12.00) for each relay event plus a \$10.00 surcharge per swimmer. Fees and surcharges for each team must be paid with one check and accompany entries. Please make the check payable to CAST and address entries to: CAST, P.O. Box 846, Post Falls, ID 83877




