There will be a 15-minute warm up prior to the start of the 500 Free on Saturday.

**Entry Fees** An entry fee of \$17.00 plus \$2.00 per event will be charged. There will be a charge of \$5.00 per relay team. Make checks payable to the **Bozeman Swim Club**. *No entries will be accepted without payment of fees. There will be no refunds.*

**Entry Deadline** All entries must be received in Bozeman no later than Wednesday, December 1, 2010. Mail entries to: **Bozeman Swim Club**

***Entries must be made through the swimmer's club with a team check.*** Unattached swimmers may make direct entries. Phone entries will be accepted until 9:00 p.m. Thursday December 2nd. Phone individual entries to Cindy Smith at 556-1855. ***Phone entries for entire teams will not be accepted.***

**Rules** 2010 USA Swimming Rules and Montana Swimming Rules will govern the meet.

**Age Groups** 8&U, 9-10, 11-12, 13-14, 15-16, 17-18 and 19 & Over. All combined/mixed individual events will be awarded and scored separately by age group. Age on December 11<sup>th</sup> shall determine the swimmer's age for the meet.

**Eligibility** Open to all swimmers who are currently registered with USA Swimming, the foreign equivalent or US Masters Swimming (USMS). Masters swimmers are welcome and encouraged to compete. **Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.**

**Limitations** Each swimmer may compete in a maximum of four (4) individual events per day and one relay. The meet limit is a total of eight (8) individual events.

**Entries** All entries may be submitted by e-mail or on the enclosed master sheet. For accuracy electronic entry is preferred. E-mail address is: [bozemanbarracudas@yahoo.com](mailto:bozemanbarracudas@yahoo.com). Also complete and return the Accounting Sheet with your entries (enclosed in the entry packet).

<b>Relays</b>	Relay entries may be submitted on the Relay Entry Sheet provided in the packet. All relays may be mixed age and gender.
<b>Seeding</b>	Each swimmer will be seeded according to submitted times in yards and age group. <i>The 500 Free AND 400 IM will be seeded fastest to slowest. All relays will be mixed – women and men.</i> No Time (NT) entries will be accepted.
<b>Format</b>	All events will be timed finals.
<b>Clerk of Course</b>	There will be no Clerk of Course. Heat and Lane assignments will appear in the program. Swimmers are responsible for taking their position behind the blocks.
<b>Timing</b>	An automatic electronic timing system will be used along with backup timers. Each club will be responsible for providing at least two (2) timers at all times. A sign-up sheet will be posted at the meet. <b>Swimmers entered in the 500 Free must provide their own counter and timers.</b>
<b>Scoring</b>	Individual: 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1 Relays: No points will be given for relays.
<b>Awards</b>	Overall Teddy Bear awards will be given to the top sixteen boy and girl swimmers in each age group ages 14 and under, and to the top eight boys and top eight girls in the 15-16 and 17-18 age groups.
<b>Concessions</b>	Concessions will be available each day. <i>Absolutely no glass containers are allowed in the locker rooms or deck areas.</i>
<b>Swim Shop</b>	There will be a full swim shop on site throughout the meet.
<b>Meetings</b>	If necessary a coach's meeting will be announced. An official's meeting will be held each day during the warm-ups.
<b>Final Results</b>	Results will be sent to the teams within ten (10) days after the meet.
<b>Seating</b>	There will be limited viewing in the pool area. The gymnasium will be available for families to use.
