Senior Zones - Clovis, CA (Ages Open-19 years)

Travel Dates: Mon., July 29th thru Mon., August 5th

Swim Meet Dates: Wed., July 31st thru Sun., August 4th

SR ZONES DEADLINES:

- 1) May 17 - \$200 deposit plus paperwork due for all current qualifiers
- 2) June 1 - uniform orders and extras due (with payment)
- 3) June 27 – remaining balance \$200 due
- 4) July 5 – Coach signed Team Application due to Coach Brenden Smith at Quad LSC meet in Missoula
- 5) Qualifiers will be handled on an individual basis

Transportation: Each family is responsible for their swimmers' travel arrangements to Clovis, CA. Coaches, Chaperones, and Coordinator will fly into Fresno, CA, the closest airport. Montana Zones coaches and coordinator will arrive in Fresno Monday, 7/29, at 9:30am. All swimmers must arrive no later than Tuesday 7/30 at 12pm. Guidelines for flight arrival into Fresno to ensure chaperone pick-up and supervision: Arrivals should occur between Monday, 7/29, at 9:30am and Tuesday, 7/30, at 12 noon. Departures should occur between Monday, 8/5 between 5:45am, 1pm. Please e-mail all flight information to Gina Leonhardt, as soon as you book your travel. If you would like to book on the same flights as chaperones or coaches, please contact Gina for flight details. The hotel is 5 miles from the Fresno (FAT) airport. As of 3/2/2013, flights are running \$302 to \$342 into Fresno. It is advised that you book quickly to receive competitive rates.

Montana Swimming is offering only one Zones option: Swimmers must stay with the team at the team hotel, eat with team, and travel with the team while on-site. Swimmers will not be allowed to stay in their parents' hotel rooms. Once swimmer arrives on site or travels to Clovis on one of the team member's flights, they become the responsibility of Montana Swimming until the end of the meet when responsibility will return to their parents. We will use 15-passenger vans for on-site transportation. Chaperones will be responsible for driving these vans and will be required to possess a commercial chauffeur's license. Cost: Meals, Hotel, and On-site Transportation - \$400 per swimmer [Transportation to Clovis is NOT included in this total and is the responsibility of each swimmer.]

Team Hotel: Holiday Inn Express- 650 W. Shaw Ave, Clovis, CA A block of 10 parent rooms (\$100 per night plus 11.65% tax) has been reserved under "Montana Swimming Parents." Uniforms: Montana Swimming will provide cowboy hats, t-shirts, shorts, bag and swim caps. Because most swimmers have a competition suit we will NOT be providing swimsuits this year. Instead, Montana Swimming is subsidizing a portion of the travel expenses for each swimmer. All swimmers must provide their own BLACK FINA-approved suit.

- 4) Qualifiers will be handled on an individual basis

Parents must accompany athletes to meet. All travel to Roseville and on-site transportation is the responsibility of the parent. Athletes will be supervised by the coaching staff while on deck and during team meetings. Parents accompanying athletes will be responsible for athlete supervision when athlete is not on deck or at team meetings.

All swimmers will be required to eat breakfast as a team each morning and Coaches Michael and Rebekah will discuss the itinerary for the day.

Meals: Breakfast is included in the price of your room. Lunch will be catered at the swim venue each day around Noon. There will be a team dinner (TBD) on Tuesday evening and ONE other night (TBD). Cost: \$100 per swimmer—4 catered lunches, 2 team dinners, and snacks during the meet in the athlete's village.
