# 2010 BAC CUPID'S CHALLENGE Fortin Center, Rocky Mountain College, Billings, MT February 14, 2010 

The Billings Aquatic Club extends an invitation to its Cupid's Challenge Meet, to be held at the Fortin Center, Rocky Mountain College, Billings, MT on February 14, 2010.

Location: The pool is located in the Fortin Center, $17^{\text {th }}$ Street West and Poly Drive. It is a regulation Short Course 25-yard pool, 6 lanes, non-turbulent lane markers.

Sanction and Rules: This is a sanctioned meet by USA Swimming and Montana Swimming, Sanction \# 0770. It is open to all swimmers holding a current USA Swimming card or the FINA equivalent. Current USA Swimming and Montana Swimming rules will govern the meet. Timing will be by Colorado Timing System and two manual watches or three manual watches. All events will be timed finals. Age is determined as of the first day of the meet. No deck entries will be allowed. All officials and coaches shall be in compliance with Montana Swimming and USA Swimming certification rules and will display certification badges. All swimmers shall be certified by their club or carry certification of current compliance. Clubs shall complete the MONTANA SWIMMING USA SWIMMING REGISTRATION CONFIRMATION form. The Meet Referee will have the final authority for conduct of the meet.

Safety Regulations: Montana Swimming Safety Guidelines and Warm-up Procedures will be in effect and strictly enforced. A safety marshal will be on deck during the meet.

Entries: This is an open invitational swim meet. Swimmers will be seeded according to submitted fastest yard times. Events will be 8\&U, 9-10, 11-12, 13-14, 15-16, and 17-18. Swimmers age 19 and over who are USAS or the FINA equivalent registered athlete members are welcome and encouraged to compete. Disabled swimmers are welcome. Those swimmers must contact the Meet Referee to arrange for any needed accommodations before February 10, 2010. It is at the discretion of the Meet Referee to determine whether the needed accommodations can be met by the meet resources. Each swimmer may compete in a maximum of three (3) individual events. Entries are to be submitted using one of three methods: SPECIAL NOTE: If entries for the meet exceed 320 this meet will be swum as a split session meet. Event file has been set up as a single session meet. The host team will take care of changing to split session at the time if it is warranted. Hard copies of team entries must be sent in order to assure that your swimmers are in the correct events. There will be a note sent out if the meet changes to a split session with warm up schedule and approximate time frames.

1. E-mail (preferred): to fshnfool1968@hotmail.com. Along with entries, include a file containing your team entry report and a relay report from Team Manager. Completed paperwork, disk and entry fees must be received by the entry deadline.
2. Hy-Tek disk: Team entries should be made on a 3.5" Hy-Tek disk with Team Manager software. Please send a "Team Entry Report" as a backup.
3. Master Entry Form: Entry information must be completely filled out as follows: first name and last name, actual age, sex, USA registration number, event and entry time for each swimmer.

The 1650-yd freestyle will be seeded by time only, swum with ages and sexes combined. The $\mathbf{1 6 5 0}$ yd freestyle will be swum fastest to slowest times-- All swimmers of the 1650 -yd freestyle must supply their own timers and counter.

Entry Fee: An entry fee of $\$ 10$ plus $\$ 2$ per event will be charged. Checks may be made out to the Billings Aquatic Club. No entries will be accepted without entry fee. No refunds will be given.

Deadlines: All entries must be received no later than February 4, 2010. Waivers must be signed. Please do not ask to enter an entire team by phone. Phone entries must send entry prior to start date of meet.

Confirmation: A confirmation will be sent if an email address is included.
Schedule: Sunday warm-ups begin at 8:30 AM with two 30 minute warm-up sessions. There will be an Officials meeting at 9:30 with the meet starting at 9:45 AM. There will be a 20 minute warm-up on Sunday before the 1650 freestyle. Lane assignments will be e-mailed out by February 12, 2010. Depending on the number of registered swimmers the warm-up and start times maybe adjusted.

Awards: A participation award will be given to each competing swimmer.
Scratches: Coaches are advised to scratch swimmers prior to the coaches meeting with the meet computer operator. Swimmers will be scratched at the block after two calls. Delay of Meet disqualifications will be issued if the swimmer is not in the STARTING AREA. There will be no Clerk of Course.

Concessions and Swim Shop: Will be provided by BAC parents.

Rocky Mountain College requires that NO FOOD, COOLERS OR BEVERAGES OTHER THAN WATER BE ALLOWED IN THE POOL AREA. Please help us comply with this regulation. Also, please be aware that the Fortin Center will be open to the public before, during and after the meet. No areas of the center should be considered secure. The Billings Aquatic Club and Rocky Mountain College will not be responsible for loss of or damage to any items.
