2011 Who Rules: Boys versus Girls Swim Meet

Invitation: Please join the Helena Lion's Swim Team in our First Boys versus Girls Meet.

This meet will be held in a dual meet format with members of each gender being on separate teams. A running score will be tabulated throughout the meet and

we are hoping for a "Down to the Wire – Who Rules" result!!

Approval: Sanction # 0804. This meet is approved by Montana Swimming and USA

Swimming. The 2010-2011 rules of Montana Swimming and USA Swimming will govern the conduct of the meet. **This is a closed deck meet**. Only athletes, certified coaches, officials, timers, and meet management may be on deck. One parent of 8 & U swimmers may accompany swimmers to the start area and may

be on deck two heats prior and one heat after that event.

Date: Sunday, January 30, 2011

Location The pool is located in the PE Center on the north end of the Carroll College

Campus at 1601 Benton Ave, Helena, MT. The pool is a regulation 25-yard pool,

6 lanes equipped with non-turbulent lane ropes.

Time: Warm-ups will begin no earlier than 8:00am. Lane assignment will be posted

online prior to the meet @ http://montana.usswim.net. Meet will begin no earlier than 9:30 a.m. Once entries are received, warm up and start times will be posted on the website and emailed to coaches prior to the meet. There will be a short

warm-up before the 1000 freestyle.

Timing: Electronic timing and two manual stop watches will be used. To the greatest

extent possible, teams will be expected to provide timers. Timer sign-up sheets

will be available at the meet.

Eligibility: All swimmers must have a current USA Swimming or FINA equivalent

registration card. To insure eligibility, please include each swimmer's current USA/FINA registration number. The swimmer's registration numbers will be verified with the MT Swimming Registration Chairperson. Swimmers age as of January 30, 2011 will determine the age for the meet. Swimmers must swim in their proper age group. **Coaches must have current certification and must**

have their cards visible while on deck.

Meet Format: Events will be swum as noted on the enclosed Order of Events. Age groups will then be broken down and scored as follows: 8 & Under, 9-10, 11-12, 13-14 and 15 & Over. All events will be time finals. Remember, this will be a team scoring

event. The 1000 Freestyle is a time trial event and will not be scored.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Entries: Teams are encouraged to submit their entries by e-mail using Hy-tek software. If

using Hy-tek, please attach a copy of the "Team Entry Report" as a back up in word format. USA numbers must be used with either format. Please submit fastest times in yards format. No time (NT) entries will be accepted. **There will**

be no deck entries.

Entry Fees: A \$20.00 entry fee per individual enters the swimmer in (5) five events. Time

trial is \$2 per swimmer. Entry fees must accompany the entries and checks should be made payable to **Helena Lions Swim Team (HLST).** One check per

team please!

Safety: Montana Swimming safety guidelines and warm-up procedures will be in effect

and strictly enforced. A safety marshal will be on deck at all times.

Scratches: Scratches will be made at the blocks. Swimmers are responsible for reporting to

the blocks on time.

Concessions: There will be a limited snack and beverage concessions for this meet.

Hospitality: Drinks and a light lunch will be provided for the coaches and officials.

Officials: Helena Lions Swim Team appreciates the help of certified officials from other

clubs. Training assistance for new officials will be available to the greatest extent

possible.
