

# **MILLARD AQUATIC CLUB - FINANCIAL INFORMATION**

**2020-2021**

## **U.S.A. SWIMMING (Premium) REGISTRATION FEE**

This fee is required and registers an athlete with the governing body of amateur swimming in the United States. MAC is sanctioned with and governed by USA Swimming and Midwestern Swimming, Inc. This applies to any member participating in a practice or competition with a USA/Midwestern Swimming Club and is non-refundable after two weeks of participation.

\$72 – covers the period from September 1 of current year to December 31 of following year. \$64.00 USA Swimming/\$8.00 Midwestern Swimming

**Fee is due upon electronic registration for EACH new and returning swimmer(s)** – Fee will be refunded for any high school swimmer not returning after the high school season. A copy of a state issued birth certificate, passport or military I.D. must be submitted prior to a tryout for new swimmers.

## **MAC SWIMMER REGISTRATION FEE**

A \$100 fee will be assessed upon electronic registration of EACH new and returning member. Multi swimmer families will be discounted \$15 for the second swimmer, \$30 for the third swimmer, and so on, at on-line registration check out. Just click the “Start Registration” tab on the MAC website to begin. This fee is non-refundable after two weeks of participation.

## **MONTHLY SESSION FEES**

**GREEN** - \$75    **GOLD** - \$85    **WHITE** - \$105    **SENIOR II/M** - \$110    **SENIOR I** - \$115    **NATIONAL TEAM** - \$125

Above fees are for 1<sup>st</sup> “active” swimmer in each family. 2<sup>nd</sup> “active” swimmer receives \$10 monthly reduction and 3<sup>rd</sup> “active” swimmer receives a \$20 monthly reduction, etc. Monthly session fees are invoiced on the 1<sup>st</sup> of each month. I.E. – October monthly session fees are invoiced automatically on October 1. (Senior M is Senior Maintenance if available.)

## **FACILITIES USAGE FEE**

MAC is privileged to utilize the three Millard high school pools, Tiburon outdoor pool and multiple dryland facilities. This fee allows us to help with equipment purchases and any fees associated with using the facilities. Parents and athletes should take the utmost pride in our relationship with Millard Public Schools and facilities. Please treat the facilities with respect and abide by all MPS facility guidelines. This fee is charged per Account.

## **MEET FEES**

If a swimmer participates in any meets, those charges will also be included on your monthly invoice on the 1<sup>st</sup> of every month. Those amounts will vary depending on the meet, number of events and facility fee charge in which the swimmer participates. A \$3.00 MAC fee is also included in every meet sign-up charge.

## **BILLING/INVOICES**

- ❖ Please see the “Invoice/Billing Summary” information under FORMS on the MAC website.
- ❖ A monthly invoice is available in your MAC website account the 1<sup>st</sup> of each month – this includes monthly session fees for the current month and any charges incurred for the previous month, such as supplies or meet fees. I.E., your October 1 invoice is for October swimming and any non-recurring fees incurred in September. Invoice balances will be paid by the registered credit card on file on the 1<sup>st</sup> day of the month. A \$15 late fee is automatically assessed on the 25<sup>th</sup> of the month for accounts not paid in full by the invoice due date. This will only affect those accounts whose credit card on file has expired or been denied. Accounts over 30 days past due will not be eligible to enter meets and accounts over 60 days past due will be considered delinquent and subject to collection/termination.\*\*
- ❖ **NO PRORATING OF MONTHLY FEES.** You will be auto invoiced on the 1<sup>st</sup> of each month unless “Inactive” notification is sent to [mactreasurer@cox.net](mailto:mactreasurer@cox.net) by the 25<sup>th</sup> of the preceding month. I.E, if going inactive for May, please send notification by April 25.
