NEW BUSINESS

Jason Hiley provided a Finance Chair Report. No big issues are noted at this time. Of note, splash fees are running behind schedule, with only 38% collected. Many outstanding fees remain to be collected. Jason acknowledges that net operating income is lagging, but this is mostly a timing issue. December should see significant inflow of money.

Stephanie Martinez shared the MW Swimming Tax Return. No discussion ensued.

Zone meet discussions came next. Apparel and travel are lined up for the zone meet.

Cristina Murray, who has recently been appointed to the Safe Sport position for MW Swimming, reported next. Christina has chosen Aidan Cho to assist her, as the Fellow for Safe Sport. Christina and Aidan manned an information table near the entrance to the D2 meet at Hitchcock, all day Saturday. Bag tags were distributed with a "1 Team -1 Goal" theme, in exchange for signing a Safe Sport Pledge regarding bullying and abuse. Activity books were also available for swimmers visiting the table. Cristina reports much interest in the Safe Sport table at the meet. Discussion came next about how to best reach swimmers with the Safe Sport Message. Safe Sport messaging at swim meets is probably the best way to reach many teams at once.

Betsy Purcell, Officials Chair, introduced discussion with regard to water temperature specifications for swim meets, particularly with this long course season championship meet in mind. Shall meet cancellations, due to elevated water temperature, be presented to the Board for approval? Despite the hot weather, the championship meet this year will go on as planned, unless deemed unsafe by either coaches or parents. Some interpret the rule to apply only to National Championships. The recommended temperature is 77-82.4°F, or 25-28°C. The City of Omaha has been less than cooperative in maintaining water temperatures at Hitchcock Pool. The City of Lincoln has been very cooperative in maintaining water temperatures at Woods Pool. The General Chair and Meet Host should be in contact with the venue owners to ensure proper water temperature in advance of upcoming meets.
