North County Aquatics Codes of Conduct

NCA is fully committed to safeguarding and promoting the wellbeing of the club and all its members. It is for this reason we insist our code of conduct to be followed at all times.

Conduct expected of ALL swimmers:

- Remember that you are representing the team and behave accordingly.
- Be respectful to your teammates, parents, and coaches.
- Listen to your coaches and follow their instructions.
- Do not interfere with the workouts of other swimmers or be disruptive during practice.
- No profanity or offensive language.
- Discussions must be appropriate for ALL ages. Conversations of a violent or sexual nature are strictly forbidden anywhere on pool grounds (pool, locker room, team room, office, parking lot) or at meets.
- No running, roughhousing, dangerous play or fighting.
- No illegal use of drugs, alcohol, or tobacco.
- No stealing, vandalizing, or other unlawful acts.
- No gum chewing in the pool.
- Enter the pool only with coach permission.
- Take care of the team's equipment as well as your own.
- Respect the property of others.
- Clean up after yourself in the locker rooms and the team room.
- Keep noise levels to a minimum in the locker room.
- Be on time for practice.
- Come to practice prepared and ready to swim.
- Work hard.
- Respect the decisions of meet officials.
- Be gracious in defeat and show sportsmanship towards your competitors.
- Be supportive of your team members.
- Be friendly and welcoming to new swimmers.
- Show team spirit.
- Report inappropriate behavior or risky situations to a coach.
- All equipment issued by NCA must stay on the pool deck. You must provide your own swim bag for items issued.

Conduct expected of ALL parents/guardians:

- Set a good example by following the swimmer's code of conduct.
- Insist that your child follow the swimmer's code of conduct.
- Show respect and common courtesy to team members, coaches, competitors, officials, and other parents.
- Demonstrate good sportsmanship during all practices, competitions, and other team activities.
- Be an active participant in all fundraising and team events.
- Bring your swimmer to practices and competitions on time and ready to swim.
- Do not Coach or discipline your children during practice or during meets; that is the coach's job; the parent's job is to love and support their swimmers.
- Please talk to coaches before or after practice if you have any questions or concerns.
- Sign up for timing at swim meets.
- Help reinforce safety concerns around the locker room and pool deck. No running on pool deck and no climbing on the rocks. Unless you are a member of the club, the pool and spa are off limits to all swimmers prior and after swim practices, including other family members.
- Encourage and praise your swimmer's hard work and accomplishments.
- Don't hold your child to expectations beyond his/her abilities or desires.
- You are responsible for any Non-swimming family members. Children must always be accounted for by their parents. Please do not allow your kids to wander onto the pool deck alone.
- Pay on time. Contact the treasurer or membership board member if a situation arises that prevents you from doing so.
- Please sit in the designated seating areas during practice (bleachers, picnic tables, etc.).
- Help keep the team room clean.
- Help with pool covers when needed.
- Go to northcountyaquatics.org with your child to be informed about vacations dates, holidays and read NCA News Splash to your child.
- Remember that you are responsible for your swimmer(s) before and after practice. Be on time to pick your swimmer up from practice.
- Consequences for violating the code of conduct may include a conference with parents, loss of practice, suspension, or removal from the team.

TUTION AND FEES FOR NORTH COUNTY AQUATICS

USA Swimming Registration: Registration with USA Swimming is mandatory. The fee is \$68.00 per year (subject to change). This fee is due and payable to Southern California Swimming when first applying for membership with NCA. This registration must be renewed each year BEFORE January 1. If this is your first time registering with USA Swimming, you must show proof of birth date to the coach for any child UNDER 19, using one of the authorized documents listed on the SCS instruction sheet. NCA will mail in the application when applying for the team, **but after the first year it is the families' responsibility to mail in this document with the registration fee by January 1st.**

New Flex Membership

USA Swimming and CCS are now offering a new membership type called the Flex Membership. The membership is a year-round membership and the membership fee is only \$20. It is designed as an entry level membership type, and as such has some restrictions. First it for athletes 18 years old and younger. Second the athletes are only allowed to compete in 2 sanctioned meets per year.

- 1) **Registration Fee:** There is a \$50 registration for all new and returning swimmers over 3 months off.
- 2) **Annual Fee:** An annual equipment fee of is charged to each swim team families. This fee is added to your September tuition and must be paid regardless of when you joined the team. Prices per swimmer Child #1 \$25/ Child #2 \$15 /Child #3 \$10 with a maximum of \$50 per family.
- 3) **Monthly Tuition:**
 - a) Payment is due IN FULL BY THE 10TH OF THE MONTH. If payment is not received by the 10th of the month, a late fee of \$10.00 will be charged.
 - b) Families must set up tuition auto payment through Paso Robles Sports Club. Failure to set up auto pay will result in an additional \$10 fee each month. NCA will apply credit information to Team Unify, the billing system for NCA. These charges will be for swim meet fee's, fundraising, and for equipment fee.
 - c) If an account or any part thereof becomes delinquent by 60 days, the family will be sent a notification. If the account is still delinquent and a payment plan has not been set up within 30 days of notification, the swimmer(s) will no longer be allowed to swim, and further action may be taken. If payment is still not received, your account will be handed over to a Credit Bureau for further action. If your account becomes delinquent due to financial hardship, please contact the treasurer or membership coordinator to work out a payment schedule.
 - d) When a swimmer is moved by their coach from one swim group to another, you must pay the monthly tuition for the highest-level group in which they participate.
 - e) Each month, Paso Robles Sports Club will charge a \$5.00 processing fee to each family account.

- 4) **Swim Meet Fees:**
 - a) When signing up for a swim meet on-line, a swimmer will be charged by the hosting team a swimmer surcharge fee and a per event charge. Local Meet Fees (Subject to change) - \$10.50 swimmer surcharge & \$3.50 per event. Away Meet Fees- Vary. You will receive one free NCA swim cap at your first swim meet. Additional caps can be purchased for \$12 from the head coach.

Additional Charges: Coaching Fee:

- (1) A coaching fee for all local swim meets - \$10.00.
- (2) NCA charges a coaching fee of \$20 per swimmer to help cover the cost of time and travel for **all away meets.**
