<b>FACILITY and HOST TEAM REQUIREMENTS</b>	<p>TYDE has discussed specific health and safety procedures with the venue management. Compliance with the most current guidelines from USA Swimming, North Carolina Swimming, CDC, State and Local jurisdictions will be maintained throughout the duration of the meet. The Greensboro Aquatic Center is currently requiring everyone to wear a mask and maintain distance whenever possible. Swimmers must remain masked until at the starting blocks.</p>
<b>PARENTAL ACCESS</b>	<p>Parents needing access to their athlete during the meet in a closed-deck environment can contact their children directly via cellphone and arrange to meet them in the concourse. Should parents be unable to contact their child directly, in the case of an emergency, please call and/or text the meet director(s).</p>

**FACILITY**

The Greensboro Aquatics Center main competition pool is a 50-meter pool which can be broken into two short course venues with a separate diving well. This competition will use one or two short course competition venues that are 10 lanes or 8 lanes (depending on entries) with continuous warm-up and cool down lanes available throughout the meet. The pool depth is 9’-10’ at the start and turn ends and 4” lane lines will be used to reduce turbulence. The lane width is 7’. An Omega timing system with a Daktronics Pro-Star LED Video Scoreboard Display will display results simultaneously. Starting platforms are Omega deck anchored platforms. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

No outside Food or Drink will be permitted. There is a spectator seating area with a capacity of 1850 persons. Spectators are not allowed on the deck at any time. The 650 bleacher seats on deck are reserved for swimmers only. **No chairs are permitted in the stands or on deck.**

**SAFETY**

The NCS Safety Program is in effect for this meet. Coaches are required to closely supervise their swimmers at all times. NO running or horseplay will be tolerated. In the event that a swimmer or others associated with a team are found to be violating posted rules for use of the Greensboro Aquatic Center or any other restrictions that are posted for the safety of the people in

attendance or to protect Greensboro Aquatic Center property the individuals will be reported to the Meet Director or one of the Meet Marshals who will notify the coach. Any coach notified will be expected to take appropriate disciplinary action up to and including expulsion of the person from the meet. The Meet Director, Meet Marshal, or Referee may also take disciplinary action.

**RACING STARTS**

Any swimmer entered in the meet, unaccompanied by a YMCA Swimming Coach, must be certified by a YMCA Swimming Coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**RULES**

This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

**MAAPP**

All applicable adults participating in or associated with the meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Protection Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

**MEMBERS WITH  
DISABILITIES or  
MEDICAL  
CONDITIONS**

The YMCA of Northwest North Carolina welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit the YMCA of Northwest North Carolina's ability to accommodate all requests.

**ELIGIBILITY**

This is a **closed** YMCA meet. All swimmers must be members of a YMCA club. All Adult Athletes must hold current APT certification to compete. There are no minimum qualifying standards for this meet.

**ENTRIES**

Entries submitted in Hy-tek or SDIF format require no hard copy entry forms. Email is preferred for electronic entries however disks are also acceptable. A completed and signed Entry Summary Sheet (included in the announcement) and payment in full must be received by the Meet Entry Coordinator by the entry deadline unless other arrangements have been made prior to the entry deadline. A swimmer's age on the first day of the meet will determine their age for the entire meet. YMCA of NWNC entries will be entered first and then will accept teams/entries in the order received, until the four/eight hour rule is reached. Entries received thereafter will be returned immediately.

**ENTRY LIMITATIONS** Swimmers may swim a maximum of four (4) individual events and one (1) relay event per day.

**ENTRY VERIFICATION** An email will be sent to the person submitting the entry confirming receipt of the entry within 48 hours of receipt.

**ENTRY DEADLINES** **The Meet Entry Coordinator must receive entries by the date and time listed in the Deadline and Meeting Summary. Late entries may be accepted at the discretion of the Meet Referee. There will be no on deck entries.**

**SEEDING** The conforming time standard for this meet is short course yards. Swimmers will be seeded and swim from slowest to fastest in all pre-seeded events. Deck seeded events (400 IM, 1000 Fr and 500 Fr) will run fastest to slowest and alternate female to male if the session is conducted in 1 pool. If 2 pools are needed then the session will be split into a male pool and female pool. All non-conforming times will be seeded last in rank order

**CHECK-IN** A positive check-in, located by the scoring table, will be required for the following events:

- Open 400 IM, 1000 FR, 500 FR

Check in for the event will be as stated in the Deadline and Meeting Summary. Swimmers that fail to check in will be scratched from the event and not seeded.

**SCRATCHES** There will be no penalty for scratching pre-seeded events at the block.

In the positive check-in events, a swimmer who has checked in, been seeded, and fails to complete in said event, shall be barred from his/her next individual event.

**SCORING** No team or individual scoring will be kept.

**AWARDS** For 12 & Unders  
Individual Events: 1<sup>st</sup> -8<sup>th</sup> place ribbons  
Relay Events: 1<sup>st</sup>-3<sup>rd</sup> place ribbons

**RESULTS** Results will be posted on TYDE’s website within 24 hours of the meet’s conclusion. At the conclusion of the meet, teams may obtain Hy-tek backups either on a memory stick or via email attachment.

**COACHES**

All coaches on deck must be registered and certified with YMCA Swimming. Meet Management will require all coaches to show proof of certification/ registration and shall prominently display their registration cards or be prepared to show their Deck Pass virtual membership card upon request while on deck. There will be a coach/general meeting at the date and time listed in the Deadline and Meeting Summary. Other meetings may be held at the meet referee's discretion. Meet Management requests that at least one coach representative from each team attend all coaches meetings.

**OFFICIALS/TIMERS/  
VOLUNTEERS**

There will be a need for officials. TYDE welcomes and encourages anyone willing to volunteer to contact the Meet Referee by email prior to the meet or sign in once you arrive at the meet. All officials on deck must be registered and certified with USA Swimming and will be required to show proof of such to the meet referee by displaying their registration card or be prepared to show their Deck Pass virtual membership card upon request. A certification card showing the official's level of certification must also be presented. Any official's assistance will be greatly appreciated and will help to ensure a great meet for the swimmers. Official briefings will be held in the hospitality area at the date and time listed in the Deadline and Meeting Summary.

**HOSPITALITY/  
CONCESSIONS**

There will be a hospitality area open to all coaches and officials. Refreshments will be available at the concession stand in the GAC Lobby.

**WARM-UP**

In accordance with USA Swimming guidelines, there will be a published warm up procedure for all swimmers and coaches attending the meet. The Marshall will ensure all teams, coaches and swimmers follow all warm up procedures. Meet management reserves the right to change warm up times according to the number of entries. Warm up assignments will be handed out in the coach's packet prior to the start of the meet. At least three lanes will be open for continuous warm up and down during the meet.

**WAIVER/RELEASE**

As a team entered in this meet, upon entry you are verifying that all of the swimmers and coaches listed on the enclosed entry are registered with the YMCA. You acknowledge that you are familiar with the Safety Rules of USA Swimming, Inc. and North Carolina Swimming, Inc. regarding warm-up procedures and meet safety guidelines, and that you shall be responsible for the compliance of your swimmers with those rules during this meet. The TYDE Swim Team, The Greensboro Aquatic Center, North Carolina Swimming, Inc., the YMCA of the USA and USA Swimming, Inc., their agents, employees, and coaches shall be held free and harmless from any and all liabilities or claims for damages arising by reason of illness or injury to anyone during the conduct of this meet. You acknowledge that by entering this meet, you are granting permission for the names of any or all of your team's swimmers to be published on the internet in the form of Psych Sheets, Meet Results, or any other documents associated with the running of this meet.

**IMAGE RELEASE**

All participants agree to be filmed and photographed by the host club approved photographer(s) and videographers and to allow the right to use

Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the meet.
