The LIVERPOOL JETS SWIM CLUB is a 501c3 charitable non-profit organization that depends heavily upon membership fees to meet its operational expenses. The Liverpool Jets Swim Club is run by an elected board of volunteers whose goal is to allow the club to function in the most efficient manner. Any family group who supports the Purpose and Objectives of the Jets as outlined in the team handbook and on the team website may become a member upon payment of the established annual dues.

All new Senior, Junior, and Age Group swimmers are given a two-week trial period. These two weeks allow the swimmer to determine if the LIVERPOOL JETS SWIM CLUB is right for them and for the coaching staff to evaluate the swimmer. In light of this trial option, the Jets DO NOT offer refunds unless there is a documented medical reason. In such cases, it is up to the member to provide a written request to the executive board of the Liverpool Jets containing any documentation that may help to establish their case.

The Liverpool Jets Swim Club operates on a September to August fiscal year. In registering for the Liverpool Jets Swim Club, athletes and their families assume the responsibility of paying membership dues on a timely basis for the entire fiscal year, regardless of whether or not they utilize the services of the Liverpool Jets Swim Club. Athletes who join after the start of the season may receive an appropriate pro-rated membership fee.
