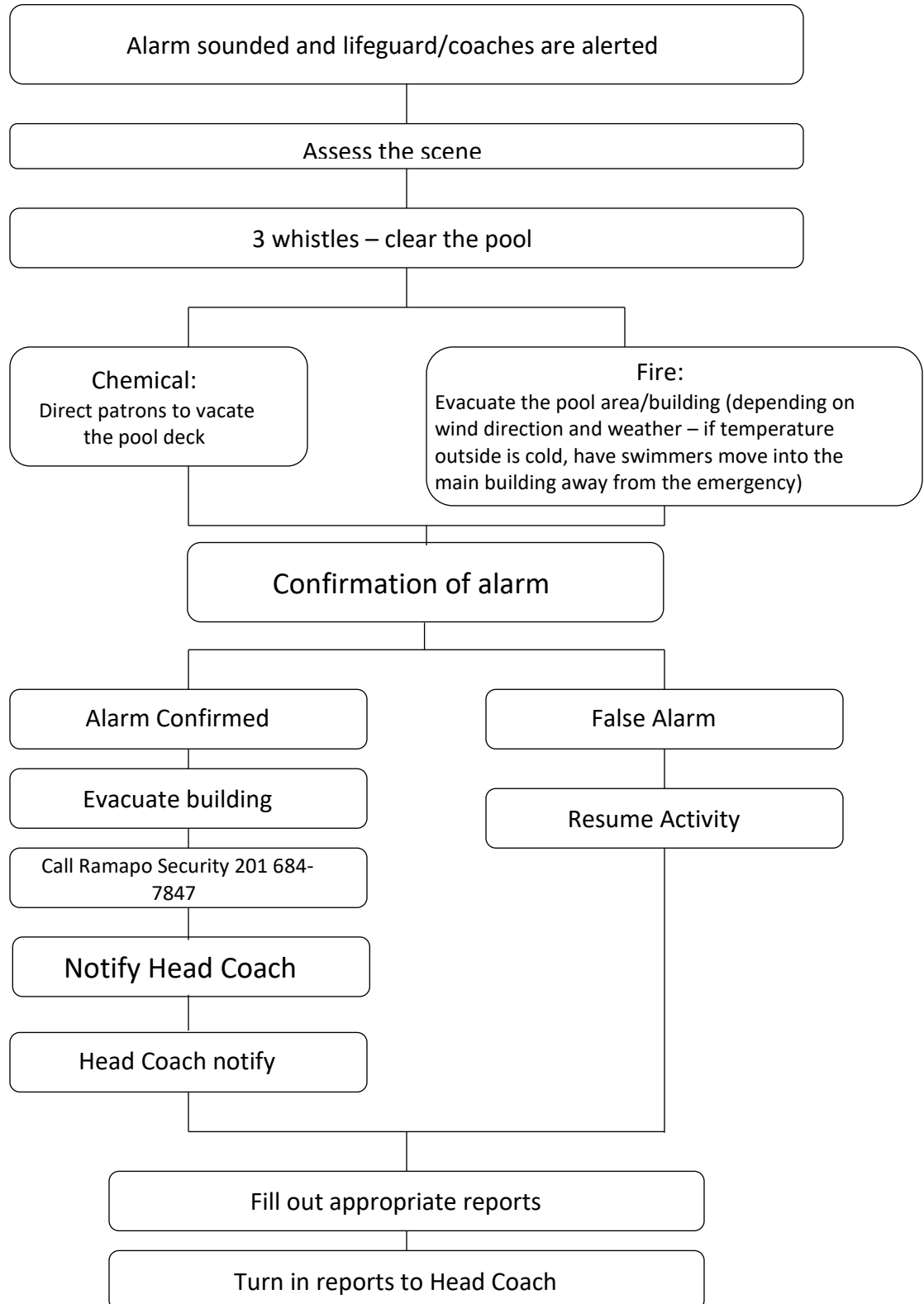

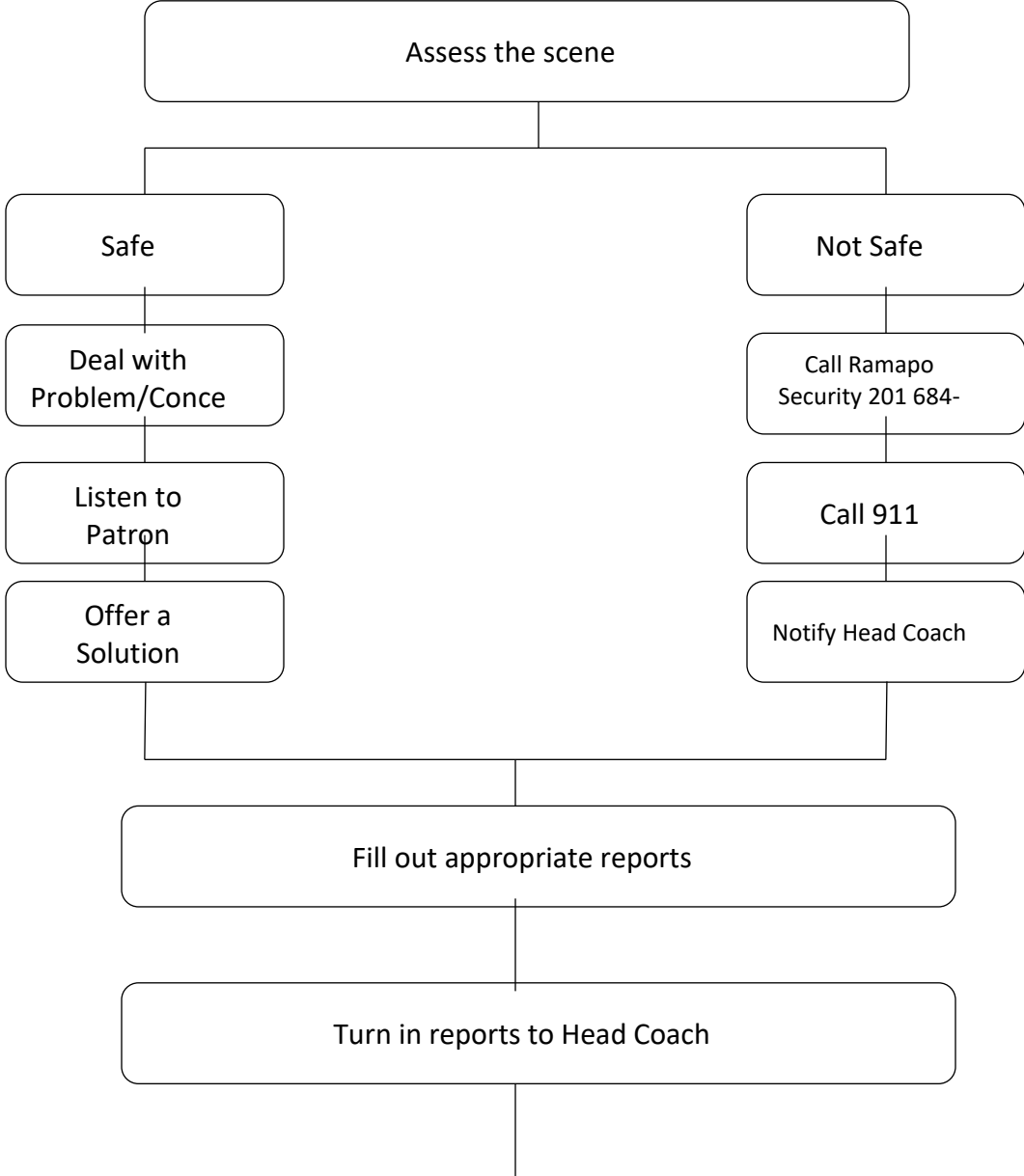

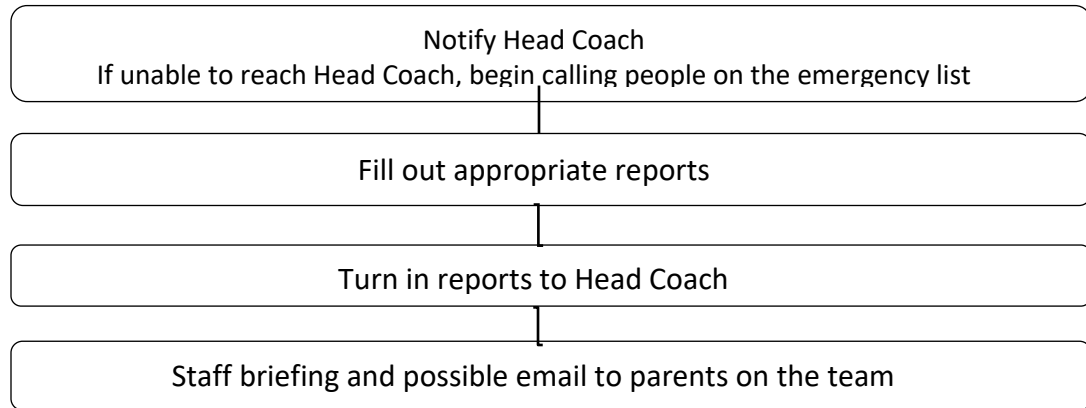

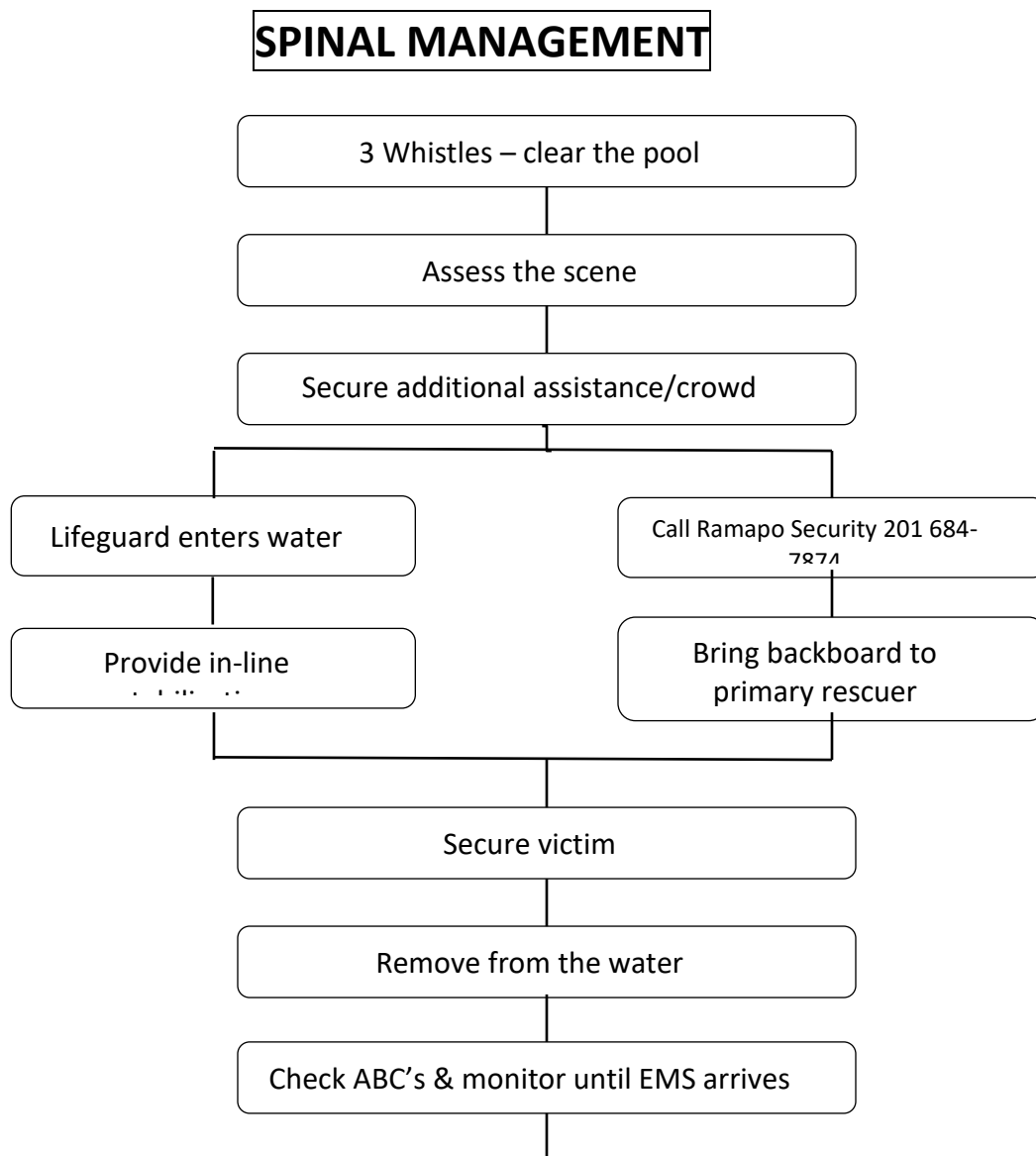

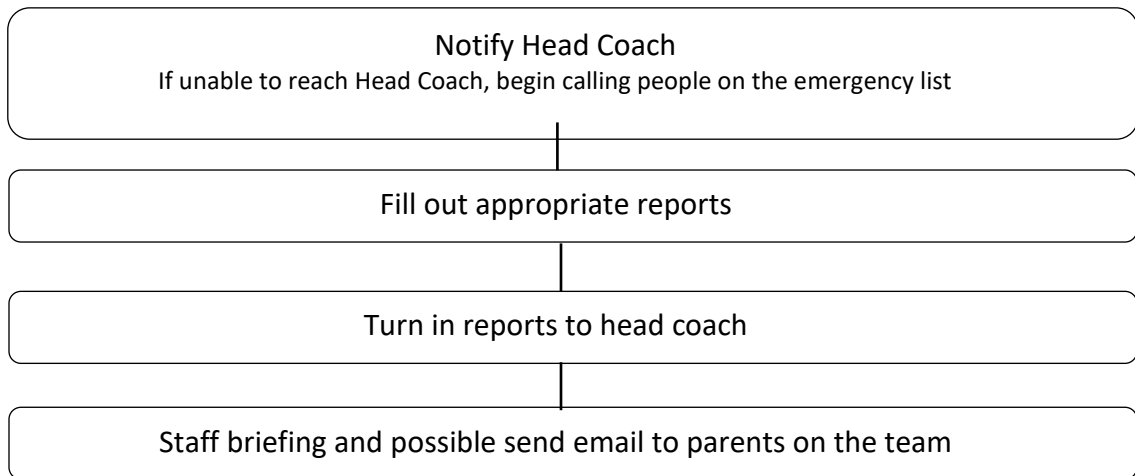

11.6. Safety Action Plan – Security Call Example

SECURITY CALL EXAMPLE

The following is a sample of the message that is hung beside each emergency phone. This sign provides directions to the appropriate emergency entrances. It also allows untrained persons to provide the appropriate information to the 911 operator.

THIS PHONE IS FOR EMERGENCY USE ONLY

1. Dial 201-684-7847

2. Read the following message:

“An aquatic emergency exists at the Bill Bradley Center in the pool area.”

“There has apparently been a _____ Injury.”

3. Remain on the phone with the dispatcher until emergency personnel arrive on the scene.

DO NOT HANG UP

Please complete the necessary paperwork and notify the Head Coach immediately after the emergency.

11.7. Safety Action Plan – 911 Call Example

9 1 1 CALL EXAMPLE

The following is a sample of the message that is hung beside each emergency phone. This sign provides directions to the appropriate emergency entrances. It also allows untrained persons to provide the appropriate information to the 911 operator.

THIS PHONE IS FOR EMERGENCY USE ONLY

1. Dial 911

2. Read the following message:

“An aquatic emergency exists at the Bill Bradley Center at Ramapo College in Mahwah, New Jersey. Please come at once to the Bradley Center’s Main Entrance, which is on your right as you enter from Ramapo Valley Road (coming from Route 17). If possible, someone will meet you there and direct you to the pool”

“There has apparently been a _____ Injury.”

3. Remain on the phone with the dispatcher until emergency personnel arrive on the scene.

DO NOT HANG UP

Please complete the necessary paperwork and notify the Head Coach immediately after the emergency.

When making an emergency call:

1. Call Nicky on both numbers
