**Please read this carefully, initial, sign where indicated and return by August 24, 2021**

HACY Parents and swimmers are obligated to fulfill the responsibilities specified below. To remain in good standing a family must be current with fee payments and have satisfied all fundraising and participation requirements.

## **YMCA Meets**

- Work a minimum number of **4** YMCA Dual meets.
- Work at the Championship/Mini meets in which your child competes.

## **USS Meets: (Age Group and Senior Levels)**

- Work any USS meet in which your child competes, or arrange for a replacement worker.

## **Parents:**

- Work all fundraising meets hosted by HAC – even if your child is not swimming. The meets are held in December (East Field Meet), June (Solstice Meet) and July (12/u Silver-Bronze Long Course Championship). We provide timers, admissions and hospitality staff, and safety monitors. (Marlins/Dolphins: 2 sessions total out of 3 meets, Age Group/Seniors 8 sessions)
- Ad booklet - Marlins/Dolphins quarter page ad or 3 sponsor lines.  
Age Group/Seniors 2 quarter page or 1 half page ad.
- **\*\*All families will be expected to pay a \$200 escrow fee for the responsibilities that will be returned at the end of the season when duties are fulfilled (Parents will be assessed another \$100.00 in addition to the fee already paid at beginning of season if duties are not met. Checks payable to: HAC (\* please write Parent Board in the memo) The fees will be returned after the last U.S. Meet in July.**

**\*\*AT THIS TIME, IT IS UNKNOWN WHETHER HOSTING FUNDRAISING MEETS WILL BE AN OPTION FOR HACY. IF WE DO, REGARDLESS OF IF YOU JUST SWIM THE FALL/WINTER SEASON WITH US, YOU ARE REQUIRED TO VOLUNTEER YOUR TIME. OUR PROGRAM FOR 38 YEARS HAS RELIED ON PARENTS BEING INVOLVED.**

## **Swimmers:**

- ALL swimmers are expected to compete in ALL YMCA dual and championship meets. Notification of inability to attend a meet must be made to your coach at least one week in advance.
