As a participant with Lobo Aquatic Club(“Lobo” or “LSC”) at the **NAME OF EVENT AND LOCATION** I understand and will comply with the following guidelines as set forth by Lobo Aquatic Club and USA Swimming.

GUIDELINES

1. The possession or use of alcohol, tobacco products or controlled substances by any participant is prohibited at all times, including traveling to and from and for the duration of the meet.
2. Curfews established by the Head Coach will be adhered to each day of the program.
3. Participants will stay in assigned rooms and will not attempt to change rooms or roommates unless authorized by the Head Coach.
4. To ensure the propriety of the participants and to protect the LSC, there will be no males in female participants’ assigned rooms and no females in male participants’ assigned rooms.
5. Participants will refrain from any illegal or inappropriate behavior that would detract from a positive image of USA Swimming or be detrimental to the meet.

6. Participants will display respect and sportsmanship toward coaches, fellow participants, administrators and the public.

IMPLEMENTATION

1. All participants are apprised in writing of this code. Signature of this document constitutes unconditional agreement to comply with all parts of this Code of Conduct.
2. Failure to comply with the Code of Conduct as set forth in this document may result in disciplinary action. Such discipline may include but may not be limited to:
 - a. Dismissal from the meet
 - b. Immediate return home at participants’ expense.
