1. One (1) copy of each dual meet team roster with the Official Roster Cover Sheet (No photocopies). Rosters must be listed by age group in alphabetical order, and include: name, age as of 12/1/19 and date of birth.
2. Certificate of Liability Insurance: minimum of \$1 million naming **Northern NJ YMCA Swim League** as the co-insured.

\*Due by October 15, 2019 to teams in your divisions only:

- One (1) copy of the dual meet team roster with the Official Roster Cover Sheet attached to each team in the *appropriate* division (ie. The teams that compete against you within the division).
- If you choose to email the roster, you must MAIL the cover sheet with the appropriate info. (The cover sheet contains signatures therefore it cannot be emailed).

## Reporting Results & Penalties

The home team shall be responsible for:

- Emailing meet results, PDF and meet backup file, to [njymcaswimleague@gmail.com](mailto:njymcaswimleague@gmail.com) **within 72 hours** of the date of the meet.
- In case of a forfeiture or postponement, it is the home team's responsibility to inform the other teams in their division, the League Treasurer, and the League Coordinator.
- A penalty of \$25 will be placed on the home team if the results are not submitted within 72 hours following the meet, which would be assessed by the Executive League Coordinator to the Executive Director of the guilty association. The Executive League Coordinator will invoke a forfeiture penalty in addition to the late fine in the event of a second failure to cooperate.

## Roster Format:

Name, age as of 12/1/17 and date of birth *must* be included for each individual, listed in ascending order by age, in order to determine eligibility. Swimmers who are ineligible for team point scoring at dual meets until 120 days from their last Y League competition must have a check placed in front of their name on the roster, as per the Northern NJ YMCA Swim League Constitution, Part IV, Section III.A.
