# North Texas Swimming

To be eligible for travel funds from North Texas Swimming, an athlete must meet the following requirements as specified in Article 708.3. of the North Texas Swimming LSC Handbook:

- .1 .A Compete in a lifetime minimum of ten North Texas sanctioned open invitational meets or Texas Senior Circuit meets, or a combination: OR
- .B Compete in a minimum of three events at two North Texas sanctioned open invitational meets or two Texas Senior Circuit meets, or a combination, during that short course season for short course funds or during that long course season for long course funds;
- AND
- .2 .A Compete in an individual event at that particular short course or long course Junior National or Senior National meet: OR
- .B Compete in a relay at a Senior National meet, having also met the qualifying criteria for the current Junior national meet in an individual event;
- AND
- .3 Have been a North Texas registered swimmer at the time of the competitions specified in 708.3.1 - 708.3.2, above

\*\* Proof of Expenditures must be attached with Application. It is not necessary to submit proof of more than \$350.00 of eligible expenditures.

Applications must be completed accurately and fully and postmarked on or before May 15 for Short Course or September 15 for Long Course in order to be eligible to receive any North Texas Swimming Travel Funds.
