ENTRIES:	Entries must be received no later than 6:00 p.m. Friday, January 28, 2011 - NO EXCEPTIONS . If confirmation of delivery is desired, please include a self – addressed stamped post card. We accept HYTEK entries. Please forward a hard copy with your payment. Entry limit: 300 swimmers.
ENTRY FEES:	 \$4.00 per individual event plus a \$2.00 OSI (Ohio Swimming Inc.) surcharge per swimmer. Limit four (4) individual events per day. All entry fees must accompany entries and none will be returned. Please pay by check made payable to: Sycamore Flying Fish. All fees must be paid before your team will be allowed to swim.

- **DECK ENTRIES:** Deck entries will be accepted only if the meet is not closed. Deck entries will be closed 30 minutes before the meet starts. All deck entries will be seeded in any open lanes. A deck entry fee of \$5.00 per individual event or \$10 per relay, plus an OSI surcharge of \$2.00. The Sycamore Flying Fish reserves the right to deck enter any of their swimmers.
- FALSE STARTS: The no recall false start rule will be in effect for this meet.
- **MEET RULES:** Age on day of the meet (2/12/2011) will determine eligibility for age group divisions. Current USA Swimming rules will govern the meet. Swimmers must compete in their own age group.
- **ELIGIBLITY:** All swimmers must be registered with USA Swimming. Registration numbers and swimmers age must appear on the entry forms. **This meet is open to all swimmers 10 and under that have times slower then National BB time standard**.

ALL SWIMMERS MUST BE PREPARED TO PROVE USA SWIMMING REGISTRATION.

AWARDS: All participants will receive an All American Trophy at the conclusion of the meet.

- **FINAL RESULTS:** Free to each team represented by a minimum of 5 swimmers or 15 individual events. Extra copies may be ordered from the Meet Director for \$5.00. Bring your disc or flash drive to the meet and we will give you results immediately! Results will also be posted on our web site: http://www.sycamoreflyingfish.com
- **SAFETY:** Ohio Safety guidelines will be enforced in the conduct of the meet as well as warm ups. *Swimmers must camp in the designated areas ONLY*, please do not camp in the pool area in order to leave as much seating available as possible for parents and other spectators.
- WARM-UP: Ohio LSC Swimming Safety Guidelines and warm-up procedures will be in effect. Depending on number of entries, we reserve the right to assign warm up lanes and to split the warm-up session into two parts: *The first part will consist of two-thirds (2/3) of the warm-up,

session allotted times and will be general warm-up in all lanes. NO DIVING or RACING STARTS ALLOWED from the blocks or edge of pool. Swimmers must enter the pool feet first in a cautious manner with <u>one hand in contact with pool edge</u>.

	*The second part will consist of the remaining one-third (1/3) of the allotted time and will be designated for sprint and pace as assigned by the Meet Director and/or Pool Marshall.
TIMERS:	Each team may be required to provide timers based upon the number of entries. Teams will be notified after entries are received.
COACHES:	ALL COACHES MUST SIGN AND PRESENT A CURRENT USA SWIMMING MEMBERSHIP CARD UPON ENTERING THE POOL. This card must be worn while on the pool deck. Ohio Swimming requires the Sycamore Flying Fish to enforce this rule. The Sycamore Flying Fish are happy to provide a Coaches Hospitality Area throughout the meet. Please indicate the number of coaches that will be attending the meet with you on the Entry Summary Sheet.
FACILITY:	The Sycamore High School facility is a six-lane 25-yard pool with Colorado system V Timing.
DIRECTIONS:	From I-75 or I-71, take 275 East to Montgomery Rd Exit 50. Turn right off the exit, go a quarter of a mile and turn left onto Cornell Rd. Sycamore High School is on the right hand side after you cross over the expressway.
