## **Required USA SWIMMING Annual Registration:**

USA Swimming Annual Registration has changed for the 2022-2023 Season. TOSC will **NO LONGER** be submitting USA Swimming Registration for your athlete. USA Swimming Registration is required for all TOSC Athletes. \*An email will be sent out with a link to register for your USA Swimming Athlete Registration. You are required to follow the link and register your athlete for the 2022-2023 Swim Team Season as soon as you receive that emailed link.

## **Multiple Swimmer Discount:**

Discounts will be given for 3rd swimmer (\$25/month) and 4th swimmer (\$50/month). 5th and any additional swimmers will be no charge.

## **Pro-rated Monthly Fees:**

Training fees are not pro-rated for partial months except for families NEW to TOSC, who begin participating after the 15th of the month; training fees will be pro-rated in half for that month. The month of August will be pro-rated in half.

### **Required Training Group Equipment:**

Each Training Group has a list of equipment required and is listed on the TEAM STORE tab on our website.

### **Credit Card Surcharge:**

TOSC will impose a 4% Surcharge on Credit Card transactions as well as a \$1.50 for ACH transactions.

### **Swim Meet Entries & Fees:**

Swim meet Entries are to only be sent to the host team by the TOSC registrar. **Families who have entered swim meets are responsible for all meet fees whether you participate in the meet.** Your account will be billed immediately following acceptance of the meet entries by the host club, according to events entered. Statements are generated monthly and due on the 15th of the month.

### **High School Swimming:**

**TOSC swimmers who plan to participate in high school swimming will be prorated to \$60.00 during the HS Season (Girls Season Sept/Oct/Nov & Boys Season Dec/Jan/Feb).** High School Swimmers are encouraged to Register Early to guarantee a spot to swim with TOSC this 2022-2023 season. HS Swimmers are encouraged to make TOSC week/weekend practices and are allowed to compete in swim meets for TOSC when not with their High School teams to maintain their proficiency. Please note: High School Age Athletes may also fulfill their Volunteer Hour Requirements for Graduation with TOSC (See the Head Coach for details).

### **Delinquent Accounts:**

Timely remittance of monthly dues and fees are critical to the efficient operations of TOSC. Communication with members whose accounts are delinquent may include but are not limited to the following:

#### **30 days past due:**

Member may be contacted via telephone or email by the TOSC Board Treasurer (or designee) to notify them of their status.

#### **60 days past due:**

Member will be sent a certified letter notifying them of their status.

#### **90 days past due:**

Member will be contacted by the TOSC Board of Directors. Member's swimmer(s) will not be allowed to attend practices or enter swim meets until their account is brought current or they have developed a repayment plan that has been approved by the Board of Directors.

#### **120 days past due:**

Member will be sent a letter notifying them of expulsion from TOSC and that TOSC may elect to use the legal system or a collection agency to remedy the delinquent account.

**Families may be reinstated upon complete payment of all past dues, fees, and account charges at the discretion of the Board of Directors.**

**Checks received on accounts that are returned for non-sufficient funds will be assessed an NSF fee of \$25.**

### **Leaving TOSC:**

To ensure that we can maximize participation in the swimming pool and to eliminate billing issues, TOSC requires **written** notice to the [TOSCswimming@gmail.com](mailto:TOSCswimming@gmail.com) prior to the 15th of the month to become inactive, to withdraw, or to suspend your account to avoid a \$25 administrative fee. **At that time, you will be invoiced for the remaining annual volunteer service hours for your athlete's time with TOSC and pay any outstanding amount on your account.**
