**MEMBERSHIP AGREEMENT**

**Membership and Financial Responsibility Information:** *(initial on line at end of each section)*

- 1. Membership** is with the Tahoe Swim Club (TSC), the Local Swim Committee (LSC), and USA Swimming (USA-S). Information (and links) with additional details is available at [www.taho swimclub.com](http://www.taho swimclub.com). \_\_\_\_\_
- 2. Swimmer participation**, practice assignments, and involvement in meets are established by the coaching staff. \_\_\_\_\_
- 3. Fees:** Annual dues are assessed in a graduated fee structure depending on training group assignments. Families pay dues monthly over a 12-month period. \_\_\_\_\_
  - A) First Time Swimmer Fee** – 3 month Developmental Program is \$349.00 and includes USA Registration. Full amount is due and payable within 3 days of joining program along with all paperwork.

B) At the end of the 3-month developmental program, participants become a member of the TSC and will pay dues on a monthly payment schedule as follows: \_\_\_\_\_

- Blue Group (beginners) \$70 per month
- Gold Group (advanced beginners) \$75 per month
- Junior Swimmers \$80 per month
- Senior Swimmers \$95 per month

C) Accounts not paid by the 5<sup>th</sup> day of the month will incur a \$25 late fee. \_\_\_\_\_

D) New members are required to sign up for auto-pay through their account at [www.tahoewimclub.com](http://www.tahoewimclub.com) using a credit or debit card. \_\_\_\_\_

E) All fees are subject to change. \_\_\_\_\_

4. **All charges are payable in advance** by the 5<sup>th</sup> of each and every month and are delinquent after that date. First time swimmers and rejoining swimmers are required to pay for three months in advance. Only full month fees apply. \_\_\_\_\_

5. **Participation by family members** is expected and required at all home meets as follows:

A) Regarding Home Meets, every family must work a minimum of 16 hours for each home meet or pay \$100.00 for each 8-hour shift not worked. \_\_\_\_\_

B) Regarding Meet Hospitality, every family must provide a requested food items for each swim meet or pay \$15 toward purchase of food items. \_\_\_\_\_

C) Regarding advertising sales for meet program and/or website, every family must sell/buy a minimum of \$80.00 at least one time per period of September 1 through August 31 of each and every year. \_\_\_\_\_

6. **Participation by family members** is expected and required at all away meets. Parents are expected to participate as a lane timer or other official at all away meets. \_\_\_\_\_

7. **Continual participation** in all Tahoe Swim Club fundraising and events is encouraged. Rejoining the Tahoe Swim Club requires that all previous fees are current, including missed swim meet requirements. Fees will not be charged during arranged absences due to injury or prolonged illness. Questions must be submitted in person or in writing to the Board of Directors. \_\_\_\_\_

8. **Team Information** is provided on the bulletin board at the Recreation Complex and at [www.tahoewimclub.com](http://www.tahoewimclub.com). It is the responsibility of each family to stay informed. \_\_\_\_\_

9. **Members leaving TSC** during the season **must submit a written notice of intent to leave** to the coach and the team treasurer at least **10 days** prior to the date of departure in order to avoid being obligated for dues after they have stopped swimming.

10. **USA Swimming annual calendar year** registration is a separate fee and is required in order to participate with the Tahoe Swim Club. Renewal registration is collected by TSC on November 1 of each year and then paid in total for all club swimmers in mid-November. For the year 2020 the annual fee is \$75 but is subject to change by USA Swimming at any time.

**PARENTAL CONSENT RELEASE**  
**WAIVER OF LIABILITY and ASSUMPTION OF RISK**

In consideration of Tahoe Swim Club permission for \_\_\_\_\_ (the minor) to participate, I, the parent/guardian of the minor for myself and on behalf of the minor:

1. Consent to the minor's participation in Tahoe Swim Club and related activities.
2. Agree that prior to the minor's participation in any event or activity the minor and I will inspect the facilities, equipment and areas where the event or activity is being conducted and, if either of us believe they are unsafe, I will immediately advise the person supervising the event, activity or area.
3. Acknowledge that the minor and I fully understand that the minor's participation may involve risk of serious injury or death, including economic loss, which may result not only from the minor's own actions, inaction, or negligence, but also from the actions, inaction, or negligence of others, the conditions of the facilities, equipment or areas where the event or activity is being conducted, the rules where the event or activity is being conducted, or the rules for this type of event or activity.
4. Release, waive, and discharge Tahoe Swim Club, employees, board of directors, and agents from any liability, loss, damage, claim, demand or cause of action against them arising from or attributable to the minor's participation in the event or activity being conducted.
5. Assume any and all risks of personal injuries to the minor and authorize Tahoe Swim Club, employees, board of directors, and agents to perform emergency first aid, CPR, contact or employ licensed physician to render any medical, hospital, and transportation bills relating there to, permanent or partial disability, or death and damage to the minor's or my property, caused by or arising from the minor's participation in the event or activity.
6. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death for or on behalf of the minor against Tahoe Swim Club, employees, board of directors, or agents attributable to the minor's participation in any event or activity.
7. Agree that photographs, pictures, slides, movies, or videos of the minor, or their projects, may be taken in connection with the minor's participation in any event or activity without compensation from Tahoe Swim Club, employees, board of directors, agents and consent to the use of photographs, pictures, slides, movies, or videos for any legal use.
8. Warrant that the minor is in good health and has no physical conditions that would prevent the minor from participating in any activity or event.
9. Agree that this agreement and release of liability will be valid for each activity with Tahoe Swim Club, employees, board of directors, and agents.
10. Agree to follow all policies and procedures as posted on the bulletin board or website.
11. Agree that if any portion of this agreement is determined to be unenforceable by a court of law, all other parts of the agreement remain in full force and effect.

This Document relieves Tahoe Swim Club, employees, agents, board members, coaches, and others from liability for personal injury, wrongful death, and property damage caused by negligence. Both parents must sign unless only one parent is living or unless one has legal custody. I have read this document, understand that I will give up substantial rights by signing it, and sign it voluntarily. I further understand that this release is binding upon the minor's heirs, personal representatives, next of kin, and assigns.
