WHERE? Cordova Blue Marlins v. Lifetime Meet is this Saturday, June 26th at 8:00 a.m. at the Cordova Community Pool. Swimmers 13 and up will need to arrive and check in with Coach Matt by 6:45 a.m. Swimmers 12 and under will need to arrive and be checked in at 7:00 a.m.

IMPORTANT: Check in time will open earlier, check in at 6:30 a.m.

PROMPT ARRIVAL AT ALL SWIM MEETS IS EXTREMELY IMPORTANT. THE SWIMMER WILL BE SCRATCHED IF LATE CHECKING IN.

WHAT CAN I EXPECT FOR THE MEET AT CORDOVA COMMUNITY POOL?

WHERE DO I PARK? Parking for swim meets will be in the lot by the turn Circle, with overflow into the park. As long as they arrive before 8 a.m., there is no charge to park in the Park. After 8 a.m., the toll booth charges \$5.00.

WHERE DO I SET UP MY POP-UP/TENT? For Saturday's meet families can set up on the grass or on the cement underneath the overhang. The area where the water feature is located will be closed off because there will not be a lifeguard for that area. There can be no pop-ups in the area marked as the fire lane. For this year we will have both teams on the grass or on the pool deck. We ask that you do not use stakes in the newly planted grass.

MASK UPDATE FROM BRANDI DIONNE, Recreation Supervisor CRPD:

CRPD is following all of the CDC guidelines and staff will follow the CalOSHA requirements.
