## **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

In consideration of participation for the persons (herein referred to as “athletes”) named below in the Concord Spring Clinics:

1. The undersigned parent or legal guardian HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE Brian Holm, Springwood Swim Club, Concord Spring Clinics and lessees of the property and each of their officers and employees all for the purpose (herein referred to as “releasees”), from all liability to the undersigned, his personal representative, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefor on account of injury to the person or property resulting to the athletes named below whether caused by the negligence of the releasees, or otherwise while the athletes named below are involved or participating in any swim program purpose or activity on or off of the property.

2. The undersigned parent or legal guardian HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS the releasees and each of them from any loss, liability damage, or cost they may incur while the athletes named below are involved or participating in any swim clinic purpose or activity on or off of the property whether caused by the negligence of the releasees or otherwise.

3. The undersigned parent or legal guardian HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while the athlete named below are involved or participation in any swim clinic purpose or activity on or off of the property.

4. The undersigned parent or legal guardian HEREBY GRANTS PERMISSION for images of the athletes named below, captured during regular and special swim activities through video, photo and digital camera, to be used solely for the purposes of clinic promotional material and publications or instruction and critique, and waive any rights of compensation or ownership thereto.

The undersigned parent or legal guardian expressly acknowledges and agrees that competitive swimming and diving are activities in which there are substantial risks of head and neck injuries or drowning etc., all of which involves the risk of serious injury and or death and or property damages. The undersigned parent or legal guardian further expressly agrees that the foregoing release waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Springwood Swim Club ("the pool") has put in place preventative measures to reduce the spread of COVID-19; however, the club cannot guarantee that you or your child(ren) will not become infected with COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Pool and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Pool may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Pool employees, volunteers, and program participants and their families. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Pool, its employees, agents, and representatives, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Pool, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Pool program.

For and in consideration of my and/or any member of my family's participation and use of Springwood Swim Club and other valuable consideration, the undersigned parents or guardian(s) consent to their family participating in activities and the use of Springwood Swim Club and release Springwood Swim Team, Springwood Swim Club, its members, officers and/or Board of Directors from any liability or claim resulting from any accident or injury sustained by the family during or while traveling to or from Springwood Swim club, club activities (i.e. swim meets,) or events; further I/we agree to indemnify and assume all expenses, costs and fees, and losses arising from said injury or accident to said family/friend; and to hold Springwood Swim Team, Springwood Swim Club, its members, Officers, employees, and board of Directors free and harmless there-from. I understand that no lifeguards will be present, and I and my family fully assume all related risk. This agreement remains in effect until the end of your participation.

I agree to follow all rules of Springwood swim club. I will follow all social distancing guidelines.

I acknowledge that there are no lifeguards on duty at Springwood swim club, and I and or my family swim at our own risk.
