

## KISL August 20, 2002 Meeting Minutes

Meeting called to order at 7:05 pm

Financial Report indicated a balance of \$1923.05.

Report from March 5, 2002 meeting approved as written.

KISL Championship Meet Rule Changes approved as written in the 8/20/2002 meeting agenda.

KISL Constitution and Bylaw Changes approved as written in the 8/20/2002 meeting agenda.

TISCA items:

- a. current TISCA Representative (Brenda) and Review Representative (Betsy) from KISL region nominated and approved for another year.
- b. Fall TISCA meeting has been changed to a meeting of the TISCA board and the 5 regional representatives – no new business to be discussed at this meeting.
- c. State Championship Meet scheduled for February 21-22, 2003, with men diving on Friday and women diving on Saturday. Rules were amended to impose a \$25 fine to teams entering swimmers who don't swim entered times and wh can't provide proof of entered time during season. If fines aren't paid, the team cannot swim at future state championship meets.
- d. Tentative schedule for the spring TISCA meeting is 2/20/2003 at 7:30 pm at a site to be confirmed.
- e. TISCA dues are \$15.00 per team due by 11/1/2002 with an additional \$20.00 late fee if turned in after 11/1/2002. Turn the dues in to Brenda.

KISL Championship meet is scheduled for February 7-8, 2003 at the UT Aquatic Center. Diving will be on Friday evening (2/7/2003) and swimming prelims/finals on Saturday (2/8/2003). A request was made to finish the diving earlier – KISL will look into how to make the diving finish earlier.

2002-2003 KISL dues are \$2.00 per athlete turned in with a roster before the first swim meet for the team.

Scheduling meeting set for October 8, 2002, at 7:00 pm at Farragut High School.

KISL Spring meeting set for March 4, 2003, at 7:00 pm at Farragut High School.

Midway High School application for membership in KISL was accepted.

Old business:

- a. KISL still in need of a secretary (Central had someone in mind will check) otherwise Keith Kitzke will do the job.
- b. 8th grade swimmers participation in KISL will be deferred until the issue is addressed by TISCA in February 2003. The 2003 KISL championship will continue with existing rulings on 8th graders.

New business:

- a. The schedule for Stroke/Starter and Coaches Safety Training will be announced at the scheduling meeting. The Safety Training has not been well attended in the past (consists of a 3 hr session with option of also attending CPR @ 4 hrs and First Aid @ 2.5 hrs). Jackie will put the information about the available classes on the KISL web site (coaches can also check Knox Red Cross web site or call Jackie for additional information).
- b. Discussion of home school definition – home school students are registered with a school and eligibility is determined by the school where they are registered. Independent study students are also registered with a school and their eligibility is determined by the school where they are registered. Home schoolers may swim with a team, but do so as unattached swimmers. Students meeting rules for school attendance or attachment as independent study students may swim attached to the school team. Unattached swimmers may not swim relays at the KISL Championship Meet, but may swim unattached at the KISL and TISCA Championship Meets. Tom will look into the definition of independent study students to verify what it means.
