Once your account is activated, you'll get access to your own private account that will enable you easily declare for swim meets, see your children's swim times histories, maintain your own contact information, and more.

As the owner of the account, by registering additional members, I certify the following:

1. I agree that my **Dunsinane Swim and Tennis Club** membership consists of no more than two adults and my children under the age of 25 living at the same address.
2. I may register a babysitter for the upcoming season by purchasing a separate Babysitter Pass for an additional fee. I understand that the Babysitter Pass is only valid when accompanying an active member of the club.
3. By registering for a membership with the **Dunsinane Swim and Tennis Club**, I agree to follow all posted Rules and Regulations. Additionally, I acknowledge that as the account owner, I am responsible for ensuring that all other members of my account and guests agree to follow posted Rules and Regulations as well.
4. I understand that **Dunsinane Swim and Tennis Club** reserves the right to take any action deemed necessary by the Staff, Management, or Board of Directors to remediate any violation of the posted rules and regulations by any member or their family or guests that may place other members of the club at risk.
5. I certify that I am the parent or legal guardian for my child(ren). I hereby give my permission for any supervisor, coach or other team administrator associated with the **Dunsinane Swim and Tennis Club** to seek and give appropriate medical attention for our child(ren) in the event of accident, injury, illness. I will be responsible for any and all costs associated with any necessary medical attention and/or treatment.

I hereby waive, release and forever discharge **Dunsinane Swim and Tennis Club** and associated supervisor, coach or other team administrator from all rights and claims for damages, injury, loss to person or property which may be sustained or occur during participation in **Dunsinane Swim and Tennis Club** activities, whether or not damages or loss is due to negligence. I hereby acknowledge that my children is (are) physically fit and capable of participation in all Club and Swim Team activities.
