WAIVER, ACKNOWLEDGMENT AND LIABILITY RELEASE:

I, the undersigned coach or team representative, verify that all of the athletes and coaches listed on the enclosed entry are registered with TISCA. I also acknowledge that I am familiar with the rules of TISCA regarding warm-up procedures and meet safety guidelines, and that I shall be responsible for the compliance of my team's swimmers with those rules during this meet. Tennessee Interscholastic Swim Coaches Association, Baylor School, Ensworth School, Kingsport Aquatic Center, Tupelo Aquatic Center, their agents, officers, representatives, employees and coaches shall be free from any liability or claim for damages for any and all injuries, illnesses or damage to valuables which may be sustained at this meet or while in transit to and from this meet. I also acknowledge that by entering this meet, I am granting permission for the names of any or all of my team's swimmers to be published on the Internet in the form of Psych Sheets, Meet Results or any other documents associated with the running of this meet. I attest that all individuals acting in a coaching capacity at this meet have successfully completed the State-mandated Concussion and Sudden Cardiac Arrest online courses for this season.

Assumption of the Risk and Waiver of Liability Relating to COVID-19:

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID 19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. **Tennessee Interscholastic Swim Coaches Association (TISCA)** has put in place preventative measures to reduce the spread of COVID-19; however, TISCA cannot guarantee that a member of my team will not become infected with COVID-19. Further, attending programs and using facilities could increase the risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that anyone on my team may be exposed to or infected by COVID-19 by attending the TISCA Championship Meet and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the TISCA State Meet may result from the actions, omissions, or negligence of myself and others, including, but not limited to, TISCA volunteers and program participants and their families.

I voluntarily agree to not place responsibility for any injury to members of my team (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that my team members may experience or incur in connection with our attendance in TISCA programming and day to day operations ("Claims"). On my behalf, and on behalf of my team members, I hereby release, covenant not to sue, discharge, and hold harmless TISCA, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of TISCA, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any TISCA activities, programs, and job duties.
