



CORONADO SWIM ASSOCIATION CODE OF CONDUCT

Practice Facility Agreement:

- 1) Entry to the practice facility will be by key fob access at the proper time allotted. Early access is not permitted. Team lanyards will be worn at all times while entering and being within the training facility. In the case of a lost fob, the account holder in question will be responsible to pay for replacement.
- 2) All members within the facility will refrain from stepping on the pool bulkhead.
- 3) I understand that the practice viewing area is restricted to the bleachers facing closest to the bayside of the pool, as well as the deck space towards the pool restrooms. Lounge chairs and tables are reserved for paying members and paying day users.
- 4) If I or a family member who is not participating in practice as a swimmer on the team would like to use the pool during lap swim or family swim, I agree that proper day use fees must be paid at the front desk, unless all parties in question hold a membership at the community center for proper use.
- 5) Children 8 years old and under will be within arms length of a parent at all times while viewing practice.
- 6) There is absolutely no running on deck, nor horseplay or extremely loud noises. There will be no food brought on deck, nor within the lobby, hallway, or locker rooms of the facility.

Athlete Agreement:

- 1) I will respect and show courtesy to my teammates and coaches at all times.
- 2) I will demonstrate good sportsmanship at all practices and meets.
- 3) I will set a good example of behavior and work ethic for my younger teammates.
- 4) I will be respectful of my teammates' feelings and personal space. Swimmers who



exhibit sexist, racist, homophobic, or otherwise inappropriate behavior will be faced with consequences including dismissal from the program.

5) I will attend all team meetings and training sessions, unless I am excused by my coach.

6) I will show respect for all facilities and other property (including locker rooms) used during practices, competitions, and team activities.

7) I will refrain from foul language, violence, behavior deemed dishonest, offensive, or illegal.

8) If I disagree with an official's call, I will talk with my coach and not approach the official directly.

9) I will obey all of USA Swimming's rules and codes of conduct.

Parent/Family Agreement:

1) I will set the right example for our children by demonstrating sportsmanship and showing respect and common courtesy at all times to the team members, coaches, competitors, officials, parents, and all facilities.

2) I will get involved by volunteering, observing practices, cheering at meets, and talking with my child and their coach about their progress.

3) I will refrain from coaching my child from the stands during practices or meets.

4) I understand that criticizing, name-calling, use of abusive language or gestures directed toward

coaches, officials, volunteers, and/or any participating swimmer will not be tolerated.

5) I will respect the integrity of the officials.

6) I will direct my concerns first to the Head Coach; then, if not satisfied, to the acting CSA Board President.

7) I will make sure my child is at practice location at least five minutes before the start of



practice.

8) Additionally, I will make sure I pick my child up no more than ten minutes after their scheduled practice if they require transportation.

I understand that if I violate this code of conduct, I will be subject to disciplinary action determined by my coaches and the swim club's board of directors.
