Payments / Tuition

- \_\_\_\_\_ I understand that the **Registration Fee is non-refundable** and cannot be prorated.
- \_\_\_\_\_ I understand that payments are due on the 1<sup>st</sup> of each month by an **Automatic Monthly Payment**. Payments will be charged to my credit card on file or by EFT draft.
- \_\_\_\_\_ I understand that if I wish to cancel enrollment, I must give notice to Circle C Aquatics by the **25<sup>th</sup>** day of the month prior to the month I wish to cancel/drop. Cancellation requests must be sent via email to **admin@ccswim.net**.
- \_\_\_\_\_ I understand that Circle C Aquatics initially covers my costs of entry for meets and that I will be charged for all events my swimmer signs up for, regardless of final participation.

Practices / Cancellations

- \_\_\_\_\_ I understand that practices may be cancelled due to weather, high or low air or water temperature, pool contamination, mechanical failure, scheduled swim meets, instructor/coach illness, or other reasons. There will be no make-up practices, credits, or refunds for cancelled practices.
