### V. Officers Reports

### A. **General Chair** – Christopher Anderson

- 1. Asked for commitments from those Board Member who wanted to go to the USAS Convention in 2010
- 2. Southern Zone Section Meeting.

- a. A Template is being worked on for the governance of the Southern Zone Section. This will aid in how both Sectionals and our All Star Meets are Scheduled and Administrated.
- 3. Decision regarding FL/FGC All-Star Meet by FL Swimming Board
  - a. The meet will not be moved to the Martin Luther King Weekend
  - b. The meet will not include 15-18 swimmers
  - c. Sid Cassidy and Jimmy Parmenter are going to work on different meet formats that may utilize All-Star Teams from other LSCs.
- 4. Swim Network Marketing Material Distribution-
  - a. Chris Anderson brought various posters and business card marketing pieces for broadcast events of 2010 swim meets on the Swim Network.
- 5. FGC Board of Directors Planning Weekend May2010
  - a. Chris handed out an information sheet detailing the itinerary for the weekend and going over the May 7,8 weekend.
- 6. USAS Service Award Nominations
  - a. Chris mentioned that nominations for this award are to be given to him by May 8<sup>th</sup>.
- 7. Report from SWIM and Sanctions Chair Workshop—Lynda Davie—
- 8. 7 Point Action Plan for a Safe and Positive Sport Environment.
  - a. Chris stressed the importance of USA Swimming 7 Point plan and passed it out to all present.—See Below.

#### --USA Swimming's 7-Point Plan for a Safe & Positive Environment

- 1. Develop and disseminate comprehensive guidelines addressing acceptable coach behavior.
- 2. Enhance the system for reporting sexual abuse to USA Swimming and law enforcement.
- 3. Review USA Swimming's Code of Conduct, as well as that of other top youth organizations.
- 4. Review USA Swimming's current background screening program and determine if enhancements can be made.
- 5. Produce stronger communications to member clubs, as the employers of coaches, regarding pre-employment screening, and the responsibility associated with hiring club employees.
- 6. Evaluate the process for sharing coaching history records with member clubs and other youth organizations.
- 7. Educate athletes, parents, coaches and club leaders on this important issue.

### B. Vice Chair Report—Allan Williams

- I. Renaming Sub-JO Meets
  - A. Sub-JO meets were to be called County Meets as per the January Meeting. Allan Williams suggested that the name "Area" be used in coordination with this level of meet. Rob Emary suggested that the Areas be divided according to which Division Meet as follows:
    - 1. Area 1 Palm Beach County, Martin County plus FLA Boca, and Pine Crest
    - 2. Area 2 Broward County minus teams/sites going to other areas

- 3. Area 3 Dade County, Monroe County plus, CST and FLA Miami
- B. The Divisional Meets Will be named according to Area as well

# Motion to Accept the Technical Planning Committee's recommendation to rename the County and Divisional meets as Area meets effective 2011—Allan Willims—2<sup>nd</sup> Richard Cavanah--Passed

- **II.** 14 & Under Junior Olympics—The Notes below were clarifications for the Junior Olympic Meet Information.
  - A. There will be qualifying times for 13-14 year old swimmers in the 50s of stroke. These qualifying times will be equal to ½ the 100 time minus 2 seconds.

# Motion to use the Technical Planning formula to calculate the 50 of Stroke qualifying times for 13-14s—Allan Williams—2<sup>nd</sup> Jimmy Parmenter--Passed

- B. Allan Williams asked for clarification of whether the 400im and 500free would continue to be a Timed Final event—Clarification the aforementioned events will remain Timed Final Events.
- C. Penalty for Missed Final Events
  - 1. It was brought up that there needs to be a penalty for missing a final at the meet. Jimmy Parmenter suggested that there be a \$50.00 cash fine to be paid to the Meet Host before that swimmer is allowed to swim their next event.

# Motion to change the fine to \$25.00with no missed event penalty—Richard Cavanah—2<sup>nd</sup> Jimmy Parmenter—Passed

- D. Bruno Dzari expressed concern that there was not enough time between the Division meets, the closure of OME and Junior Olympics to effectively proof all the entries and entry fees properly.—It was discussed that the TPC would try to allow for a one week interim between the Division Meets, OME Closure and Junior Olympics when the schedule allowed.
- E. Coach Bruno also asked about Bonus Events and the confusion surrounding whether there were or were not Bonus events at Junior Olympics.—The TPC members agreed that there were to be NO Bonus Events and the FGC Standing Rules should be amended to reflect this change.
- F. It was discussed how seeding for the 400im and 500free should be conducted 8 lanes or 10 lanes. It was decided by the committee that the meet host should decide how to run the slower heats as long at the Finals lanes are full.
- G. It was discussed whether to have both the 1000/800 and the 1650/1500 in the meet format in the future. At Junior Olympics there will only be a 1650/1500
   Free and the order of events will be adjusted to accommodate that change—

- III. FGC Division Meets
  - A. In the Future these meets will be called Area 1,2, or 3 Meets

- The 200s of stroke, fly, back, breast will be combined, positive check in, and swam as Time Finals in Prelims. Results and Awards will be sorted according to the event entered. The Meet Information is to reflect this change—Motion Passed
- **2.** The 200IM and 200Free will be a Prelim and Final Event for all the age groups at the meet.—**Motion Passed**
- 3. Relays are to be the 2<sup>nd</sup> Event of the Session in Prelims—This is a clarification from the January meeting that is to be reflected in the Meet Information for these Meets
- 4. The 13-14 50s of Stroke will be spread out in the meet order of events—

  Motion Passed

- **A.** It was discussed that the 400IM and 500/400Free continue to be a Prelim/Final Events.—**Motion Passed**
- **B.** It was discussed to eliminate that 800Free Relay from the order of events— **Motion Withdrawn**
- **C.** It was discussed that all Override times in OME must be proven before the meet—**Motion Passed**

A. It was discussed whether to keep the FGC-FL All Star Meet going in its' present state given the FL Swimming vote to not move the meet to January and not to include 15-18 Swimmers. The committee agreed to proceed with the meet "as is" for now while exploring other possible options.

  - d. Sid also mentioned that any vacancies would be filled by the last weekend in June.
    - i. Times may be converted to meters using the swimming world conversion function.
  - e. It was discussed how to fill vacancies for the 15-18 age groups for the Zone Team.

Motion—Duffy Dillon motioned that 15-18 Zone Team selection be limited to the those swimmers with times placing them in the Top 24 at the meet from the previous year, and the FGC take no fewer than 6 athletes per gender to the meet.—2<sup>nd</sup> David Rodriguez--Passed

    - b. FGC Registration Chair signs the form and sends it to USA Swimming
    - c. USA Swimming then contacts the foreign NGB for verification of the athletes last swim for another entity and sends it back to the FGC Registration Chair
    - d. The FGC Registration Chair then notes when the 120 days being Unattached begins and ends and notifies the team of that date.
    - e. Richard also reminded coaches that Unattached swimmers should be entered in meets as UN-FG or just UN
