- VIII. Coaches Rep: Zone Team will be comprised of 48 athletes. Coaches will be Dave Doolin, Head Coach; Nonie Morgan, Manager; Sarah Weitz, Diana Mokler, Jamie Doctor and Scott Paulson. The Zone Selection Process was passed at last House of Delegates and includes using FINA Points.
